

Errors give Omuthiya disclaimer audit opinion

OMUTHIYA – The finance manager for Omuthiya Town Council Taimi Lungamenti has saved council further trouble from the auditor general as well as members of the parliamentary standing committee on public accounts after admitting and having shown determination in correcting the wrongs.

Council showed that it has been running losses year after year, having recorded a loss of NS4.7 million in 2016, which ballooned to NS14.5 million before soaring to a high of NS16.6 million for 2018.

This Lungamenti appointed to wrongly entered figures by services of a consultant who was compiling financial reports for the council then.

“The problem was that figures were wrongly entered, both on expenses and assets,” she said.

“Also, our depreciation amount was quite high, hence making the losses seem higher. Also, on our system, we had wrong interest figures, especially on assets, however, all these have been rectified, as of 2019,” said Lungamenti.

She acknowledged there were some errors in entering figures

during the process of compiling the financial statements, to which she added such mistakes have been picked up and are being addressed.

This, the AG Junias Kandjoke concurred through records that some such erroneous mistakes have been addressed.

A disclaimer of opinion means that the auditors are distancing any compensation from providing any themselves from providing any

losses being reported, trade creditors overstated by NS305821, including an omitted sum of NS1 554 287 on trade payable listings. Other issues included opening balances which were understated by NS6232137, property plant and equipment understated by NS519 308, as well as council's failure to have a fair presentation of financial reporting frameworks.

Furthermore, the committee wanted to find out what council has done and whether there is an action plan in place to rectify and resolve the issues, to which Lungamenti said, council had none, but assured that they put up the problem, thus from 2019/20 financial year, the issues were corrected.

“Regarding the variance on the land compensation, the NS15 amount was paid after the financial year has closed on 30 June 2018, and it was for the purposes of paying invoices which were already approved prior to closing of financial year,” she said.

“So, this too, we have proof and has been rectified as such. On the opening balance, we realised a wrong formula was used, therefore, reflecting a different percentage in the system on the asset register,” further explained the finance manager.

Parliamentary committee member Harald Kimbunde added the council would have walked away with an unqualified audit opinion had it corrected mistakes earlier.

“We recognise your zeal in trying hard to find the wrongs and correct them considering that you just started doing it yourselves,” he said.

Kandjoke on the other hand requested the local authority to immediately convene a special council meeting to address issues raised. “As per Section 87, Subsection 3 and 4 of the Local Authorities Act, you are mandated within two months of receiving the audit report to convene a special council meeting outlining the action plan, which responds to the issues outlined, and that should be with the minister, advised Kandjoke, while instructing council to do so beginning with the latest financial years.

Meanwhile, the chairperson of the committee Peter Kazongomina wanted to find out whether the finance department was fully capacitated with relevant skills, and implied the officials to seek necessary competencies so that the work can be done diligently. – osimassiku@newera.com.na

Etunda immigrant camp bursting at the seams

ETUNDA - Following the rise in numbers of Angolan immigrants, the governor of Omusati region Erginus Endjala said the existing camp accorded to the immigrants at Etunda has become too small.

Assuch, the arriving immigrants are now being accommodated outside the camp, as there is barely space inside for more people.

There are now 355 immigrants camping outside.

There are 3 000 immigrants at the camp. The governor said there are 1 784 children and 71 pregnant women. There are 198 men and 630 women altogether.

Endjala said the situation is now critical because the number is continuously changing as there is a new group arriving almost daily.

“The camp cannot sustain the growing number. The number is too big now because we now have more immigrants arriving on a daily basis,” said Endjala.

Meanwhile, Endjala said there is progress in talks to repatriate the immigrants back home.

He said his office has received communication that the Angolan government is busy reconciling the number of the existing immigrants to prepare their repatriation.

The idea for repatriation was initially received with mixed feelings when it was sold to the immigrants this year.

While some were eager to go when it rains, others refused to go, fearing that they will be abandoned when they are back home.

A caretaker at the centre Penezambo Joseph who took care of the first immigrants who

arrived earlier this year said the situation of the immigrants has changed compared to when they first arrived.

The ones who have been in the camp now look healthy, thanks to the support of the Namibian government, private organisations

and individuals who continue to support the immigrants with their daily needs.

Joseph said the challenge now at the camp is resistance to getting to the hospital for medical treatment, as they are not too accustomed to the hospital.

Stalling growth creates headache for next German government

FRANKFURT—Global supply chain bottlenecks forced the German government to downgrade its 2021 growth forecast on Wednesday as it prepares to hand over the reins of a stalling economy to the country's next coalition.

Supply chain disruptions and shortages of raw materials, including metals and paper, have choked off the recovery from the impact of the coronavirus pandemic in Europe's top economy.

As a result, the government on Wednesday lowered its forecast for economic growth to 2.6% this year from 3% previously.

"Bottlenecks and high energy prices are both equally slowing the progress of the economy in Europe and worldwide," German Economy Minister Peter Altmaier said in a press conference.

The economic recovery is expected to be pushed into next year, with the government forecasting growth of 4.1%, down from its previous estimate of 4.6%. In 2022, growth would then fall back to 1.6%. A scarcity of components has had a particularly hard impact on the country's manufacturing-driven economy, with

production lines grinding to a halt in Germany's important automotive sector.

Rapid growth in 2021 would depend on "how quickly chipmakers can increase production of semiconductors," Altmaier said, noting that demand for the components would continue to be strong.

Though the minister said he did not expect there to be another coronavirus lockdown over the coming winter months in Germany, but that rising case rates could still have "negative economic consequences".

The German economy would reach its pre-crisis level at the "end of the first quarter" in 2022, "one quarter later than originally thought", Altmaier said.

The new forecast comes against the backdrop of a raft of tough news for the German economy.

The German Ifo institute's closely watched business climate indicator fell for the fourth consecutive month in October, according to figures published earlier this week.

"Supply problems are giving businesses headaches," Ifo president Clemens Fuest said in a statement, describing the bottlenecks as "sand in the wheels of the German economy".

As supplies have dried up, costs have risen, with the prices faced by industry rising by 14% year on year in September, a rate not seen since the 1970s.

Meanwhile, other indicators are turning downwards. German exports fell in August for the first time since April 2020, near the start of the pandemic.

Industrial output slumped by four percent in August, too, while new orders fell 7%.

Under pressure from "surprisingly long-lasting bottlenecks in components, raw materials and transport, more forecasts for the economy will be revised downwards", said Ulrich Kater, chief economist at Deka Bank.

The question of how to get the economy rolling again will be at the top of the agenda as the parties seeking to form the next German government pick up talks on Wednesday.

In their initial agreement, the Social Democrats, Greens and Free Democrats (FDP) pledged massive investments and less red tape to prepare Germany for a greener and more digital future.

But they vowed not to introduce any tax hikes and to maintain Germany's strict debt rule, which limits deficits to 0.35%

of GDP in normal times, a red line for the FDP. Finding a way to deliver on both will require "creativity" by the parties' own admission, and could see the new coalition house their investment programme somewhere else, such as public lender KfW, as per one mooted solution. Germany's "stuttering economic engine" was a "wake-up call" for the coalition negotiators, said Joachim Lang, head of the influential German industrial lobby the BDI. "Investments are now essential", Lang said, calling for faster planning and approval processes, as well as tax reforms.

To avoid "choking off" the recovery, the challenge over the next months – and likely for the next government – was to "reduce obstacles and burdens, speed processes up and put the emphasis on innovation", Altmaier said at the press conference. - *Nampba/AP*
