

Mushelenga wants 100% internet coverage

OKAHANDJA and communication technology minister Peya Mushelenga has urged stakeholders in the ICT sector to redouble efforts to ensure 100% internet coverage nationwide.

"A majority of our population does not have access to the internet – or if there are internet services in their areas, the signals are not so strong, and therefore connectivity is poor," said Mushelenga, who was speaking during the launch of a network tower installed by PowerCom at Okahandja yesterday.

"That (slow internet) naturally causes frustration among internet users. We, thus, need to redouble our efforts and work very hard as stakeholders in the ICT sector to make the internet more accessible and secure 100% across every nook and cranny of our beautiful country," he explained.

According to Mushelenga, half of Namibians do not have internet

population to lag in terms of digital transformation," he said.

Besides access to the internet, Mushelenga implored network operators to make ICT services and products affordable for everyone.

"For instance, devices such as smartphones should be made affordable and available to all sectors of society. At the moment, these gadgets are financially out of reach of the common man and woman on the street. In addition to accessibility and affordability,

We need to educate our people on the various benefits of technology, such as starting small businesses from their smartphones, laptops or tablets. They should not merely use technology on things that are in no way beneficial to their social and economic wellbeing," he said.

However, he said, as much as people celebrate the internet and the wonderful things it can do for them in terms of enhancing experiences and accelerating service delivery, the public must be mindful of the threats that it also poses.

"We, thus, need to be keenly aware of the threats we face and develop the capacity and ability to withstand and overcome these threats," Mushelenga said.

Although there is a remarkable digital divide, Mushelenga said new network towers are part of a response to bridging the gap.

"The symbolism of this unveiling is simply to express and demonstrate how committed and dedicated government is to accelerating internet access and narrowing the digital divide in our country," he said.

PowerCom board chairperson Elorette Harms said since the current board's tenure, the company has thus far erected and installed nine towers to the combined value of roughly about N\$9 million countrywide.

"Six of these nine towers are accounted for in the current financial year. We are on track to construct 17 more towers to the combined estimated value of N\$21.6 million. Construction of eleven of these 17 towers is due to commence in the next two to three weeks," she said.

PowerCom CEO Beatus Amadhila said with the current year strategic plan cycle that ended on 1 October 2021 and ends on 31 September 2026, the organisation is keen to amend the previous shortcomings and challenges.

"We are currently in a process awarding eleven more sites to the combined value of N\$14.4 million, and we anticipate construction to commence within the next two to three weeks," he said. - loide@nepc.com.na

Also speaking at the event, WFP's Ericah Shafudah, who represented the country's director George Feiboh said the MoU comes at the right time when the country is crippled by the effects of the global trend, where food and cash prices have been on an increase.

"This MoU comes at the right time when we have started to feel the global trends' effects. The global food and fuel prices have gone up and the fuel and farm inputs are critical inputs in food production. Therefore, we need to see how we can respond to the effects of global food price increases," Shafudah said.

Shafudah further said the humanitarian organisation partnered with various regional councils, including Oshana, to promote food and ensure communities have enough to feed themselves and surplus to give to others or sell for an income. - nuusitapala@nepc.com.na

Mutorwa: Transport is fundamental

CASAVA - Investment in roads is important in stimulating economic growth and job creation in all regions, works and transport minister John Mutorwa has said.

Speaking during the ground breaking ceremony to commence work to improve district road (DR) 3446 (Charlie Cutline) at the Casava village in Kavango West on Thursday, Mutorwa said government aims to improve accessibility to rural areas in all regions, where more than 80% of the population live in scattered homesteads.

"Construction of roads provide much-needed opportunities for the villagers to be connected to other groups of society, which in turn,

instils in them a sense of being part of the national economic mainstream," he noted.

The minister further emphasised that a safe and efficient road network is important to facilitate growth in other sectors of the economy such as agriculture and tourism.

DR3446, which starts at Casava, some 70km to Rundu, is a vital

artery that connects the Kavango West, Kavango East, Oshikoto and Oshana regions.

In the Kavango West, this road runs through approximately 95 farms, numerous schools and clinics. The betterment works of this sandy road will be divided into three phases. Phase 1, covers the first 40km, will include clearing, forming and adding the first

layer of gravel on the road to make it trafficable. The same road improvements will be done in phase 2, which will cover 50km of the road. Phase 3 will conclude the project, with the remaining 48km which ends at Helavi.

Phase 1 of this project is funded by the Namibian government via the Road Fund Administration (RFA) to the tune of approximately N\$29.8 million and the construction period is six months.

RoadHart CC has been appointed for this project, while the RA will be responsible for the overall supervision and management.

Roads Authority (RA) CEO Conrad Lutombi stated that this road has been on their priority list for upgrade for many years, but could not be achieved earlier due to the economic downturn.

In future, the RA plans to upgrade this road to low volume seal standard as funds become available, he noted.

"More projects are lined up here in the Kavango West region to upgrade roads to low volume

seal standard in this financial year. This includes the road from Nkurenkuru to Nepara Clinic over 28km, and from Mbururu to Mutjokotjo over 33km," Lutombi noted.

On her part, Kavango West governor Sirkka Ausiku said this road is of utmost importance as it connects many Kavango West communities to schools and health facilities, and it is surrounded by many small-scale farming units.

"We cannot expect our farmers to produce more and be able to take their produce to the market if there are no proper roads. Our request is that we don't want this project abandoned halfway, because that will affect the livelihood of our community members," she said.

On Friday, Mutorwa also officiated at the ground breaking of the 50km Ncaute-Karukuvisa gravel road in Kavango East that will be constructed over a period of 12 months at the total cost of N\$28,7 million. It is fully funded by the RFA. Danny's Building Construction CC was awarded the tender. - jmuyamba@nepc.com.na

Namibia compelled to promote sustainable use of ocean

WALVIS BAY - Namibia understand that a healthy and sustainable ocean will not only fight climate change but also contribute to environmental sustainability, food security, poverty eradication, and social equity. Therefore, Namibia feel compelled to play a pivotal role in the sustainable use of marine resources in the country.

This was said by prime minister Saara Kuugongelwa-Amadhila during the second United Nations Ocean Conference

currently underway in Lisbon, Portugal. Leaders of 120 countries are attending the conference in an attempt to reach an agreement to save global oceans as climate change takes a toll.

The conference is held under the theme "Scaling up Ocean Action Based on Science and Innovation for the Implementation of Goal 14: Stocktaking, Partnerships and Solutions". It started on Monday and will end on Friday.

According to Kuugongelwa-Amadhila, the conference affords coastal towns the opportunity to leverage the value of partnerships and interconnectedness

through the oceans.

"All continents border at least one ocean, and Namibia is one of 38 coastal states out of 55 on the African continent. Oceans play an indispensable role in the economies of each of our countries. How we relate to and interact with the ocean in all its mystique and as a powerful economic life force will have direct impact on our efforts and capacity to deliver on the shared targets for sustainable development as set out in Agenda 2030," she said.

The prime minister then explained that Namibia

– as a member of the High-Level Panel on Sustainable Ocean Economy – not only advocate for this to garner increased international commitment and action-oriented support to the important focus on the blue economy, but also in the local context.

"Namibia is, therefore, committed to implement three critical areas of the transformations document in areas such as ocean wealth, health and ocean equity along with sustainable ocean transport and a precautionary approach to seabed mining, among others."

By doing so, she explained, it will reduce greenhouse gas emissions, protecting and restoring marine and coastal ecosystems, reducing ocean pollution to promote equal opportunity for people to benefit from the ocean.

Oceans cover some 70% of the earth's surface, provide food and livelihoods for billions of people and are home to some of the planet's most vital ecosystems.





The above caption has reference.

1. Eagle Focus Investments cc submits its objections to the environmental clearance certificate application by proponent, Marton Investments cc as advertised in the local papers with intention to launch it with the Environmental Commissioner.
2. Eagle Focus Investments cc has three mining claims located on this same portion 2 of farm Sonnleiten. Eagle Focus is a registered right holder of mining claim No.72245 to operate a quarry and crushing of aggregates while the other two are still on pending applications.
3. Eagle Focus Investments is officially registering its objections to the proponent's application for the ECC and EIA for a purpose of setting up an identical quarry operation within our mining claim areas. Eagle Focus is ready to commence its registered commercial quarry operations to provide the aggregate supplies services on demand, in accordance with the proponent's consent to us.
- 4. Our concerns and objections are based on the following grounds:**
 - 4.1 The proponent is the owner of the farm who consented to our ECC application to set up a quarry and crushing activities operation by means of a consent letter issued by her legal representative.
 - 4.2 The position of the proposed quarry that the farm owner advertised on 23 June 2022, with intentions to apply for an ECC has not only encroached onto Eagle Focus' mining claim sites which was already cleared and numerous aggregates testing were run with her consent, over a year ago. The proponent also intends to operate the same quarry operation within 500 metres of the boundaries of one or two of our claim sites, which move contravenes Sections 31 to 33 of the Minerals (Prospecting and Mining) Act 33 of 1992.
