INTRODUCTION AND WELCOMING REMARKS

The meeting was officially opened by Mr. Jacobs Stephanus (a community member) with a prayer. Then Ms. Aili lipinge an Environmental Assessment Practitioner (EAP) from Excel Dynamic Solutions (Pty) Ltd (EDS), thanked and welcomed everyone for making time to attend the important public consultation meeting. She further introduced the EDS present in the meeting. Since the majority of people who attended the meeting understands Damara / Nama , Mr. Jacobs translated from English to Damara Nama and vice versa throughout the meeting.

To ensure transparency and provide clarity to the attendees, the Environmental Consultants also presented the potential pre-identified positive, negative environmental, and social impacts.


