From: The EPL is located approximately 10 km south of Arandis, Erongo Region. It covers a surface area of 64 Hectares (ha) and lies within the #Gaingu Conservancy.

In accordance with: Review of Heritage Impact Assessment conducted on Exploration Prospecting Licence (EPL) 8905, for the exploration of Base and Rare metals, Industrial minerals and Nuclear Fuel minerals. It is located approximately 10 km south of Arandis, Erongo Region.

The following conditions (imposed in terms of Section 55(9) of the Act.) apply to this permit:

- a) Consent should be granted for EPL 8598.
- b) A buffer zone of 50m radius is to be created and maintained around all rock shelters within the EPL.
- c) A buffer zone of 100m radius is to be created and maintained around the historical buildings and chimney found within the EPL.
- d) As per Section 55 (9) (a) the activity authorised by this consent is to be supervised by a person with appropriate professional qualifications or experience in the identification and conservation of heritage.
- e) The consent holder is to report back to the National Heritage Council every six (6) months on compliance with the conditions of this consent.
- f) This Consent does not exempt the holder from any conditions that may be imposed by owners, hosts or any other relevant authorities in consultation with NHC who have a stake in the project area.
- g) NHC shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities related to this permit.



- h) This Consent is subject to the provisions of the National Heritage Act (Act 27 of 2004). Should any of the conditions contained herein conflict with the Act; the provisions of the Act as per Section 55 (10) shall prevail.
- i) Adoption of the Chance Find Procedures are mandatory.
- j) This consent is renewable, upon submission of an application at least two months before the current permit lapses

This Consent will be valid from 31st May 2023 to 30th May 2024.
