


Your letters N 92/16121 dated 10 May 1994 and 16 June 1994 bear reference.

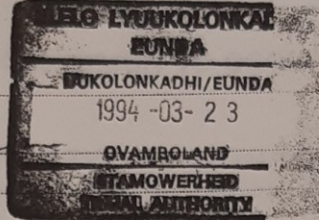

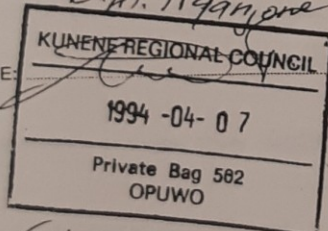
