Dear Sir

We write, on behalf of our client (TradePort Namibia PTY Ltd.) in respect to the requirement for provision of support letter in support of the above-mentioned application. TradePort Namibia has been in communication with both TransNamib and NamPort regarding the use of their premises and service for the trade operation.

Both service provider has previous provided consent for their trading operations along the Trans-Oranje route through the Lüderitz Port and are keen to render similar services for the other routes which consist of the Trans-Kalahari (Gobabis / Witvlei - Walvis Bay), Trans-Zambesi (Grootfontein – Walvis Bay) and Trans-Oranje (Keetmanshoop – Walvis Bay).

However, due to the rather extensive process of drafting and legalizing another agreement for the new proposed routes (see attached quote), our client is unable to provide the consent letter as it may only be in the form of a signed agreement of which negotiations are underway.

Herewith, we would like to request for exemption of this requirement or it be set as an ECC condition for submission prior to or on commencement of the operations. Mr Commissioner, the process of obtaining the ECC is necessary for initiating the investment and funding planning process thus our humble request.

- The above rates exclude VAT; as well as the Fuel Surcharge which is currently standing at 0.00%, which must be added additionally.
- The above quote exclude the following which must be the customers responsibility; as per their stated commitment and undertaking:
 - a. The provision of dedicated Locomotives and Wagons to execute this project in full.
 - The provision of operators and mechanics to operate and maintain these own supplied equipment.
 - c. Fuelling to the locomotives and other machinery to be provided by Tradeport, as per own consumption or once provided by Transnamib to be billed accordingly.
 - d. Equipment maintenance (i.e. locomotives and wagons) to be done by the customer themselves.
- Please take note that TransNamib as the service provider and as by regulation will be responsible for the provision of Perway Civil teams with their small-plant and machinery, Carriage & Wagons Examiners and all other supporting staff members.

- 4. The proposed rates are based on Take-or-Pay agreement principles i.e. an irrevocable commitment / guarantee to pay TransNamib for the minimum monthly guaranteed volumes. Non-acceptance of this will lead to the revision of the quoted tariff.
- The loading at the origin point, the covering of wagons with tarpaulins (if needed) and the discharge at the end destination remains the customer's responsibility.
- 6. Demurrage charges have been waived as the customers will provide own equipment; however strict adherence to TransNamib's operational time schedules is required.
- 7. We provide a standard freight insurance cover of **N\$500,000.00** per consignment note at no additional charge to the customer. Terms and Conditions apply.
