Man Utd lean on Ronaldo to prove Man City's missed opportunity

anchester United are relying Cristiano on Ronaldo to show Manchester City what they missed out on when they meet at Old Trafford on Saturday with both sides in need of the point

Ronaldo continued to dig United out of holes in the Champions League in midweek with a double in a 2-2 draw at Atalanta as he struck late to salvage points for the third time in four European games.

The 36-year-old now has nine goals in 12 games since returning to the club that first made him a household name.

Had things gone differently in the final days of August, Ronaldo could have been lining up in City blue for Saturday's game.

Indeed it was City's interest in the five-time Ballon d'Or winner that appeared to spark United's move to sign Ronaldo from Juventus despite already boasting an over-subscribed array of talent for attacking positions.

Pep Guardiola's men have shone at times this season, but have also missed a clinical finisher as they failed to score at home to Southampton and Crystal Palace to fall five points behind Premier League leaders Chelsea.

United are three points further back after a run of one win in five league games.

The Red Devils have won in just five of Ronaldo's 12 appearances, while the likes of Jadon Sancho, Marcus Rashford and Mason Greenwood have been marginalised.

A 3-0 win at Tottenham last weekend bought Ole Gunnar Solskjaer some time as United boss.

But the defensive frailties that Liverpool exposed in a 5-0 humiliation of Solskjaer's men less than two weeks ago were on show once more in Italy on Tuesday, especially after Raphael Varane limped off with a hamstring injury.

Varane has been ruled out for a month leaving Solskjaer with a headache of how to protect his remaining sluggish centre-backs.

Antonio Conte: Tottenham appoint former Chelsea boss as new manager

ottenham have appointed former Chelsea and Inter Milan boss Antonio Conte as their new manager until summer 2023.

The Premier League club sacked Nuno Espirito Santo on Monday after just 17 games, with Spurs eighth in the table.

Tottenham says there is "an option to extend" 52-year-old Conte's deal with them.

"I am extremely happy to return to coaching, and to do so at a Premier League club that has the ambition to be a protagonist again," said Conte.

The Italian returns to London after winning the Premier League in his first season at Chelsea (2016-17) and the FA Cup in his second before being sacked in 2018.

He then led Inter Milan to their first Serie A title in 11 years before leaving the club in May.

Conte had been in charge for two years and Inter said it was a mutual decision to end his contract with one year remaining.

The former Juventus and Italy coach was then in talks with Tottenham in the summer about becoming Jose Mourinho's successor.

But negotiations were halted before Spurs appointed ex-Wolves boss Nuno at the end of June, with the Portuguese

boss, 47, lasting just four months.

"I can't wait to start working to convey to the team and the fans the passion, mentality and determination that have always distinguished me, as a player and as a coach," said Conte.

"Last summer our union did not happen because the end of my relationship with Inter was still too recent and emotionally too involved with the end of the season, so I felt that it wasn't yet the right time to return to coaching.

"But the contagious enthusiasm and determination of [Tottenham chairman] Daniel Levy in wanting to entrust me with this task had already hit the mark.

"Now that the opportunity has returned, I have chosen to take it with great conviction."

Conte's first game will be at home against Dutch side Vitesse Arnhem in the Europa Conference League on Thursday before Spurs play at Everton in the league on Sunday.

"His track record speaks for itself, with vast experience and trophies in both Italy and England," said Tottenham managing director of football Fabio Paratici.

"I know first hand the qualities Antonio can bring to us, having worked with him at Juventus, and look forward to seeing his work with our talented group of players."

Antonio Conte will become one of the Premier League's highest-paid managers and adds to the list of highprofile coaches now working in the English top flight.

His duels with Pep Guardiola, Jurgen Klopp and Thomas Tuchel in particular will be fascinating.

The speed with which this deal was done underlines the commitment managing director of football Fabio Paratici has to this working out and, while the option of an extension to Conte's 18-month contract was expected, it does suggest an element of long-term planning.

Tottenham accept Conte's demanding style but Paratici in particular feels his fellow Italian is exactly what the club needs to drive them forward.

The pair worked together at Juventus and Paratici is understood to have driven the process to bring Conte to Tottenham after talks in the summer failed to reach a positive conclusion.

Solskjaer Gunnar le compared Cristiano Ronaldo's talismanic influence at Manchester United to NBA legend Michael Jordan after he scored twice to salvage a 2-2 draw at Atalanta on Tuesday.

For the third time in four Champions League games since returning for a second spell at Old Trafford, Ronaldo rescued United with a late goal as his sweetly struck volley in the 91st minute snatched a barely deserved point in Bergamo.

The 36-year-old also scored late winners at home to Villarreal and Atalanta, when United came from 2-0 down to win 3-2 two weeks ago.

However, another disjointed display bailed out by Ronaldo's brilliant finishing will do little to ease the pressure on United boss Solskjaer.

"Ronaldo is one of the best that's ever played this game. I'm sure this is the same feeling Chicago Bulls got with Michael Jordan," said Solskjaer, referring to the American star who won six NBA titles in two spells with the Bulls.

"If you want the ball to fall to someone in the last minute, Cristiano is the one. He's done it so many times for us and I'm okay with him scoring more goals than me."

Ronaldo's double took him past Solskjaer's 126 goals for the club.

Solskjaer's switch to a back three for a 3-0 win at Tottenham on Saturday resulted in some much-needed defensive solidity after a humiliating 5-0 thrashing at home to Liverpool.

However, that was just the Red Devils second clean sheet in 22 games and their problems at the back were again easily exposed in Bergamo.

David de Gea has been one of United's best performers of a desperately disappointing season so far, but he was at fault as he let Josip Ilicic's shot squirm under his body and over the line.

Duvan Zapata had two glorious chances to double the Italians' lead, but the Colombian firstly fired high and wide before being denied by a brilliant block by Eric Bailly.

United suffered another blow when Raphael Varane was forced off midway through the first-half with what appeared the recurrence of a groin injury.

However, the individual quality in the United squad was in evidence for a brilliant equaliser in first-half stoppage time.

Mason Greenwood played in Bruno Fernandes, who picked out Ronaldo with a backheel for the Portuguese to blast home his eighth goal in 12 games since returning to Old Trafford in August.

But United have only won five of those games as Solskiaer continues to struggle to find the right balance goes on.

The offside flag initially came to United's rescue when Zapata finally found the net 11 minutes into the second period.

After a review that took over two minutes, the Gewiss Stadium erupted in celebration when the goal was given.

Despite being starved of service for the majority of the second-half, Ronaldo delivered again in stoppage time.

Greenwood flicked the ball towards the five-time Ballon d'Or, who arrowed the ball into the bottom corner.

United even had a late chance to snatch all three points when substitute Donny Van de Beek was denied by Juan Musso from a narrow angle.

But a point is enough to keep them ahead of Villarreal at the top of Group F on head-to-head record with both sides locked on seven points.

Conte arrival has raised expectations at Spurs - Lloris



ottenham Hotspur's players have a great opportunity to work under new manager Antonio Conte but the Italian's arrival means expectations have been raised even higher at the club, captain Hugo Lloris said.

Conte, who has previously managed Juventus, Chelsea and Inter Milan, as well as the Italy national team, was appointed to replace Nuno Espirito Santo after the Portuguese was fired after 17 matches in charge.

"He is very ambitious and believes in all the players in the dressing room," Lloris said on Wednesday. "It is a great opportunity to work under one of the greatest managers of the last few years.'

Conte takes over with Spurs ninth in the Premier League on 15 points after 10 games, 10 points behind leaders Chelsea.

"Now is not the time for words. It is time to work," said Lloris. "It is time to believe again in ourselves, our team and in our club ... Tottenham, with Antonio Conte, there will be even more expectations.

"But again, it does not matter what people say outside. The most important is what is going on inside the changing room, inside the building. There is ambition in the club. We also want to respond to the expectations of the fans. That is important."

Manchester United's Varane ruled out for a month

anchester United have revealed Raphael Varane will be ruled out for up to a month after suffering a hamstring injury, adding to the French defender's troubled start at Old Trafford.

Varane was forced off in the first half of United's 2-2 draw at Atalanta in the Champions League on Tuesday.

The 28-year-old had only just returned to the United side in Saturday's victory at Tottenham after a groin problem sustained in the Nations League final.

Now the World Cup winner faces another spell on the sidelines and will miss Saturday's derby against Manchester City and a host of other kev fixtures for club and country.

"The club confirms that Raphael sustained a hamstring injury, which is expected to keep him out of action for around a month," United said in a statement. "We'd like to wish Raphael all the best as he works on his recovery."

Varane's absence is a major blow for United, who have struggled defensively for much of this season.

United have conceded 13 goals in their last five matches in all competitions and after Varane left the pitch on Tuesday needed a late equaliser from Cristiano Ronaldo to rescue a 2-2 draw against Atalanta that salvaged their chances of qualifying for the Champions League knockout stage.

After the forthcoming international break, Ole Gunnar Solskjaer's side travel to Watford, Villarreal and Chelsea before the end of November.
