### ESTABLISHMENT OF THE DANGEROUS GOODS STORAGE FACILITY BY NATIVE STORAGE FACILITIES IN WALVISBAY, EFONGO REGION

The Parliament Standing Committee on Foreign Affairs, Defence and Security listened to the presentation conducted by Mr Thomas Mbokoma Jonas on the Dangerous Goods Storage facility. The purpose was to sensitise and clarify to the Members of the Committee the effect posed by the dangerous goods transported and stored in terms of health and safety on our rail and route networks, effects they have on the society, animals and environment in the country.

The Parliamentary Standing Committee, after having carefully listened to this presentation, supports the establishment and facilitation of dangerous goods storage facility in Namibia. To this end, the Committee believes that the establishment of this institution will add value to sectors such as health and safety at the work place, The Mining Sector, safe storage of dangerous goods, safe transportation of dangerous goods, and the implementation of policies in the Republic of Namibia as stipulated in Article 95(L) and 114 (where international environmental laws are applicable) of the Namibian Constitution as well as Environmental Management Act, 2007 (Act No 7 of 2007) and regulations. In addition, the Institution will to some extent assist relevant Government and private institutions to enforce proper regulations that will effectively address the facilitation of the dangerous good in the country.

The Committee therefore, will request all private and public institutions, who may be interested in the safe storage facility of dangerous goods to render support to this healthy initiative.

# NON OBJECTION FOR THE CONSTRUCTION OF THE STORAGE FACILITY FOR DANGEROUS GOODS AT FARM 38, WALVIS BAY

This letter serves to inform you that the NACOMA project has no objection to the new site allocated for the construction of a storage facility for dangerous goods at farm 38 provided all affected stakeholders are well consulted. The site falls within the jurisdiction of the Walvis Bay's industrial area zone as per the IUSDF and the nearest protected area is classified as 'low sensitive' as per Dorob National Park management plan.

A site visit on 10<sup>th</sup> of May 2017 with the chief control warden of Erongo's Directorate of Wild life and National Parks (DWNP) made the following observations and recommendations;

- The Walvis Bay's Environmental section be fully involved in this project from the construction phase to monitor the environmental compliance;
- The contractor should be well briefed on the EMP and its requirements;
- There is urgent need to address the following issues as the earthworks has already begin: dust suppression on site, make use of a single access road,oil spill on site, absence of an EMP on site
