The public consultation meeting was attended by 16 people, including 1 Environmental Consultant and 2 Archaeologist from Excel Dynamic Solutions (Pty) Ltd (EDS) - **Please refer to the attached attendance register.**

1. INTRODUCTION AND WELCOMING REMARKS

The meeting was opened by the Otjimbingwe leader with a prayer and the Environmental consultant introduced of the team, who they are, and why they are consulting affected parties of the proposed prospecting and exploration activities on EPL 8016.

The meeting was translated from English to Damara-Nama and Vice versa.

The meeting attendance register was circulated for the attendees to write down their names and contact details so that they could be added to the list of Interested and Affected Parties (I&APs) and receive further information on the ESA process.

2. MEETING AGENDA AND PRESENTATION

The agenda of the meeting included the following main points:

2.1 Brief Description of the Project

The Environmental Scoping Assessment (ESA) and the reason that the Proponent appointed Excel Dynamic Solutions (Pty) Ltd (EDS), an independent Environmental Consultant to carry out the ESA and apply for the Environmental Clearance Certificate (ECC).

2.2 Explanation of what an ESA is, its Process, and the Public Role in the Process

Mr. Titus Shuuya explained to the attendees the purpose of the meeting and why they were invited (with reference to the Environmental Management Act (EMA) No. 7 of 2007 and its 2012 Environmental Impact Assessment (EIA) Regulations on Public Consultation). Mr. Shuuya further explained what an ESA is and that the proposed exploration activities are one of the listed activities in the 2012 EIA Regulations of the EMA that cannot be undertaken without an ECC from the Environmental Commissioner.

2.3 Presentation of Potential Project Impacts

To ensure transparency and that the attendees understand both sides of the proposed project activities, the Environmental Consultant also presented the potential pre-identified potential positive & negative environmental and social impacts.

2.4 Public Open Discussion (Interactive Session)

Mr. Shuuya allowed the meeting attendees to raise their concerns, issues, and/or comments on the proposed project activities. The concerns/issues and comments recorded are presented in **Table 1** below.

Furthermore, Mr. Shuuya informed the attendees that the draft meeting minutes, Environmental Assessment Report, and Environmental Management Plan (EMP) will be shared with them for review and further comments. These documents will be made available through emails provided on the attendance register.

Once the review of the draft ESA Report and EMP is done, the documents will be finalized and submitted to the Environmental Commissioner at the Department of Environmental Affairs and Forestry (DEAF) for evaluation and consideration of an ECC.

Let's wait and see Benjamin

DESTINY favours the bold, and the Brave Warriors were anything but against Burundi on Tuesday in Dar es Salaam, Tanzania, says Namibia head coach Collin Benjamin.
 As well as lacking courage or cohesion, they repeatedly made costly errors which Burundi's Swallows duly punished them for in the opening half of the 2023 Africa Cup of Nations qualifier, he said.
 Namibia remain top of Group C on five points from four matches despite the 3-2 defeat, with Burundi now level on four points with Cameroon's Indomitable Lions.
 Cameroon host Burundi in September and a win for either side secures top spot along with qualification for the finals together. Namibia will end second in that scenario, a position that guarantees qualification to fourth appearance at the biennial African football showcase.
 "I want to congratulate Burundi, they are a good team, took their chances and that's exactly what we lacked," Benjamin said in his post-match analysis.
 The hosts raced into a three-goal lead inside the opening 20 minutes through quick-fire strikes from Abedi Bigirimana, Bonfils-Caleb Bimenyimana and Hussein Shabani.
 Namibia captain Peter Shalulile hit back for the Brave Warriors just before half-time and Wendell Rudath further reduced the deficit with five minutes from the end.
 "We lost this match in the first 15 minutes of the game. [We were] not taking responsibility and in these decisive moments not being courageous to make the right decisions," Benjamin lamented.
 "We let them to get those goals very easily, and at this level if you allow a team to get those easy goals, you will be punished.

And, that's what Burundi did," he continued.
 The deflating performance was the antithesis of Namibia's last two encounters in March when they upstaged five-time Afcon winners Cameroon.
 The absence of first choice goalkeeper Loydt Kazapua through suspension, the experience of winger Deon Hotto and youthful attacking midfielder Prinz Tjiueza due to injury, appeared to affect the team's rhythm.
 The trio were central to the Warriors game-plan against pressure from Cameroon, who must win at home against Burundi to be certain of qualifying.
 "Our fate is not in our own hands. We don't have any influence over that. We had our chance and we lost it. We'll see what is gonna happen in the next match," Benjamin said.
 Scoring before the break helped galvanise the disoriented Warriors, he said.
 "But I think to come back before half-time through Peter and Wendell towards the end, it was a good fight for my team. But these are mistakes that we made and we will go back to the training field to try and rectify that," said Benjamin.
BATTLES FOR AFCON SPOTS
 Elsewhere, Kelechi Iheanacho scored a 95th-minute winner as Nigeria survived a scare to beat Sierra Leone 3-2 and secure qualification.
 Victor Osimhen, Serie A's top scorer with 26 goals as Napoli won the title last season, put Nigeria 2-0 up inside 32 minutes with a deft lob and a close-range finish.
 Sierra Leone, playing in Liberia because they do not have an international stadium, levelled through Mustapha Bundu and Augustus Kargbo. But Leicester City striker

Iheanacho poked home the winner to secure qualification and send Guinea-Bissau through as Group A runners-up.
 Pierre-Emerick Aubameyang's international return did not go to plan as Gabon lost 2-0 at home to the Democratic Republic of Congo - a result which lifted DRC from the bottom to the top of Group I. Gabon are second in a group from which all four teams can qualify, but they must beat Sudan in the final round of games in September to go through.
 Ghana missed out on qualifying with a game to spare as they were held 0-0 in Madagascar.
 Two points separate the Group E leaders from Angola in second and third-placed Central African Republic, whom they host on 3 September.
 The Central African Republic, who could also have qualified, lost 2-1 at home to Angola. Patson Daka and Kings Kangwa struck and Serge Aurier scored an own goal as Zambia beat hosts Ivory Coast 3-0 in Ndola to seal their Afcon place.
 A late penalty gave Equatorial Guinea an impressive 1-0 win against Tunisia in Malabo that secure a second successive Afcon qualification, while Cape Verde, with a population less than 600 000, will make their fourth appearance at the tournament following a 3-1 home win over Group B winners Burkina Faso.
 Mali secured top spot in Group G with a 2-0 win in Congo-Brazzaville, who face a winner-takes-all clash with the Gambia for the runners-up spot.
 Hosts Ivory Coast, holders Senegal, Algeria, Egypt, Morocco, South Africa and Tunisia had already secured their spot in the 24-team Afcon, which was postponed to January next year because of the summer rainy season in West Africa. - *Additional reporting from BBC.*

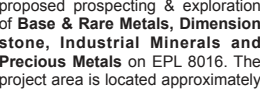

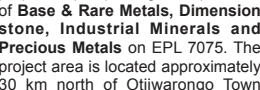

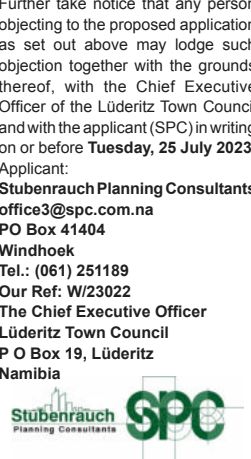
