**Borrow pit Agreement between Onanime Community
Represented by Mr. Shivute sha Hango (Village Headman) of Id
number 43121900072 and Benz Building Supplies Represented by
Mr. Benny Zaaruka (M.D)**

Hereby the two parties agree as follow:-

1. The Onanime community under the leadership of Mr. Shivute sha Hango (Village Headman) and Mr. Primus Hango are requesting Mr. Ben Zaaruka of Benz Building Supplies to construct a ground water Dam next to the efundja water way in Onanime village to secure a long term water reservoir catchment Dam for the utilisation of the Onanime community cattle's, goats and other household animals.
2. In return as a compensation, Benz Building Supplies will be given an exclusive right to remove the sand bank and filling for his own use which can pave the way for the construction of the Dam retainer wall. This contract will be valid for a period of 10 years commencing from the 07th March 2014 until the 07th March 2024.
3. Further this agreement was approved by the Chief of the Uukwambi Traditional Authority, Chief Herman Iipumbu.
4. Further it is also agreed that no other big construction companies will be allowed during this period to take any sand or filling from this borrow pit, only small community companies will be allowed. The borrow pit will be fenced off as per attached map and measurements during the full period of this contract.


With their signature under the two parties confirm that this is the only contract agreement between them and no other agreement will be recognised unless signed off by both parties as an addendum.
