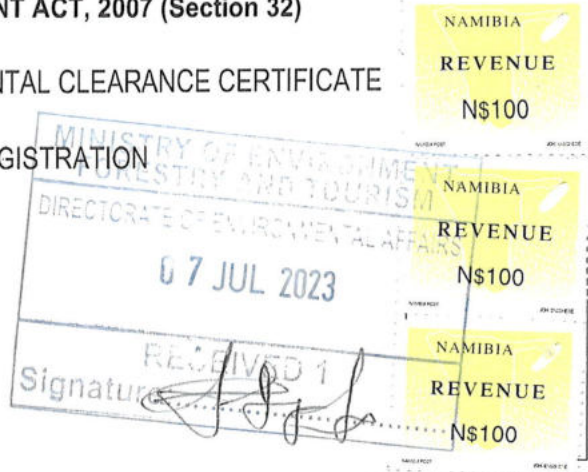

Farm management plan for the bush thinning activities and biochar production on Farm Waltersshagen 135.

Nature of activity:

Farm management plan for the bush thinning activities and biochar production on Farm Waltersshagen 135. The bush control measures are expected to be of low intensity. Harvested wood will be used for biochar production.

Scale and scope of activity:

The proposed bush control activities will involve the use of manual harvesting techniques in an area of 5 304 ha. However, this area will be divided into smaller camps. The total area dedicated to bush thinning activities will be 3 800 ha. The impact of bush control measures is expected to be of low intensity. The farm will therefore be classified as a medium-sized bush harvesting operation and require a GEMP.
