A Rough One Million for Cancer

The annual "Rough n Tough Rally" hosted by the Beard-family over the weekend raised more than N\$1 million to the benefit of the Cancer Association of Namibia (WO30).

The three-day rally challenge is undertaken annually through Damara-land, and this year kicked off on Thursday, 18 May 2023 and travelled offbeat tracks, mountain trails and riverbeds through Oma-jete Village and up to-wards Khorixas where the rally ended at the Madisa Camp on Saturday evening.

Two hundred and eighty participants, seventy-eight rally cars and thirty-five back-up vehicles participated (included a team from the Cancer Association and additional media crew) and completed the 1 000 kilometres trek over a period of three days. "A community of classic and off-road car lovers, adventurers and high-spirited enthusiasts who lived their passion this weekend and paid it

forward to help others – this is the beautiful story of Rough n Tough," said Mr Rolf Hansen, Chief Executive Officer (CEO) of CAN.

The rally was initiated by Mr Philipie Beard some six years ago to answer his quest on creating an adventure experience for car lovers, while giving something back to the community. 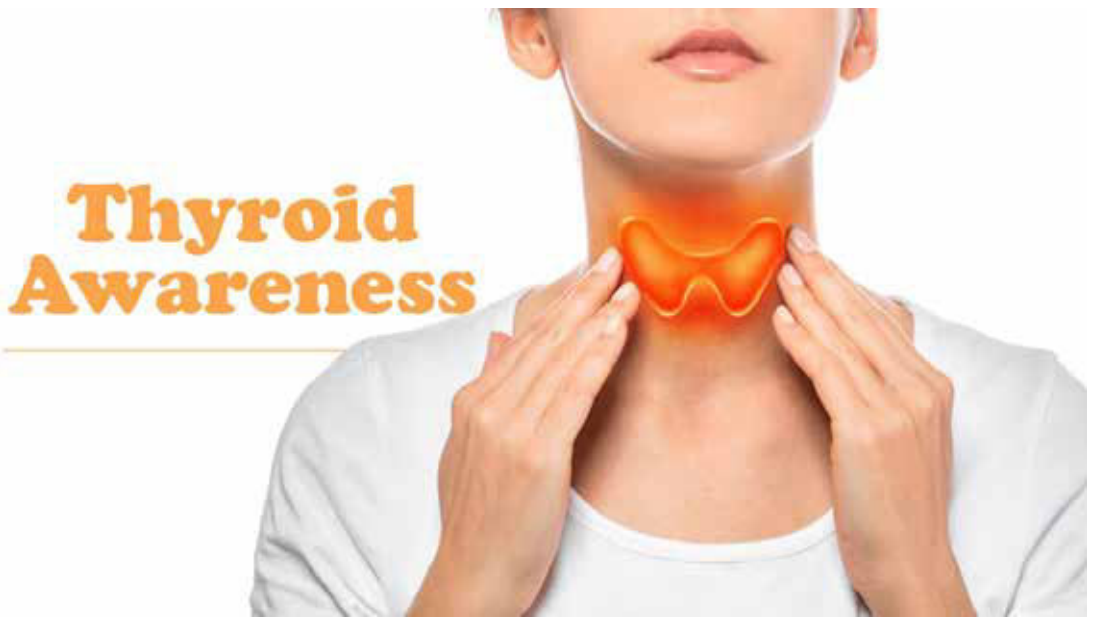

- The appearance of a lump in the neck.
- Pain in the neck and throat.
- Swollen lymph nodes.
- A persistent cough not linked to a cold.
- Difficulty in breathing.
- Pain and difficulty swallowing.
- The appearance of a lump or growth in the neck.
- Constant voice changes and hoarseness.

It's crucial to remember that while the signs and symptoms previously mentioned may not always be a direct result of thyroid cancer, seeking medical advice is highly recommended advised Dr Apffelstaedt

If your doctor determines that the symptoms require further investigation, you will likely be referred to a specialist for a more accurate diagnosis and an assessment of the appropriate treatment plan.
