

# Champions League: What has happened so far this season?

**T**he Champions League returns on Friday - and it feels like a lifetime ago since the group stages and early knockout matches.

The remaining four last-16 ties will be played this weekend, with the rest of the tournament then happening in a series of one-off games in Lisbon.

What has already happened this season? BBC Sport recaps some of the main storylines.

## A new star emerges - while a veteran enjoys his best season

Two players have reached double figures in the Champions League this season - after just six and eight games respectively.

Bayern Munich striker Robert Lewandowski has scored a remarkable 11 goals in six matches.

He netted against Red Star Belgrade, twice against Tottenham, twice and once against Olympiakos, four times in Belgrade, was rested against Spurs and then scored once against Chelsea.

The 31-year-old Poland international is enjoying the best season of his career, with 51 goals in 43 matches for Bayern - including one every 81 minutes in the Bundesliga.

He is one clear of Erling Braut Haaland, who had maybe the most spectacular start to Champions League life of any player.

Haaland, who only turned 20 in July, scored an unbelievable 10 goals in eight games (one every 55 minutes) - despite being knocked out of the tournament twice.

He became the first player to score eight goals in his first five appearances in the Champions League - but Red Bull Salzburg went out in the group stages with defeat by Liverpool, despite scoring 16 goals. Only three teams scored more in this season's group stages.

Haaland then joined Borussia Dortmund, and struck twice against Paris St-Germain to reach 10 goals in seven games, four games quicker than any other player in the competition's history.

The Norway international did not score as they went out in the second leg - but he has still managed as many Champions League goals this season as Barcelona.

He will quite possibly finish as second top scorer, with the changed format meaning teams only have a maximum of three or four matches left. The next top scorers still in the tournament are Bayern's Serge Gnabry and Dries Mertens of Napoli, who have six each.

## Liverpool knocked out - in a game with bigger ramifications

Liverpool were hoping to reach a third consecutive Champions League final but fell to Atletico Madrid in extra time in the last 16 on 11 March.

That was the first time they competed in the tournament without reaching the final since 2014-15.

Trailing 1-0 from the first leg, Liverpool took the tie to extra time at Anfield thanks to Georginio Wijnaldum's goal, before Roberto Firmino gave them the aggregate lead. An Adrian error then gifted the first of three extra-time goals to Atletico, who won 3-2 on the night and 4-2 on aggregate.

But the game may well go down in history for different reasons. Some 3,000 Atletico fans flew over from Madrid, despite the city having almost half of Spain's coronavirus cases at the time and being in partial



lockdown.

That was the last major match played in England for more than three months. Two days later, the Champions League and Premier League were among the many competitions suspended.

A Sunday Times report claimed 41 deaths in the Liverpool region were linked to the game as data gathered from millions of volunteers found rates of cases locally "increased several-fold".

Steve Rotherham, the mayor of Liverpool City Region, called for an investigation into whether the game should ever have happened.

## Entertainers Atalanta come back from the brink

Atalanta were hoping to make an impact in their first Champions League campaign after scoring 77 goals in Serie A, more than any other team, to finish third the previous season.

But they looked doomed after losing their first three games - including a 4-0 defeat at Dinamo Zagreb and 5-1 thrashing by Manchester City - and picking up one point in their fourth.

But they beat Zagreb 2-0 and Shakhtar Donetsk 3-0 to become

the first side to qualify for the next round after losing their opening three matches since Newcastle United in 2002-03. They are also the first debutants to reach the knockout stages since Leicester City in 2016-17.

They showed why they are considered one of Europe's most entertaining teams - they scored 98 goals in Italy's top flight this season - with an 8-4 aggregate win over Valencia in the last 16. They won 4-1 at the San Siro in Milan, their Champions League home because their ground does not meet Uefa requirements. Josip Ilicic then scored four goals in Spain in a second leg played behind closed doors - as the rest of the tournament will be.

This was another tie with big ramifications, with the mayor of Bergamo - where Atalanta play - calling the first leg "a biological bomb" as the city went on to become one of the worst-hit areas in Europe.

Bayern Munich and RB Leipzig have enjoyed their matches against London sides this season - with five wins out of five, and the last-16 second leg between Bayern Munich and Chelsea yet to come.

Gnabry's six Champions League

goals this season have all come in two games - four in a 7-2 win at Spurs and two in the 3-0 first-leg win over Chelsea.

Bayern Munich beat Spurs 3-1 in their final group match, with both sides qualifying for the last 16. Sadly for Spurs, they met another German team at that stage - with Leipzig winning 1-0 in England and 3-0 at home.

Leipzig will be missing one of their goalscorers when they play Atletico Madrid in the quarter-finals. Timo Werner has already linked up with Chelsea, although he cannot play for his new club in their second leg against Bayern, or any game this season.

## Atletico game set to go ahead despite positive cases

**B**ERLIN – UEFA sees no reason to postpone Atletico Madrid's Champions League quarter-final with RB Leipzig on Thursday despite two members of the Spanish team's travelling party testing positive for the novel coronavirus.

"The match is planned to be played as scheduled," European football's governing body told dpa on Monday. There would be no further comment, it added, saying the organization's medical protocol was being followed.

On Sunday, Atletico reported two positive cases after mandatory tests but did not name the individuals. Spanish media reports say they are players.

As a result, the 93-member Atletico delegation had to postpone their arrival in Lisbon, which had been scheduled for later Monday. The two people who have tested positive are now in quarantine and all other members of the travelling party must undergo another test.



## Germany bars fans from soccer matches till at least end of October - source

**B**ERLIN - The health ministers of Germany's federal and state governments have agreed to extend a ban for spectators in stadiums at Bundesliga soccer matches until at least the end of October due to the coronavirus pandemic, a source told Reuters on Monday.

The Bundesliga season restarted in mid-May after a suspension of more than two months, becoming the first European league to resume under strict rules to contain the spread of the coronavirus.

"We need to stay vigilant. In the current situation, spectators in the stadiums would be the wrong signal," Health Minister Jens Spahn said in a tweet.

Spahn pointed to a rising number of new coronavirus cases over the past few days and warned against taking any avoidable risks that could further increase the infection rate.

Government officials have repeatedly urged Germans to stick with such precautionary measures as social distancing and the wearing of face masks, but the rising number of infections suggest some have become less careful during the summer months. Reuters

## Jadon Sancho to stay at Borussia Dortmund, sporting director says 'decision is final'

**E**ngland forward Jadon Sancho will remain a Borussia Dortmund player next season, says the club's sporting director Michael Zorc.

The 20-year-old has been named in the Bundesliga club's squad for this week's training camp in Switzerland.

It comes on the day of the deadline set by Dortmund for any deal to be agreed for Sancho, who is Manchester United's top summer target.

"We plan on having Jadon Sancho in our team this season," said Zorc.

"The decision is final. I think that answers all our questions.

"Last summer we adjusted Jadon's salary to match the development of his performances. So in context, we had already extended his contract until 2023 back then."

Dortmund want about £100m for Sancho, who they signed from Manchester City for £10m in 2017.

Sancho and England Under-17 midfielder Jude Bellingham are among 31 players to travel to Bad Ragaz.

Bellingham, 17, joined Dortmund

from Championship side Birmingham City in July.

Dortmund have two matches during their training camp, against Austrian sides SCR Altach on Wednesday and Austria Vienna on Sunday.

They set the deadline for Sancho, who is under contract with them until 2022, because they want undisturbed preparation for the 2020-21 Bundesliga season.

The new campaign starts on 18 September, with the transfer deadline for international deals on 5 October.

### Analysis

It will be interesting to see what happens now.

I mentioned to someone at Dortmund there is a feeling around United that the Bundesliga side have to sell Sancho for financial reasons.

The answer was fairly quick in coming back - "they will see". Time will tell on that one.

The truth is, before we even get to

that point, something has to change within the current negotiations.

The news about Sancho's contract running to 2023 underlines why Dortmund have been sticking to their guns when it came to that £100m fee, which United believe to be unrealistic.

But it's not just the fee that is too high. Wages and agents fees are also a sticking point it seems. United simply do not believe, in the Covid-affected world football finds itself in, that either are realistic.

There is also an element of frustration in the corridors of power at Old Trafford around Dortmund's claims not to have had any contact with United when they asked for negotiations to be conducted through intermediaries. Discussions, it is being suggested, have been too slow.

United have been threatening to look at alternative targets. Now we might find out if they have any. Today was an artificial deadline - the real one is on 5 October - but the positions do appear entrenched. It will be fascinating to see who moves first. -bbc

# Champions League: The rules players are following during 'final eight' in Lisbon

**U**efa's solution to a Champions League competition disrupted by the effects of the coronavirus pandemic is a 'final eight' knockout tournament played across 12 days in Lisbon.

Football's reputation is at stake and, according to Europe's governing body, the staging of future international matches if protocols are not followed.

In Lisbon, all eight teams and their officials, including Premier League side Manchester City, are required to stick to the rules from a 31-page document.

Some of them will make life very different for the elite of European football.

#### Hotel lockdown

The beaches and sights of Lisbon will be out of bounds, with players only allowed to leave their hotels with prior agreement - and even then they cannot come into contact with anyone outside

their group.

In the hotels, players should have private access routes and a private dining area, while food should only be served by the team's own staff.

Need your pants washing? Clothes and equipment can only be handled by team staff.

#### Late line-up changes?

The life of a footballer these days involves plenty of tests for coronavirus and the Champions League bubble will be no different.

Tests were conducted before clubs left for Portugal - two people connected with Atletico Madrid have already returned positive results and not been allowed to travel.

Tests will also be carried out in Lisbon the day before each game. Uefa has promised the results will be delivered - at the latest - six hours before kick-off.

But one or two positive tests could lead to some torn-up team sheets and tactical masterplans.

It is worth noting Uefa's rules stipulate that provided a team can field 13 'A list' players, plus a goalkeeper, games have to go ahead. If a team cannot do that, they would be allowed to bring in any new signings who had not been registered.

Uefa would look at the potential for rescheduling on a case-by-case basis. However, given the Champions League final will not be moved from 23 August, the reality for any team not capable of fielding a side is that they would probably have to forfeit the fixture.

#### A mirror in front of the toilet

As if coronavirus tests weren't enough, there are also drugs tests to think about.

Doping control officers would usually observe from close quarters

when players produce a urine sample.

But, to enable the officer to watch from a socially distanced position, players will have a mirror set up opposite the toilet - which might be a little disconcerting.

Planes and buses must be thoroughly disinfected and, "to minimise contact with the general public", players will be using VIP arrival areas at airports.

Because of the coronavirus pandemic, the Champions League is concluding with a 'final eight' tournament in Lisbon, with single-leg games held behind closed doors. -bbc

## Portugal PM encourages fans to visit for Champions League finals

**L**ISBON - Portugal's Prime Minister Antonio Costa has encouraged fans and tourists to visit the country during the Champions League tournament, which begins on Wednesday, despite supporters being barred from the stadiums due to Covid-19 restrictions.

Europe's top teams are in action in Lisbon in a special 'Final Eight' mini-tournament starting with Paris Saint Germain against Italians Atalanta on Wednesday at the Estadio da Luz.

Costa said he understood the frustration of those who cannot attend the matches, "But whoever wants to come, be it for the tournament, to spend their holidays, or for any other reason, you are very welcome to Portugal and

you can be yourself in Portugal safely", he said in a statement.

The special tournament, organised by European soccer body UEFA, is being held at two venues in the capital - including Estadio Jose Alvalade - and was arranged after the Champions League was suspended in March due to the Covid-19 pandemic.

Instead of the usual two-legged, home and away, quarter-final and semi-final games, the ties will be decided in a single game, with extra time and penalties if needed. The final will be held on Aug. 23.

"It is a great honour for us to be able to host this event. It is, on the one hand, the demonstration of the extraordinary organisational capacity of Portugal and the FPF (Portuguese Football Federation)," added Costa.

"I hope this is one more

demonstration of our excellence. But it is also a form of recognition by UEFA as the safest place to host this competition."

Portugal has reported a total of 52,945 cases and 1,761 deaths from the novel coronavirus, much lower than many other European countries including neighbouring Spain where more than 28,500 have died.

The sunny southern European nation initially won praise for its quick response to the pandemic, but a steady count of several hundred new cases per day in and around Lisbon after the lockdown was lifted worried authorities at home and abroad. Though the number of infections in Lisbon has been slowly falling, the toll hurt Portugal's tourism-dependent economy, with several European nations imposing travel restrictions or

issuing warnings.

The tourism industry contributed around 15% to gross domestic product in 2018, according to the latest official data.

The biggest hit came when Portugal was left off a list of countries Britain, its leading source of tourism, considers safe enough for travel without coronavirus-related restrictions.

The need for holidaymakers returning to Britain from Portugal to quarantine for 14 days has particularly affected the southern Algarve region, popular among Britons for its sandy beaches and golf courses.

The other quarter-final matches this week see RB Leipzig play Atletico Madrid, Bayern Munich versus Barcelona and Manchester City against Olympique Lyonnais.

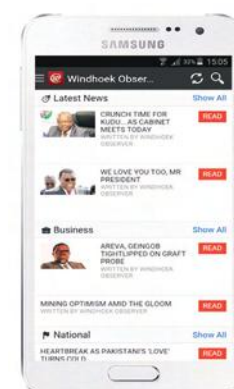
