Sand Mining Notes:

-Sand mining operations remove important stabilising riparian vegetation and constantly more location, leaving behind unproductive and unrestored land.

-The sand mining cumulative impact on the receiving environment should inform permitting decisions, with more careful consideration given to ensure that extraction limits do not exceed the natural sediment yield of the relevant river system.

-Sand acts as a sponge which helps in recharging the water table; thus the progressive depletion of a river is accompanied by sinking water tables, which has an adverse impact on nearby communities.

-Sand eroded from upper catchments and transported by rivers is deposited along river banks and floodplains, where it sustains a riparian habitat and provides fertile ground for agriculture.

-Sand mining damages riparian habitats through destroying vegetation, riverbanks and wetland systems, altering the flow of a river and fragmenting ecological corridors.

-Illegal sites are not rehabilitated and usually become quickly overgrown with invasive alien vegetation.

NB! Any person wishing to extract sand must apply to the state for the right to do so, through administrative means of acquiring a sand mining permit.
