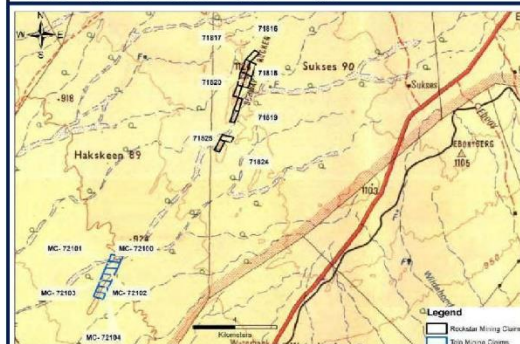

Yuki Tsunoda to have first Formula 1 test

Japanese driver Yuki Tsunoda is to have his first Formula 1 test in an Alpha Tauri car at Imola on 4 November.

Tsunoda, a protégé of Alpha Tauri's engine partner Honda, is a potential candidate for a race seat at the team next year.

Tsunoda hopes to cover the 300km that would qualify him to take part in a Friday practice session, if the team chose to run him in one.

After the test there are four races remaining where that could happen.

Tsunoda, 20, is third in the Formula 2 championship with two races remaining, a position that would guarantee him the "super licence" required to race in F1.

"My main priority is to do those 300 kilometres," he said on Wednesday as he had a seat fitting at the Alpha Tauri factory in preparation for the test, which will come at the wheel of a 2018 car.

"I don't want to crash or go off the track because the more mileage I do,



the more I can understand the car, so I will take it easy.

"But I am confident that I can do it and I will drive the way I normally do. I

will focus on my job while enjoying my first day in a Formula 1 car.

"I am sure I will be very excited when I'm sitting in the car waiting for the green light at the end of the pit lane."

Alpha Tauri have already said they plan to run Tsunoda in the young driver test after the season finale in Abu Dhabi.

Until Honda announced its decision to withdraw from F1 at the end of 2021, Tsunoda was considered close to a certainty to take the seat at Alpha Tauri currently occupied by Russian Daniil Kvyat.

Masashi Yamamoto, the general manager of Honda Motorsports, said at last weekend's Eifel Grand Prix that he did not believe Honda's decision would have "any impact" on whether Tsunoda would graduate to F1 in 2021.

"Red Bull don't just let anyone drive their cars," he said of Alpha Tauri's owners.

"I think they will be evaluating him strictly as a junior driver and also it depends on his Formula 2 results as well. But we'd like to back him up where we can." - **bbc.com**

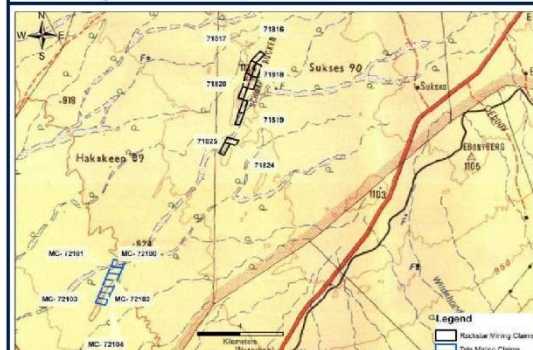

Griezmann wages a war against Ronald Koeman



Antoine Griezmann

Barcelona continue to struggle with Antoine Griezmann and it seems like a never-ending issue.

Barcelona signed Antoine Griezmann from Atletico Madrid in the summer of 2019 for 120 million euros after successfully paying his release clause. The French forward was destined for greatness at Barca after a rather successful spell with Atletico and the French national team where he became a World Cup winner in 2018.

However, Griezmann has failed to live up to the expectations of the fans and the hefty price tag that was paid. Many believe that the reason why the French forward has failed to excel at the club is due to the new position he has had to adapt to.

The 29-year-old left-footed forward prefers playing through the centre of the attack and likes

to drop deep to collect the ball and start attacks, however, that role at Barca is already occupied.

This meant that Griezmann had to shift on the right-wing, a position that he has not yet adapted to after an entire season. It was expected that Ronald Koeman would be able to make most of the 120 million euro signing. However, Koeman so far has found the method to make the most out of Philippe Coutinho but not the former Atletico Madrid striker.

Barca's recent clash against Sevilla sparked a few controversial statements post-game by the Dutch manager. Koeman was asked about Griezmann's poor performance in the fixture to which he replied –

He had two chances and, due to his quality, he should have scored in one of those two plays.

However, Antoine Griezmann was quick to retaliate Koeman's statement. The French forward has

once again shown glimpses of his past form with the French national team lately while on international duty. Griezmann stated that the reason behind this is because Didier Deschamps knows where to play and that he has the backing of his teammates, according to reports by OK Diario.

"I feel good, I feel good, because the coach [in reference to Deschamps] knows where to put me and, therefore, I benefit from it, as well as the confidence that the coach and my teammates give me

This can be considered as a subtle dig towards Ronald Koeman and the senior squad of Barca. Antoine Griezmann has not got along very well with his teammates since his switch last summer.

The Frenchman seems more or less lonely and is often ignored during matches that have become quite a common phenomenon.

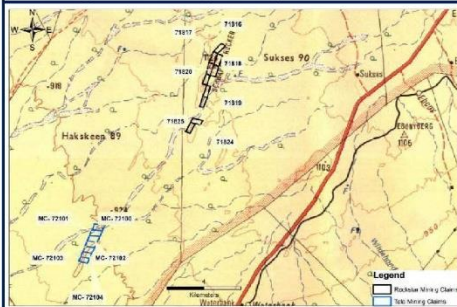

Lampard sets Bayern Munich benchmark for youthful Chelsea

Chelsea manager Frank Lampard believes reigning European champions Bayern Munich are a benchmark for his young players as they target improvements on all fronts ahead of their Champions League opener against Sevilla.

Bayern thrashed Lampard's Chelsea 7-1 on aggregate in the round of 16 last season before lifting the trophy for the sixth time in August.

"It is a great platform to learn because you're playing against the best, and we played against the best in Bayern Munich," Lampard told a news conference on Tuesday.

"We were a young team last year, working a lot to improve, and the Bayern game was a great marker for the young players in the squad to realise

the levels that need to be attained. I remember having that myself as a young player.

"Of the players we have brought in, some have more Champions League experience than others."

Chelsea have added Champions League experience to the squad in the close season with the arrival of defender Thiago Silva and forwards Kai Havertz, Timo Werner and Hakim Ziyech.

Lampard's players, however, have struggled to get up to speed following a short pre-season and suffered another lapse in concentration on Saturday when Southampton came from behind to secure a 3-3 draw at Stamford Bridge.

Sevilla visit Stamford Bridge for Chelsea's first match in Group E, which also includes

Russian side FC Krasnodar and France's Stade Rennais.

"I mentioned before about concentration, focus and discipline and that becomes even more important here than other competitions because of the level of Champions League," Lampard added.

"That's what I would always make very clear to the players going into a match against someone of the quality of Sevilla," Lampard confirmed midfielder Billy Gilmour is nearing a return to action as he stepped up his recovery from a knee operation.

"Billy has been working really well – he's about three weeks away from returning," said Lampard. "Hopefully it will be two or three weeks. The next side of the international break, all being well," - supersports

Marcus Rashford shines again in Paris



The Parc des Princes is home to a speedy forward with designs on being the best player in the world, but not for the first time Kylian Mbappe was overshadowed by his opposite number as Manchester United picked up another famous win.

Nineteen months ago Marcus Rashford stepped up to score a last-minute penalty against Paris St-Germain and send Ole Gunnar Solskjaer's side into the last eight of the Champions League.

This time it was only a group game but the result was the same - Rashford finding the far post to rattle in a wonderful 87th-minute winner and leave Mbappe frustrated again.

Solskjaer said after the game that Rashford and Mbappe were "both potentially top strikers for the next 10-15 years", but how does Rashford measure up to France's World Cup winner?

When Wayne Rooney signed for United he scored outrageous goals, he didn't score ugly goals. He became obsessed with scoring.

"Marcus scores fantastic goals and creates fantastic goals - if he can create that ugly side to the game then this kid can be unbelievable.

"The difference between Rashford and Mbappe is when Mbappe gets the ball I'm on the edge of my seat because he shapes up to go for goal. Marcus will have a look up and think about it a bit more.

'You might only get one chance'

Solskjaer said that this win in Paris lacked the "euphoria" of the last-16 victory from last year, with this match played behind closed doors because of coronavirus.

Bruno Fernandes put United ahead in familiar fashion from the penalty spot-retaken - before Anthony Martial misguidedly headed into his own net.

Mbappe's best moment came when he chipped inside two challenges but saw David de Gea make a flying save to beat out his shot.

And Rashford then drilled in the winner with three minutes left after failing to make the most of a clear counter-attack minutes earlier.

"It's a different feeling from the last time we won here, it's at the start of the group stage but we've beaten a fantastic team," Solskjaer said.

"Last time it was a knockout and it was euphoric, this is sterile without the fans but it's still excellent and we deserved to win."

"For me, they were both opportunities to win the game," Rashford said.

"As a striker, in the game late on, that's the mentality. You might only get one chance. It gets us the three points."

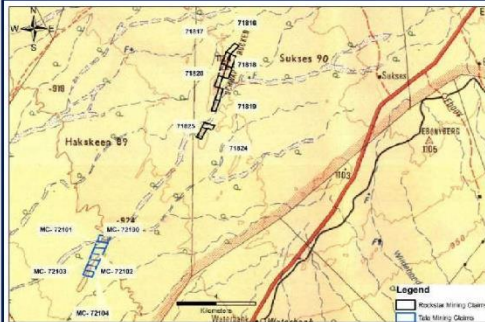

Eden Hazard's ongoing injury problems have led to him being sidelined for 34 games since his move to Real Madrid

Months disappearing for Hazard at Real Madrid - Michael Laudrup

Eden Hazard's persistent injury problems are "so sad" and "the months are disappearing for him", says former Real Madrid midfielder Michael Laudrup.

Hazard joined Real Madrid from Chelsea for a fee in excess of £150m in 2019, but has made just 22 appearances.

"I don't understand what's wrong, he had some injuries at Chelsea but never this much," said Laudrup.

The forward is yet to play this season and will miss Saturday's first El Clasico of the season.

The 29-year-old's latest setback is a muscular injury to his right leg and manager Zinedine Zidane said this week he faces another month on the sidelines.

"I've watched him so many times with Chelsea and Belgium and I really enjoy him because I think we lack these kinds of players in football nowadays, players who take the ball and players who go one-on-one or one-on-two," former Swansea manager Laudrup said in a special Clascio preview edition of BBC Radio 5 Live's Football Daily podcast.

"We need them, otherwise we just play the ball around and who is going to do the special things?"

The Belgian scored 110 goals in 352 appearances for Chelsea during seven years at the club but has scored just one goal so far for Real Madrid.

"Every time you think he's back he plays a few games and then he's out again - I think it's so sad to see a great player like him and the weeks and months are just disappearing for him," added Laudrup, who joined Real Madrid from Barcelona in 1994.

"I hope he will come back but the problem is as you get older it's tougher to come back at the level you were before."

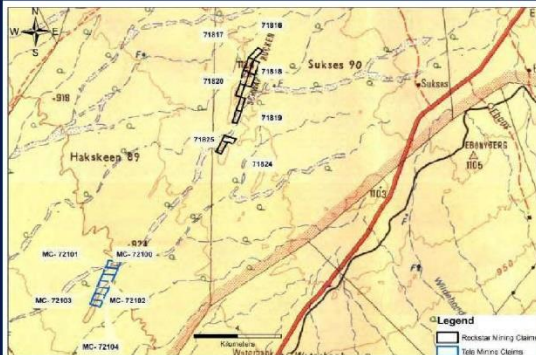
