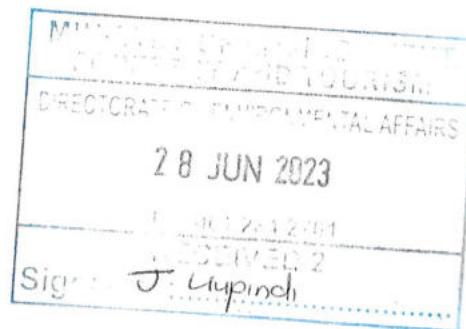

Nature of activity:

Farm management plan for the bush thinning activities and biochar production on Farm Wronin 1013. The bush control measures are expected to be of low intensity. Harvested wood will be used for biochar production.

Scale and scope of activity:

The proposed bush control activities will involve the use of manual harvesting techniques in an area of 5 800 ha. This area will be divided into smaller camps with an average size of 251 ha. The impact of bush control measures is expected to be of low intensity. The farm will therefore be classified as a medium-sized bush harvesting operation and require a GEMP.

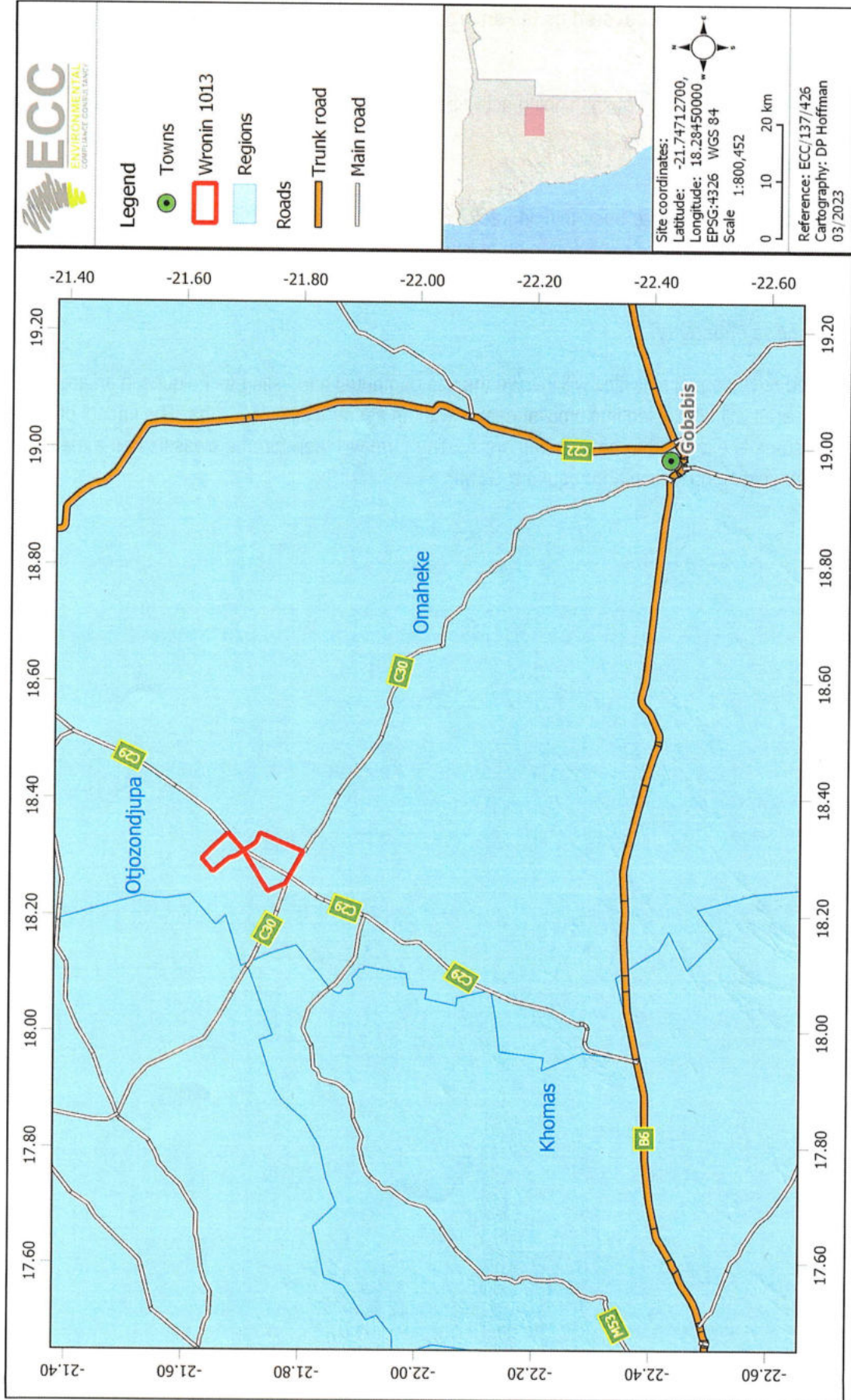


Figure 1 – Locality map of Farm Wronin 1013 in Namibia
