#### 1 INTRODUCTION

An Environmental Clearance Certificate dated 29 October 2019 was granted to the Oranjemund Town Council by the Ministry of Environment and Tourism for the following:

- o Subdivision of Erf 991, Oranjemund Extension 3, into Erven A, B, C and Remainder;
- o Subdivision of Erf 993, Oranjemund Extension 3 into Erf D and the Remainder.
- Rezoning of Erf B of Erf 991, Oranjemund Extension 3 from General Residential to Industrial purposes;
- o Creation of street on subdivided Erf 993, Oranjemund Extension 3.

The Environmental Assessment (EA) in order to obtain an Environmental Clearance Certificate (ECC) for the above activity was conducted by Africa Planning Forum CC (APF) in 2019. Following the submission of the final Environmental Assessment Report, the ECC was granted as per letter dated 29 October 2019 (Appendix C). In accordance with the Environmental Management Act No 7 of 2007 and the Environmental Impact Assessment Regulations of 2012 the ECC is only valid for three years and as such the ECC has expired. Stubenrauch Planning Consultants (SPC) has been appointed to apply on their behalf to the Ministry of Environment, Forestry and Tourism (MEFT) for the renewal of the ECC. The EMP is herewith updated as part of the application to apply for the ECC renewal for the above proposed activities.

The above are listed activities in terms of the Environmental Management Act (No. 7 of 2007) and Environmental Impact Assessment Regulations (Government Notice No. 30 of 2012).

An Environmental Management Plan (EMP) is one of the most important outputs of the EIA process as it synthesises all of the proposed mitigation and monitoring actions, set to a timeline and with specific assigned responsibilities. This EMP details the mitigation and monitoring actions to be implemented during the following phases of these developments:

- <u>Planning and Design</u> the period, prior to construction, during which preliminary legislative and administrative arrangements, necessary for the proposed development, are made and engineering designs are carried out. The preparation of construction tender documents forms part of this phase;
- <u>Construction</u> the period during which the proponent, having dealt with the
  necessary legislative and administrative arrangements, appoints a contractor for
  the development of services infrastructure and construction of the road to service
  the development as well as any other construction process(s) within the
  development areas; The proposed road has already been constructed and thus the
  proposed development does not entail a construction phase.
- Operation and Maintenance the period during which the services infrastructure will be fully functional and maintained.

It should be noted that to date, no engineering designs have been carried out for the development of the infrastructure associated with this development.

The decommissioning of these developments is not envisaged; however in the event that this should be considered some recommendations have been outlined in **Table 4-5**.

#### 2 DEVELOPMENT DESCRIPTION

Oranjemund is located in the Karas Region in the far southwestern corner of Namibia. It is bordered by the Orange River to the south, the Atlantic Ocean to the west and the Namib Desert to the north and east.




Figure 1: Locality map of Erven 991 and 993, Oranjemund Extension 3

Erf 991 is situated adjacent to Erf 993 in the neighbourhood of Oranjemund Extension 3. Please refer to below locality map (**Figure 1**).

#### 2.1 Proposed Development: Erf 991, Oranjemund Extension 3

The proposed development involves the subdivision of Erf 991 into Erven A, B, C and Remainder. Erf B will be rezoned from General Residential to Light Industrial use, Erf C will be rezoned from General Residential to Office use, whereas Erf A will be rezoned to Local Authority and the Remainder will retain the General Residential zoning.

Erf 991 is planned to be transferred to Namdeb as part of the Oranjemund town transformation agreement. Over the years the erven were leased to the business and thus the buildings on the erven are the property of Namdeb. Namdeb intends to offer the land to the current occupants of the erven for purchase.

# 2.2 Proposed Development: Erf 993, Oranjemund Extension 3

Erf 993, Oranjemund Extension 3 is currently an office zoned erf located adjacent Erf 991. Erf D which is to be created is currently a tarred road that provides access to Erf 991. It is the intension of the proponent to rectify the situation on the ground by subdividing the tarred section of road and formally creating the road.

#### 2.3 Engineering services and Access Provision

Erven 991 and 993, Oranjemund Extension 3 are connected to the municipal reticulation system of the Oranjemund Town Council. Proposed Erven A, B C and the Remainder of Erf 991 Oranjemund Extension 3 and Erf D and the Remainder of Erf 993, Oranjemund Extension 3 will be connected to these services that are anticipated to be sufficient for the proposed development as the land use does not change.

#### 3 ROLES AND RESPONSIBILITIES

The proponent is ultimately responsible for the implementation of the EMP, from the planning and design phase to the decommissioning phase (if these developments are in future decommissioned) of these developments. The proponent will delegate this responsibility as the project progresses through its life cycle. The delegated responsibility for the effective implementation of this EMP will rest on the following key individuals:

- Proponent's Representative;
- Environmental Control Officer; and
- Contractor (Construction and Operations and Maintenance).

#### 3.1 PROPONENTS'S REPRESENTATIVE

The proponent should assign the responsibility of managing all aspects of these developments for all development phases (including all contracts for work outsourced) to a designated member of staff, referred to in this EMP as the Proponent's Representative (PR). The proponent may decide to assign this role to one person for the full duration of these developments, or may assign a different PR to each of the development phases – i.e. one for the planning and design phase, one for the construction phase and one for the operation and maintenance phase. The PR's responsibilities are as follows:

#### 3.2 ENVIRONMENTAL CONTROL OFFICER

The PR should assign the responsibility of overseeing the implementation of the whole EMP on the ground during the construction and operation and maintenance phases to an independent external consultant, referred to in this EMP as the Environmental Control Officer (ECO). The PR/ proponent may decide to assign this role to one person for both phases and may assign a different ECO for each phase. The ECO will have the following responsibilities during the construction and operation and maintenance phases of these developments:

- Management and facilitation of communication between the PR, the contractors, and Interested and Affected Parties (I&APs) with regard to this EMP;
- Conducting site inspections (recommended minimum frequency is weekly) of all construction and/or infrastructure maintenance areas with respect to the implementation of this EMP (audit the implementation of the EMP);

- - Assisting the Contractor in finding solutions with respect to matters pertaining to the implementation of this EMP;
  - Advising the PR on the removal of person(s) and/or equipment not complying with the provisions of this EMP;
  - Making recommendations to the PR with respect to the issuing of fines for contraventions of the EMP; and
  - Undertaking an annual review and bi-annual audit of the EMP and recommending additions and/or changes to this document.

#### 3.3 CONTRACTOR

Contractors appointed by the proponent are automatically responsible for implementing all provisions contained within the relevant chapters of this EMP. Contractors will be responsible for the implementation of this EMP applicable to any work outsourced to subcontractors. **Table 4-3** applies to contractors appointed during the construction phase and **Table 4-4** to those appointed during the operation and maintenance phase. In order to ensure effective environmental management, the aforementioned chapters should be included in the applicable contracts for outsourced construction, operation and maintenance work.

The tables in the following chapter (**Chapter 4**) detail the management measures associated with the roles and responsibilities that have been laid out in this chapter.

#### 4 MANAGEMENT ACTIONS

The aim of the management actions in this chapter of the EMP is to avoid potential impacts where possible. Where impacts cannot be avoided, measures are provided to reduce the significance of these impacts.

The following tables provide the management actions recommended to manage the potential impacts rated in the scoping-level EA conducted for these developments. These management actions have been organised temporally according to project phase:

- Applicable legislation (Table 4-1);
- Planning and design phase management actions (Table 4-2);
- Construction phase management actions (Table 4-3);
- Operation and maintenance phase management actions (Table 4-4); and
- Decommissioning phase management actions (**Table 4-5**).
- The proponent should assess these **commitments** in detail and should acknowledge their commitment to the specific management actions detailed in the tables below.

#### 4.1 ASSUMPTIONS AND LIMITATIONS

This EMP has been drafted with the acknowledgment of the following assumptions and limitations:

- This EMP has been drafted based on the scoping-level Environmental Assessment (EA) conducted for the above-mentioned proposed project activities. SPC will not be held responsible for the potential consequences that may result from any alterations to the above-mentioned layouts.
- It is assumed that construction labourers will be sourced mostly from the townlands area and that migrant labourers (if applicable) will be housed in established accommodation facilities within Oranjemund.
- No engineering designs have been carried out for the development of the associated services infrastructure (roads, potable water, storm water, sewerage and electrical reticulations).
