From: Exclusive Prospecting Licences (EPLs) 9663 & 9664 are located approximately 50km west of Kamanjab, Kunene Region. EPL 9663 covers a surface area of about 29 608 ha and overlies the following farms: Farm no.621, Keiserfontein no.620, Farm no.619, Grootberg no.191, and Persianer no.705. EPL 9664 covers a surface area of about 19 758 ha and overlies the following farms: Atlanta no.618, Grootberg no.191 and Estorff no.600.

In accordance with: The Archaeological and Heritage Impact Assessment (HIA) Report for the proposed exploration activities on Exclusive Prospecting Licences (EPLs) 9663 & 9664 for the exploration of Base and Rare metals, Dimension stone, Industrial minerals, Precious metals and Semi-precious stones.

The following conditions (imposed in terms of section 55(9) of the Act.) apply to this permit:

- a) A buffer zone of 100 radius is to be created and maintained around all burial sites found within the EPLs.
- A buffer zone of 100m radius is to be created and maintained around the stone walling found within EPL 9664.
- c) Monitoring and evaluation inspection will be carried out on the area during the year.
- d) Failure to adhere to the conditions will attract fines or imprisonment or the retraction of the consent as per the National Heritage Act no. 27 of 2004.
- e) As per Section 55 (9) (a) the activity authorized by this consent be supervised by a person with appropriate professional qualifications or experience.
- f) The proponent should take cautious approaches together with the compliance of the Chance Find Procedure.

- g) The consent holder is to report back to the National Heritage Council every six (6) months on compliance with the conditions of this consent.
- h) This consent does not exempt the holder from any conditions that may be imposed by owners, hosts or any other relevant authorities in consultation with NHC who have a stake in the project area.
- NHC shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities related to this permit.
- j) This Consent is subject to the provisions of the National Heritage Act (Act 27 of 2004). Should any of the conditions contained herein conflict with the Act; the provisions of the Act as per section 55 (10) shall prevail.
- k) This consent is renewable, upon submission of an application at least two months before the current permit lapses.
