Two T20 World Cup spots up for grabs

THE last two spots for the International Cricket Council Men's T20 World Cup 2024 will be decided during the seven-team Africa Regional Oualifier. beginning in Windhoek today, with action live and free on ICC.tv.

Namibia will fancy their chances in claiming one of the two spots in the single round-robin tournament alongside Zimbabwe under new captain Sikandar Raza.

The teams traded blows in a bilateral series across late October, though it was Gerhard Erasmus side who landed the final blow at the United Cricket Club grounds, defending a meagre 101 by bowling out their rivals for just 93

The left-arm pair of JJ Smit and spinner Bernard Scholtz claimed three wickets a piece, before another left-armer, quick Jan Frylinck, claimed the final scalp for an eightwicket win.

Zimbabwe welcome a number of players who did not play in the preparation series, most notably Blessing Muzarabani and Sean Williams. the latter sitting out while named on tour.

Raza takes the leadership reins from Sean Ervine after the series

defeat, with Ervine keeping test and one-day international positions. The two teams were automatic qualifiers for the regional final by virtue of their participation at the T20 World Cup 2022, with Uganda also receiving a bye to the final qualification stage via their final finishing

Uganda have made waves in recent years, most notably claiming a final-over victory over Namibia in a T20I back in April 2022.




