
The Environmental Scoping Report and Environmental Management Plan submitted are sufficient as it made provisions of the environmental management concerning the project's activities. From this perspective regular environmental monitoring and evaluations on environmental performance should be conducted. Targets for improvements should be established and monitored throughout this process.

This Ministry reserves the right to attach further legislative and regulatory conditions during the construction and operational phase of the project. From this perspective, I issue this clearance with the following condition: (1) all applicable permits obtained prior to commencement of the project, and (2) any key biodiversity habitats must be protected.

On the basis of the above, this letter serves as an environmental clearance for the proposed installation of mobile telecommunication antennae (appendix A). However, this clearance letter does not in any way hold the Ministry of Environment and Tourism accountable for misleading information, nor any adverse effects that may arise from these activities. Instead, full accountability rests with MTC Namibia and its consultants.

This environmental clearance is valid for a period of 3 (three) years, effective from the date of issue unless withdrawn by this office.
