SUBJECT: RENEWAL OF THE ENVIRONMENTAL CLEARANCE CERTIFICATE FOR FUEL FILING STATION, INDUSTRIAL WAREHOUSE, RETAIL SHOPS OUTLET AND A SUPERMAKET AT ONAANDA.

Since Dayola Investment CC (Reg No: CC/2018/01340) was first the Environmental Clearance Certificate (ECC) on the 14<sup>th</sup> May 2018, the project never took off the ground due to two main reasons.

- 1. The initial investors on the project withdrew on the eleventh hour and construction never commenced.
- 2. Following the announcement by the Ministry of Mines and Energy (MME) on the Moratorium of Fuel Retail License application in year 2020, the process was equally halted.

Subsequent to the securing of new investors and the lifting of the Moratorium, the proponent thus intends to renew the ECC as a prerequisite for the application of the Fuel Retail License (see attached letter from MME).

Against this background, we seek from your good office the renewal of the above-mentioned ECC.
