# Messi scores penalty but Argentina held by Chile in 2022 qualifier

**L**ionel Messi scored a first-half penalty for hosts Argentina before Chile's Alexis Sanchez equalised as their World Cup qualifier ended 1-1 on Thursday.

Messi converted from the spot midway through the first half after Guillermo Maripan brought down Lautaro Martinez in the box. Chile striker Sanchez levelled in the 37th minute, finishing off a cut back from Gary Medel.

Chile keeper Claudio Bravo made a world class save to keep the scores level just before halftime, tipping a Messi free kick round the post.

Messi also saw a free kick come off the woodwork in the second half.

The match in Santiago del Estero was Argentina's first competitive outing since November and both sides looked rusty.

Argentina pushed forward as the game went on but Chile's rearguard was solid, even without their talismanic holding midfielder Arturo Vidal, who missed out after contracting Covid-19.

Messi almost snatched all three points in the last five minutes but his shots could not find a way past Bravo.

The draw means Argentina are unbeaten at home against Chile in 35 matches, and have gone 12 games without defeat since losing to Brazil in the 2019 Copa America semifinals.

"The positive aspect is that this team always stands up to be counted, tries to attack," Argentina



coach Lionel Scaloni. "They (Chile) practically never created any chances."

Argentina are second in the 10-team South America qualifying group for Qatar 2022 with 11 points from five games, a point behind Brazil, who play Ecuador on Friday.

Chile are sixth, with five points from five games.

The top four teams qualify automatically for Qatar while the fifth-placed side goes into an intercontinental play-off.

Colombia got their second win in the qualifiers, a 3-0 victory at last-placed

Peru.

Yerry Mina put the visitors ahead five minutes before the break and Peru's task became even harder when Miguel Trauco was sent off for a second yellow card offence on the stroke of halftime.

Mateus Uribe made it 2-0 just four minutes into the second half and Luis Diaz added a third six minutes later.

Colombia moved into sixth while Peru remain the only one of the 10 teams still to record a win.

Earlier in the day, Bolivia beat Venezuela 3-1 at home and Uruguay and Paraguay drew 0-0 in Montevideo.

# Joel Glazer: Man Utd co-chairman to make fans forum appearance

**M**anchester United co-chairman Joel Glazer will make his first fans forum appearance in his 15 years as owner of the Old Trafford club on Friday.

Glazer vowed to be more receptive to the club's supporters in the wake of the European Super League fiasco.

Demonstrations were held against the Glazer family, which forced the postponement of the Premier League game against Liverpool on 2 May.

He has since apologised for United's involvement.

Subsequent home games against Leicester and the re-arranged Liverpool game were played but amid an enormous security presence. Manager Ole Gunnar Solskjaer and his squad had to prepare for the Leicester match at Old Trafford after arriving at the ground hours before the evening kick-off.

Songs were sung against the Glazer family during the final home game of the season against Fulham.

The family are under huge pressure to spend significant sums this summer, both on the stadium, which has been showing signs of wear and tear, and to improve Solskjaer's squad. BBC Sport understands Solskjaer has identified four areas of improvement - in attack, central midfield, central defence and a right-sided attacking player - although the Norwegian, who is set to get a contract extension this summer, accepts addressing all these issues will be difficult given the enormous impact Covid-19 has had on

the club's finances.

One player who is of significant interest is England international Jadon Sancho.

It is understood Borussia Dortmund have a gentleman's agreement with Sancho that he will be allowed to leave if a club meets their valuation before a specific point of the summer.

Last year, that was the start of pre-season training in July. United felt there was likely to be some flexibility in Dortmund's position but that proved to be incorrect and Sancho remained at the club, where he impressed over the final weeks of the season as BVB won the German Cup and, importantly, secured a place in next season's Champions League.

It remains to be seen whether Glazer will address any of these issues at the fans forum or whether those present on the virtual call will be allowed to ask questions.

It appeared an honest statement by Denmark coach Morten Olsen at the time, and even Netherlands coach Bert van Marwijk was lulled into admitting his side were favourites in 2012, but in hindsight it may all have been mind games.

The Netherlands - World Cup runners-up two years earlier - were stunned by Michael Krohn-Dehli's first-half strike, and went on to lose all three of their games.

Denmark, despite their surprise win, also failed to make the knockout stages.

### 4. Belgium 0-2 Turkey - Euro 2000 group stage (19.7% chance)

"This is a great gift for the whole of Turkey," Turkey coach Mustafa Denizli said. "This is the best achievement in 77 years of Turkish soccer history."

Denizli's elation followed Turkey's 2-0 defeat of Belgium at Euro 2000, which simultaneously sealed his nation's first ever appearance in the knockout stages of a major tournament, and eliminated the co-hosts.

Hakan Sukur scored both goals for the underdogs, who had taken only one point from their first two games.

### 3. Belgium 1-3 Wales - Euro 2016 quarter-final (19.6% chance)

"If I was a chairman of a Premier League club I would be making Hal Robson-Kanu my next signing," said

former Wales forward John Hartson. "What a goal. He sent Thomas Meunier for a cup of tea and a piece of toast with that turn."

The greatest night in Welsh football history ranks as the third greatest Euros shock of all-time, with Robson-Kanu's sensational turn and finish - as attested to by Hartson - the highlight of an unforgettable victory in 2016.

In Wales' first major tournament for 58 years, Chris Coleman's side came from a goal down to beat a talented Belgium 3-1 and reach the semi-finals of a major tournament for the very first time.

Radja Nainggolan had put Belgium ahead with a strike from 25 yards, but goals from Ashley Williams, Robson-Kanu - who did not even have a club - and substitute Sam Vokes turned it around.

### 2. France 0-1 Greece - Euro 2004 quarter-final (19.1% chance)

"This is the greatest moment in Greek football," declared matchwinner Angelos Charisteas.

At the time it was a fair comment, as Otto Rehhagel's side booked their place in the semi-finals of Euro 2004 by dumping out holders France.

Les Blues could offer no response to Charisteas' second-half header as the Greek's fairytale summer continued at the expense of a French side which

boasted Zinedine Zidane, Robert Pires and Thierry Henry.

But Charisteas' comment soon became out of date - because there were even greater moments to come. Greece would go on to beat the Czech Republic 1-0 in the semi-final, before claiming their first and only major title, beating Portugal in Lisbon.

### 1. England 1-2 Iceland - Euro 2016 last-16 (17.4% chance)

"We all believed. The rest of the world didn't but we did."

Those were the words of defender Kari Arnason, after he and his Iceland team-mates recorded, statistically speaking, the most unlikely result in the competition's history and condemned Roy Hodgson's England to surely their most humiliating defeat in any competition.

In what was described by former England striker Alan Shearer as "the worst performance I've ever seen from an England team", Iceland came from behind to beat the Three Lions 2-1 in the last 16 in 2016.

Wayne Rooney's fourth-minute penalty suggested an easy evening lay ahead for England, but Ragnar Sigurdsson and Kolbeinn Sigthorsson turned the game on its head within 14 minutes and the final whistle was swiftly followed by Hodgson's resignation.

## Spain sets up 'parallel' Euro 2020 team over virus worries

**S**pain have set up a "parallel" squad of 17 reserves for Euro 2020 who may have to play if the Covid-19 infections among its players spread, team management said on Wednesday.

In a decision announced just hours after Spain defender Diego Llorente became the second player to test positive for Covid-19, the Spanish football federation (RFEF) announced in a statement posted on its website that it was setting up a "parallel bubble".

The RFEF said it had called in 11 players to join six backups who were already acting as cover for the coronavirus-hit first-choice squad.

Captain Sergio Busquets tested positive on Sunday, just a week before Spain open their Euro campaign on Monday, playing Sweden in Group E in the southern city of Seville.

Sweden's Euro 2020 squad has also been hit by infections, with two players, star forward Dejan Kulfusevski and midfielder Mattias Svanberg, testing positive, its federation said Tuesday.

Since Busquets tested positive,

Spain's entire Euro squad has been in isolation.

The 11 newcomers were part of an Under-21 team that thumped Lithuania 4-0 on Tuesday evening in Spain's final warm-up match ahead of the Euro.

"The coaching staff of Spain's national team have decided 11 internationals initially called up for the match against Lithuania will remain part of the senior national team," it said.

"This group of internationals will join their teammates... within a parallel bubble, created in anticipation of the possible consequences that could result from the positives of Sergio Busquets and Diego Llorente."

The players are Alvaro Fernandez, Oscar Mingueza, Marc Cucurella, Bryan Gil, Juan Miranda, Gonzalo Villar, Alejandro Pozo, Brahim Diaz, Martin Zubimendi, Yeremy Pino and Javi Puado.

They join six players already drafted in by coach Luis Enrique as insurance against any more positives among his squad: Rodrigo Moreno, Pablo Fornals, Carlos

Soler, Brais Mendez, Raul Albiol and Kepa Arrizabalaga.

The 17 reserves in their separate bubble will have no contact with the main Euro 2020 squad.

Players on the first-choice squad were all to be vaccinated against Covid-19 later on Wednesday, the Spanish sports ministry said.

Spain are also scheduled to play Poland and Slovakia in Group E, with all their group stage matches at the Cartuja stadium in Seville.

# England aim to emulate spirit of Euro 96

**T**wenty-five years after England's dramatic Euro 96 campaign revived the nation's love affair with football, Gareth Southgate's side aim to emulate the golden summer when football came home.

England manager Southgate leads his team into their opening match of the European Championship against Croatia at Wembley on Sunday.

It should be a memorable occasion as England play on home turf at a major tournament for the first time since Euro 96.

For Southgate, England's role as one of several hosts of the delayed Euro 2020 offers a chance for redemption after his penalty miss condemned the country to Euro 96 semifinal heartache against Germany.

If England can create the same wave of national enthusiasm that Terry Venables' team surfed 25 years ago, Southgate will have a chance of winning a first major title for the country since the 1966 World Cup.

English football was undergoing a long-awaited rebirth by the time Euro 96 arrived, recovering from a dark period in which its image was badly damaged by hooligan gangs who clashed in decaying stadiums.

The Premier League had been established four years earlier, with Britpop bands Blur and Oasis and even future prime minister Tony Blair jumping on the bandwagon to broaden the game's appeal.

Capturing the optimistic "Cool Britannia" mood, comedians David Baddiel and Frank Skinner teamed up with The Lightning Seeds to write England's Euro 96 anthem "Three Lions".

With its "Football's Coming Home" chorus, the song became the soundtrack to England's summer.

Yet, while there were unforgettable days ahead, England started Euro 96 in disarray.

Celebrating Paul Gascoigne's birthday during a pre-tournament trip to Hong Kong, England players found themselves on the front pages after a drunken evening at the China Jump bar.

The debauchery peaked in the "dentist's chair" - a drinking game in which the footballers sat with their mouths open as tequila and vodka were poured in.

Gascoigne and other players were also involved in a heated dispute that led to televisions being damaged on a Cathay Pacific flight back to London.

Rather than read the riot act as tabloid headlines screamed "Disgraceful", Venables fostered a siege mentality among his squad.

### 'WE HAD A LOT OF FUN'

Venables' ploy nearly backfired when England were held to a 1-1 draw against Switzerland in their opening game at Wembley.

But England's tournament turned in the grudge match against Scotland, an opponent who lie in wait for Southgate's men in their Euro 2020 group.

Alan Shearer headed England into the lead and David Seaman saved Gary McAllister's penalty before Gascoigne repaid Venables' faith with a sublime goal that showcased his maverick genius.

Gascoigne celebrated by lying on the ground while Teddy Sheringham squirted a water bottle into his open mouth in a nod to their "dentist's chair" antics.

"Gazza saw the dentist's chair in the middle of this bar. From that moment it turns into chaos," former England midfielder Jamie Redknapp recalled. "One of the great nights. And Gazza's like 'I'm going to score against

Scotland and when I do, I'm going to do the dentist chair'.

"Apart from Bobby Moore lifting the World Cup, that's the best picture I've seen of anyone in an England shirt."

England produced one of their greatest performances to crush the Netherlands 4-1 in their final group game. But after surviving a tense shootout to beat Spain in the last eight, England's infamous penalty demons resurfaced when they faced Germany in a pulsating semifinal.

Stefan Kuntz cancelled out Shearer's opener and, after Gascoigne was inches away from an extra-time winner, it was Southgate who played the villain with his shoot-out miss.

Southgate wept on Venables' shoulder, while Germany went on to beat the Czech Republic in the final.

Despite the painful denouement, Euro 96 remains an iconic moment in English football, one that Southgate would love to recreate with his team over the next month.

"It was not only that we reached the semifinals, it was that we had a lot of fun along the way, and I think the whole country did too," Shearer said.

coach Frank de Boer not prepared to risk how long he needs to recover.

### SPAIN

\* Sergio Busquets - tested positive on 6 June

\* Diego Llorente - tested positive on 9 June

Spain captain Sergio Busquets tested positive eight days before their first match at Euro 2020 and is set to miss Spain's opening fixture against Sweden on Monday.

Spain defender Diego Llorente tested positive five days before their Euro 2020 opener, which he was also set to miss. However, one day later he was set to return to the squad's training camp after testing negative in another two rounds of

tests. There were indications he had returned a false positive on Tuesday.

### SWEDEN

\* Dejan Kulusevski - tested positive on 8 June

\* Mattias Svanberg - tested positive on 8 June

Sweden midfielders Dejan Kulusevski and Mattias Svanberg have tested positive for Covid-19 and will miss the opening game against Spain.

After the first of the two players returned a positive test, Sweden head coach Janne Andersson said no reserve would be called up as he hoped Kulusevski would be able to rejoin the squad after the Group E opener.-supersports

## Baxter calls for patience from Chiefs fans

**S**tuart Baxter has returned for a second spell in charge of Soweto giants Kaizer Chiefs, who have not won a trophy since he left the club in June 2015.

He claimed two league titles, the MTN8 and Nedbank Cup in a highly-successful first stint with the team, and is looking to restore former glories again, with the immediate carrot of a CAF Champions League final in front of him.

**You are back in the Naturena hot-seat, give us a snap-shot of where you have been since leaving the club in 2015 ...**

I'm feeling very comfortable with the decision to come back here. Since leaving Chiefs I have been all over the world again. I have been Bafana Bafana and SuperSport United coach in the interim. Immediately before coming here I was in India and then back in Sweden. I have also been back in South Africa visiting my children. [My son] Lee works with Kaizer Chiefs [as goalkeeper coach] and my daughter Natalie lives in the [KwaZulu-Natal] Midlands. The family always take every opportunity we can to come to South Africa.

**What do you see as the biggest task ahead for you at Chiefs?**

It is important that people understand that the coaches that have been here before me are not bad coaches, they are good coaches. They are some of the top coaches in this country. This is not about me coming and dismantling everything that has been done, this is about me trying to find a better balance and rebuilding the culture around the team. Kaizer Chiefs have moved forward a lot since I was here last time. There will be a lot of expectation, I will have to manage that. It is a tougher league [now], the league has improved in terms of the bottom teams, they are all tight games. The game has moved forward and changed. I remember when I came last time and spoke about 'transitions', people laughed and asked what they were. Now they are an integral part of everybody's game. I have to find what is new and what can I use that will bring us an advantage and that edge. It will be a challenge, but an interesting one.

**Chiefs have not won a trophy since you left, the longest barren spell in the club's history ...**

When I came here last time [2013],

I know Chiefs had not won anything for quite a while too. So when I came in, I knew winning something was a priority for them. But I did not look only at winning trophies, I was trying to build a team, I was trying to bond with the supporters, trying to help us find an identity. I think that will be the same again now, if we can keep our eyes firmly on the pathway and not the destination. That will be very important for Chiefs right now. We are the hunter, gradually we became the hunted during my first stint. I thought the boys did fantastically well, the whole club handled the success very well. The memories I have are from lifting trophies to seeing young players come through and become stars, seeing the club develop and the building at Naturena. [But] for me it was about the happiness we created for the supporters and the they identified so strongly with how we played.

**You had that amazing 24-game unbeaten run in your previous stint,**

**you must be looking to restore that reputation for Chiefs as a team that was hard to beat...**

The streak was ... again, I don't think any of us were thinking about the streak. We had games of football to go out and win. It became that teams played us with a little bit of the hand-break on, and if we scored [first] they believed they would lose. We have to recreate that ... no crowds have been a handicap for the previous coaches to work with, and a handicap for the supporters to bond with the players. Gradually, as we get back to normality, and it won't be immediately, we have got to rebuild that. That is one of the strengths of Kaizer Chiefs.

**You have a CAF Champions League semifinal against Moroccan powerhouse Wydad Casablanca this month, which means you have to hit the ground running ...**

There is a challenge for me there in that I have got to try and identify a couple of things, maybe tactically, for

these games that will impact big on the contest. It is a strong opponent, but we have shown in the home game [in the group phase] that we can match them. We have to improve on our first leg and tactically and mentally we have to grind out a result there. That allows us the opportunity to bring them back here and have a real go at them. It will be a challenge in the build-up, but I am hoping that if we do them properly, then these two games, and hopefully the final, will serve as good preparation and a springboard into the new season.

**You will be reunited with your former Bafana Bafana assistant coach Molefi Ntseki, who is now the head of technical and development at the club ...**

Kaizer Chiefs have been in a period of expansion for quite a few years, it probably started picking up speed when I was here last time and it has continued. Even now when I come back, things are changing. On the commercial side things have expanded

and in terms of youth development it has progressed. It is great to see Molefi joining Chiefs, he is a top-class football person and I am looking forward to working with him again.

**Are you also looking forward to working with assistant coaches Arthur Zwane and Dillon Sheppard?**

Coach Arthur and coach Dillon have had to take the reins [as caretaker coaches] and I think they have done really well. Both of them are potentially top-class coaches. If I can do anything to help them equip themselves for the future, be it at Chiefs or somewhere else, then I hope that can be the case. I hope together we can produce something to make the fans proud.

**You left your job in India due to some comments that were made in a post-match interview, and which received widespread criticism. What do you say to people who were offended by those comments?**

Given the unfortunate nature of my exit from India and the unfortunate, and to be very honest, stupid comments that I made, I felt strongly that I needed to make another apology before recommencing my work in South Africa. Anything that I said that offended anybody, I humbly apologise. I know that it [rape] is a heinous crime that it looked like I made light of it, but I was not. That was absolutely not my intention. That does not reflect me as a person. But I do know that many were upset and for that I am truly sorry. In the future there will not be an issue with me, making such clumsy, insensitive and downright stupid comments. I really hope that anyone who is offended by my insensitive words will accept this really heartfelt apology.

**What would be your message to Kaizer Chiefs supporters?**

We are living in massively difficult times, but that doesn't change the fact that the supporters will want us to win. They will have a bit more patience, but not unending patience. I understand that, I know there will be expectations now. I will do everything I can to live up to those expectations, but we need to do things together. It is more difficult when supporters are not in stadiums to feel together. But we have to get that feeling back. The supporters need to know the players are giving their blood to give them what they want. The players need to know the supporters are still there with us. - supersport.com



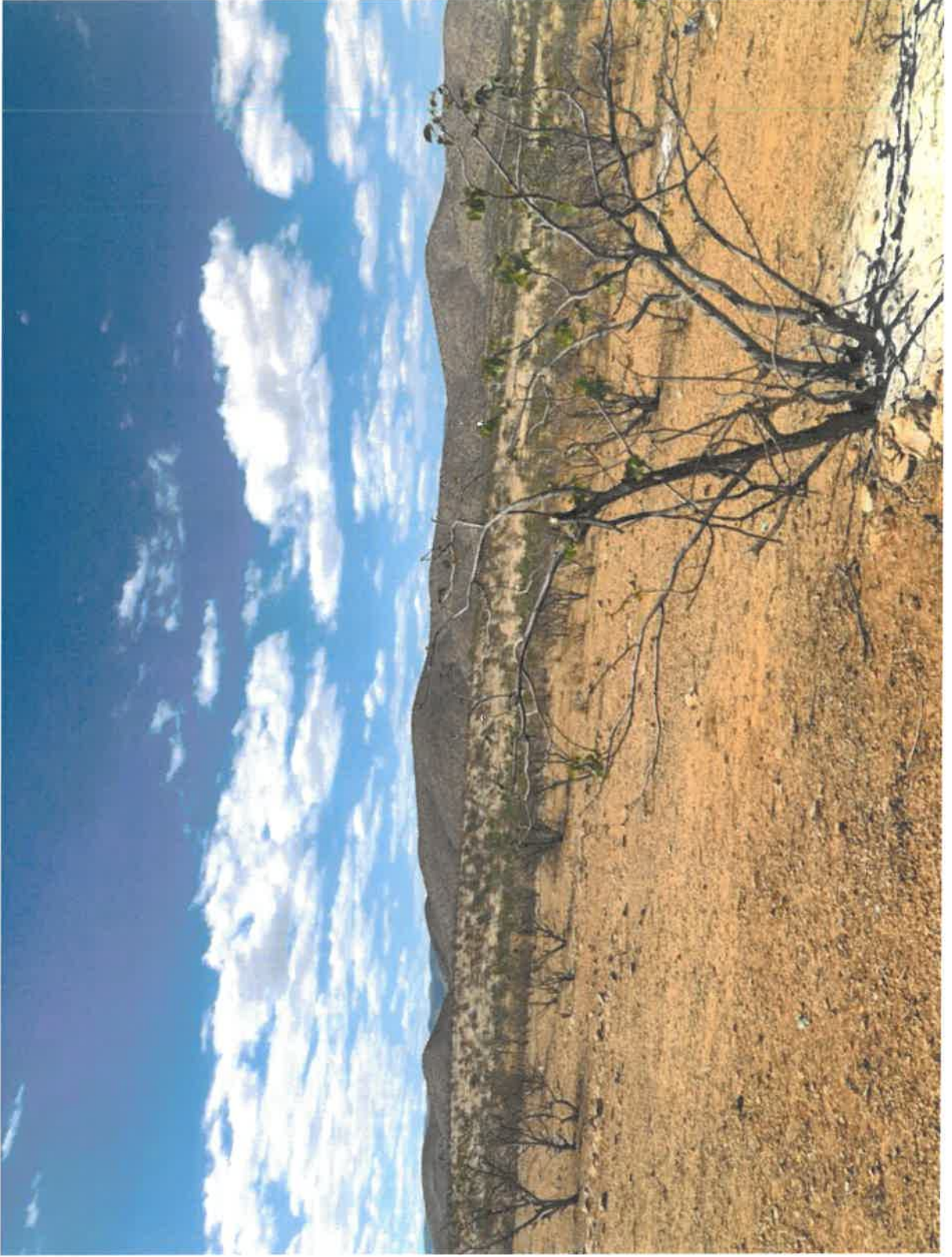

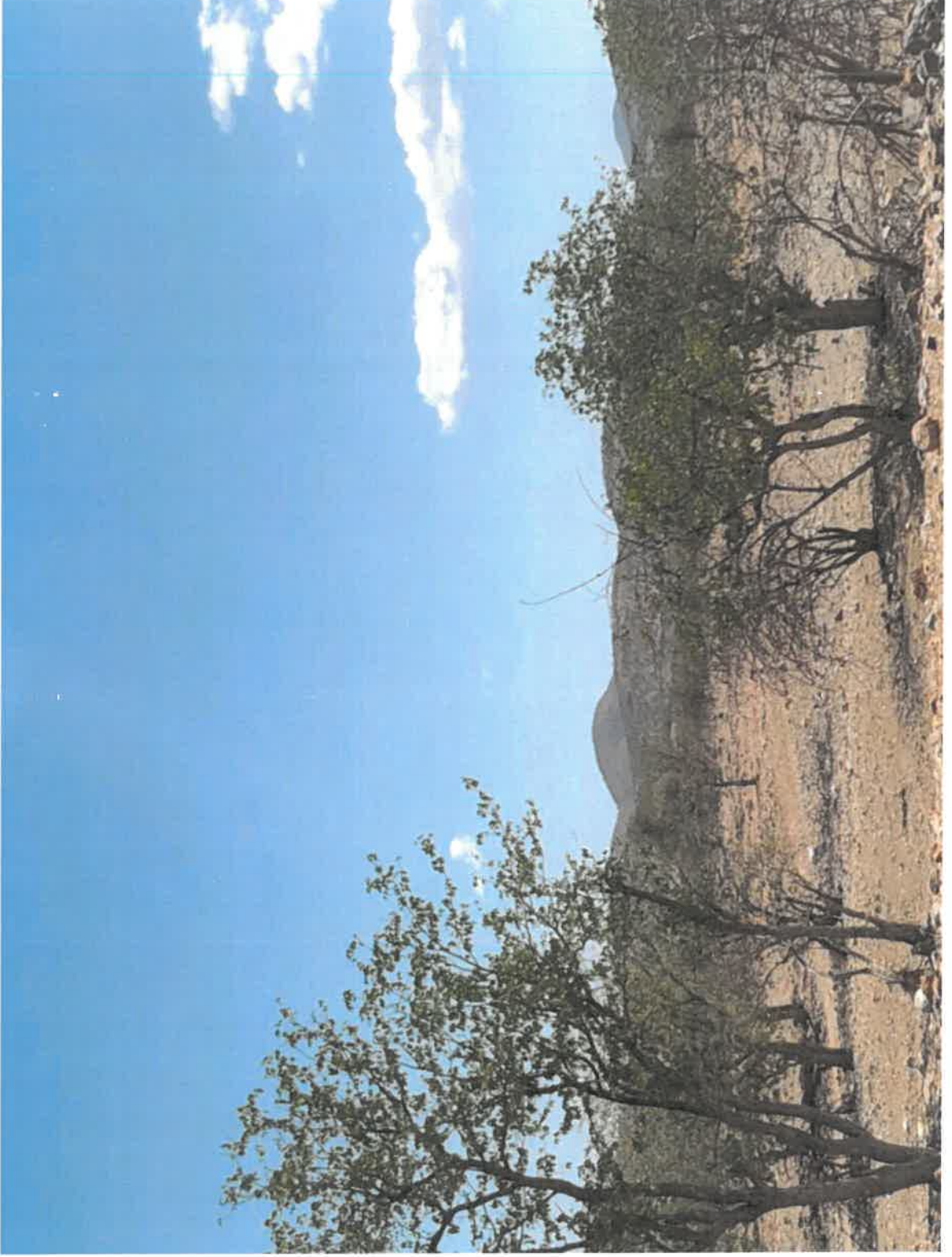

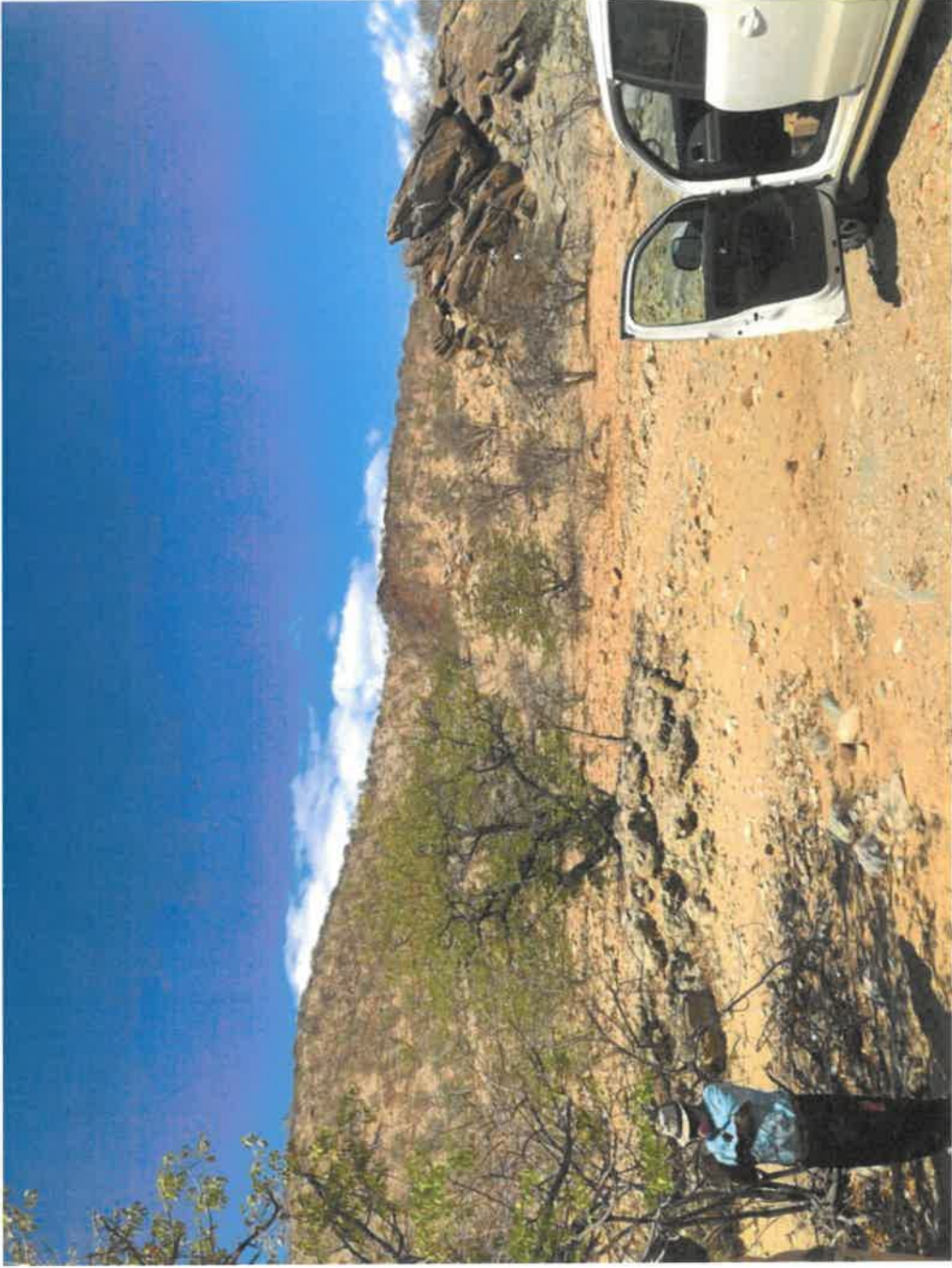

- The Proponents intend to extract base and rare metal mineral resources for commercial purposes.
- The targeted mineral resource is mainly copper, other minerals that could be found in the area include Lead-Zinc, Cobalt-Nickel deposits.
- Copper is by far the most abundant mineral commodity in Namibia.
- This is reflected not only in the fact that there are several copper mines in the country, but official data reveals that Namibian copper deposits have been exploited for centuries.
- Speculative resource availability is estimated to be sufficient to provide this project with a lifespan of approximately 10 years.
- The proposed development provides employment for 5 permanent skilled people and up to 15 locals who will be involved in the exploration phase and thus contributing to the local economy of the Otjikondavirongo Village area.

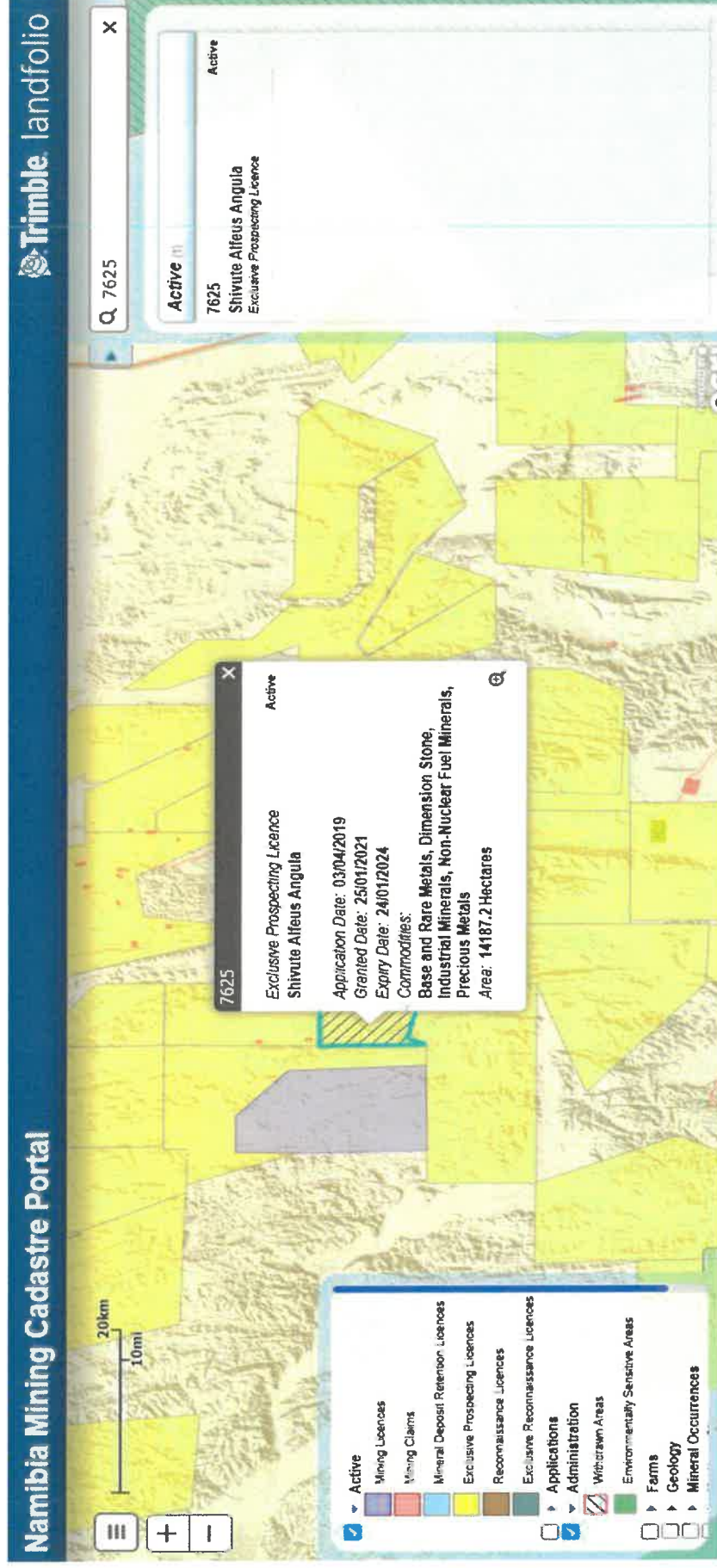

- However electricity on the site is not connected to the national grid via the regional distributor as yet and the sites will use diesel & solar power.
- Sewage is to be removed from the site mobile toilets by means of sewer removal vehicle at regular intervals for disposal at the sewerage/oxidation ponds to be constructed for the safe disposal of effluent.

# Access to Development

- Access to the EPL 7625 will be obtained from the C43 road from Opuwo into the D3705 road and continue for about 120km to arrive to destination at Otjikondavirongo.
- It is anticipated that the road network will be able to accommodate the additional traffic generated through the exploration activities as there is generally a few vehicles using these roads.

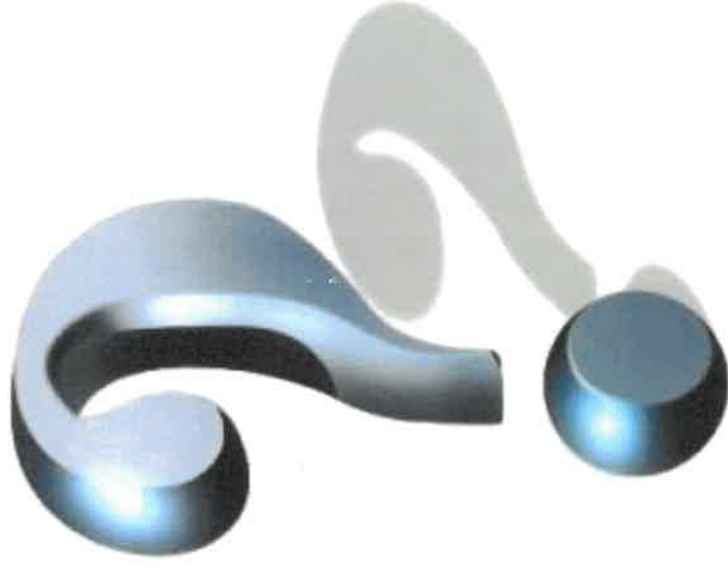

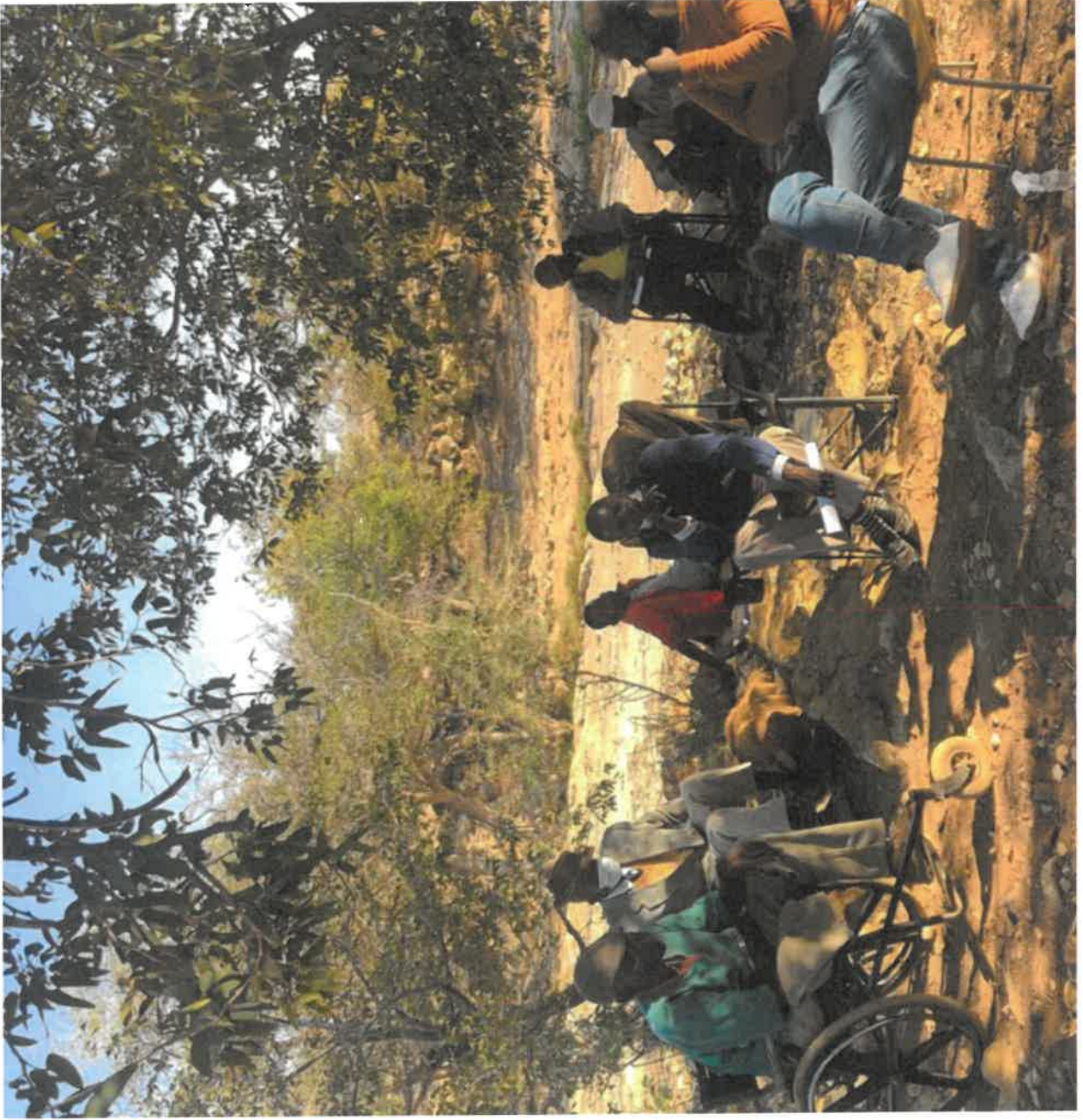
