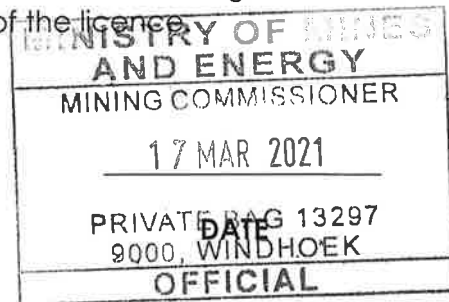
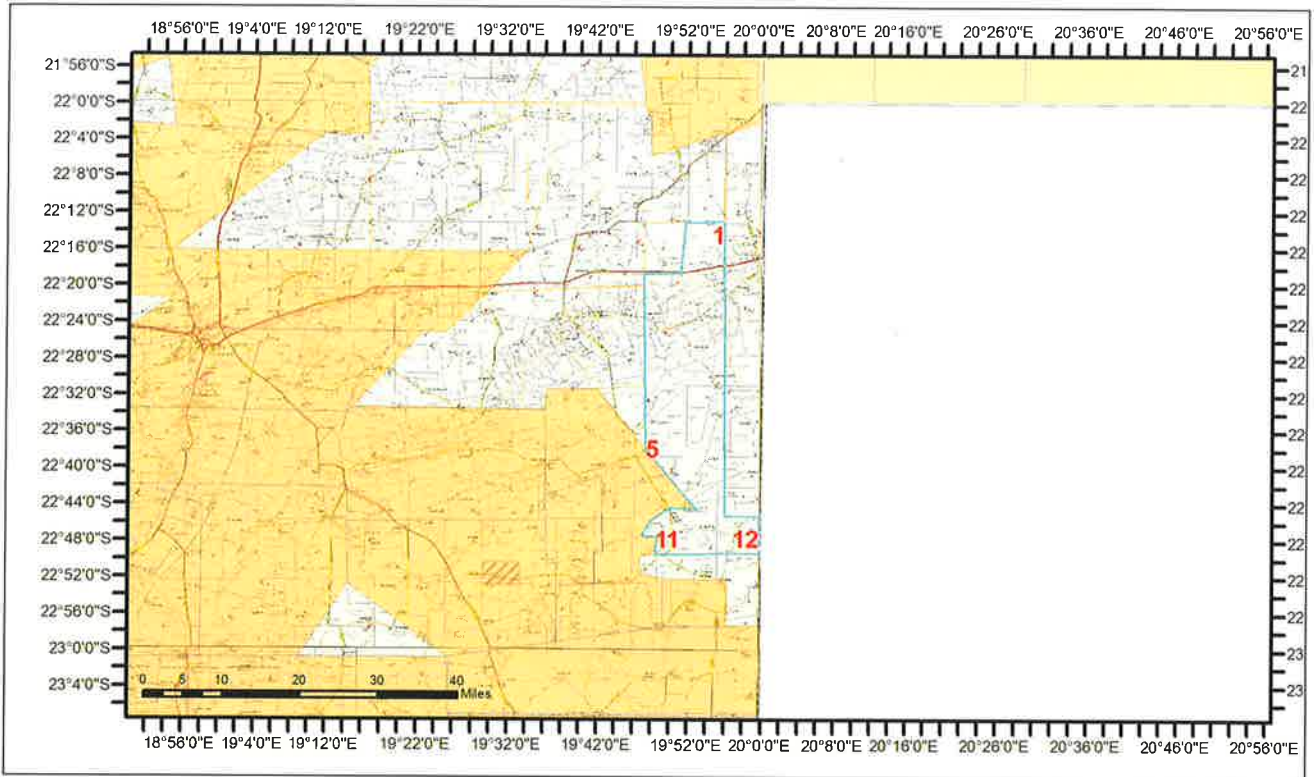
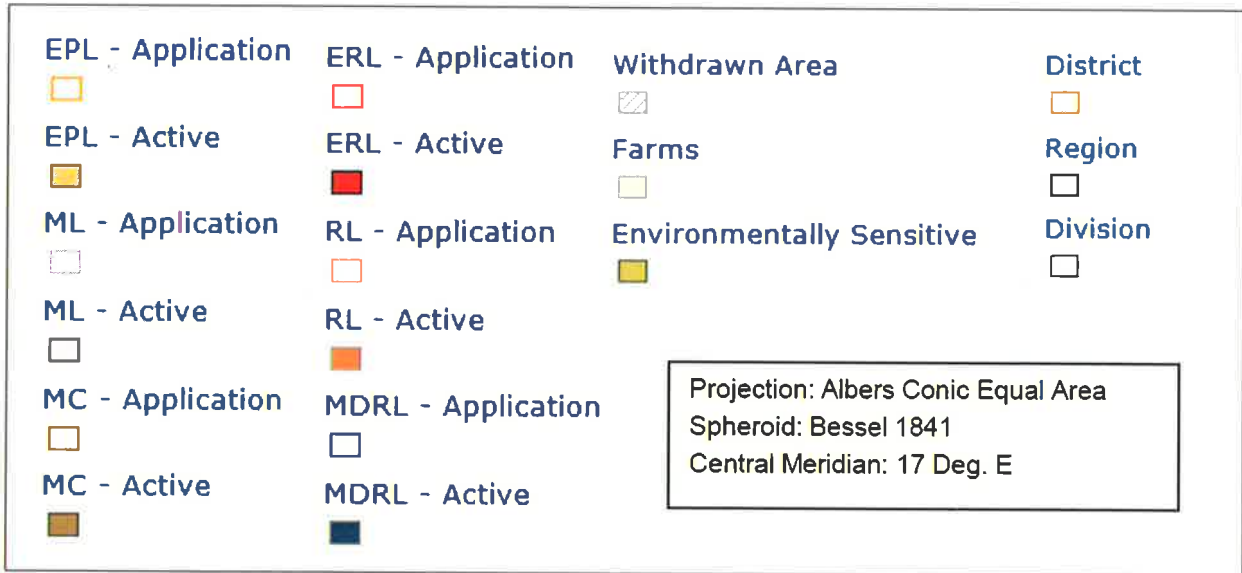


DIAGRAM – EXCLUSIVE PROSPECTING LICENCE – 8140

The holder of the exclusive prospecting licence shall undertake an Environmental Impact Assessment scoping study over the area covered by the exclusive prospecting licence, formulate and forward through the Mining Commissioner's office to the Ministry of Environment and Tourism for approval an Environmental Management Plan Report (EMPR) within six (6) months from the date of issue of the licence.

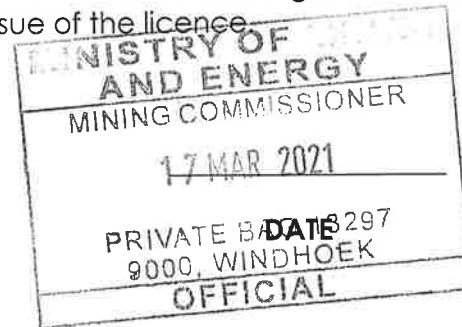
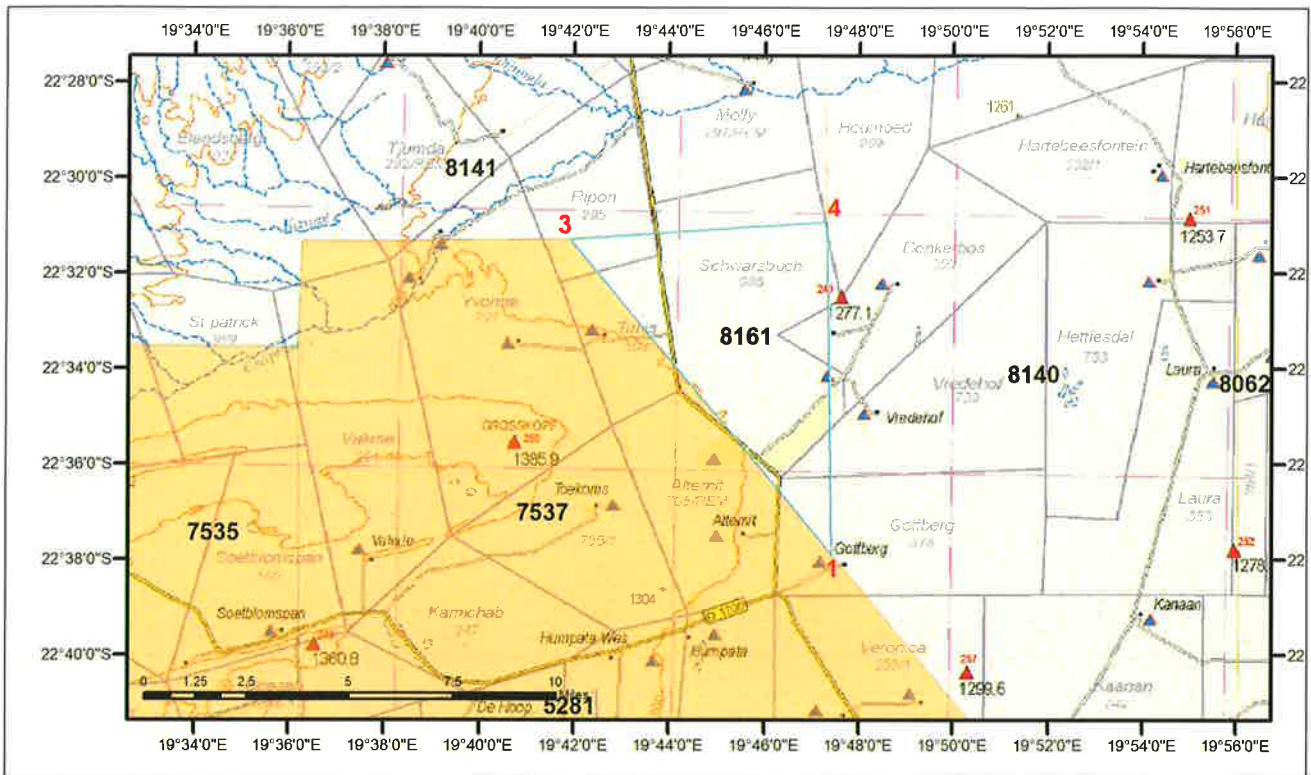
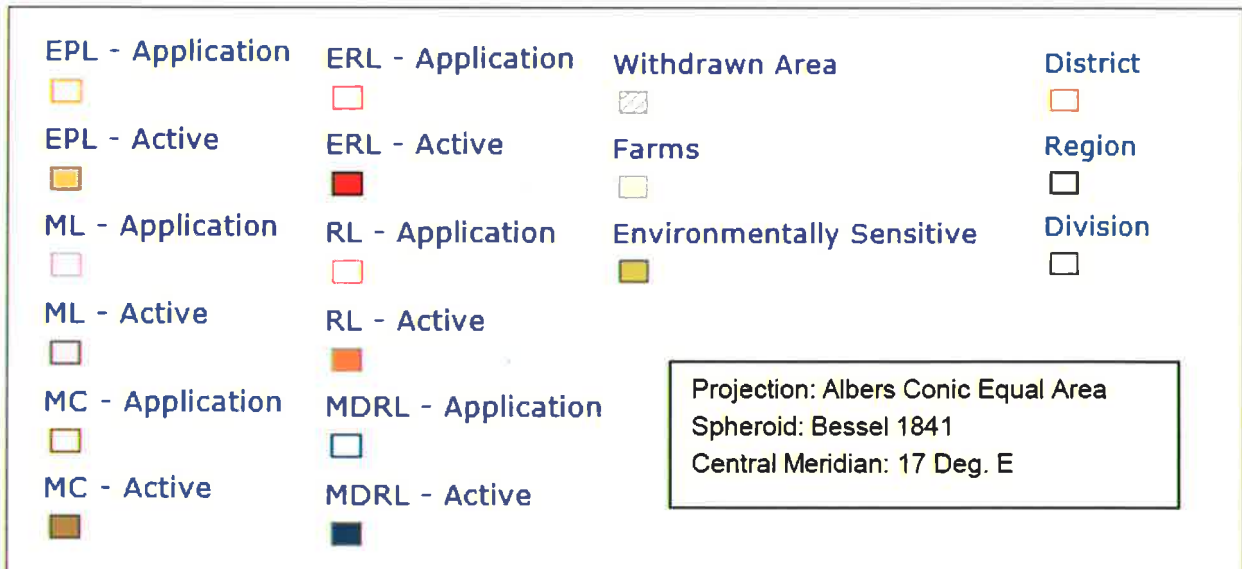


DIAGRAM – EXCLUSIVE PROSPECTING LICENCE – 8161
