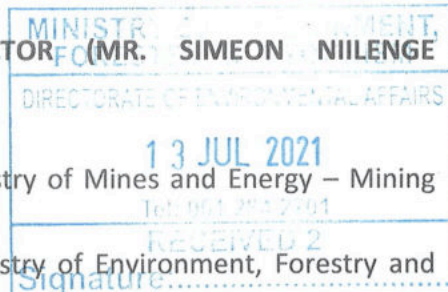

**RE: APPLICATION FOR AN ENVIRONMENTAL CLEARANCE CERTIFICATE FOR VOTORANTIM METALS NAMIBIA TO UNDERTAKE EXPLORATION ACTIVITIES ON EPL 7212, 7789, 7964, 7970, 7971, 7972 AND 7974 FOR BASE AND RARE METALS, INDUSTRIAL MINERALS AND PRECIOUS METALS IN THE KUNENE, OTJOZONDJUPA AND KHOMAS REGIONS, NAMIBIA.**
