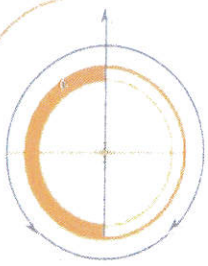

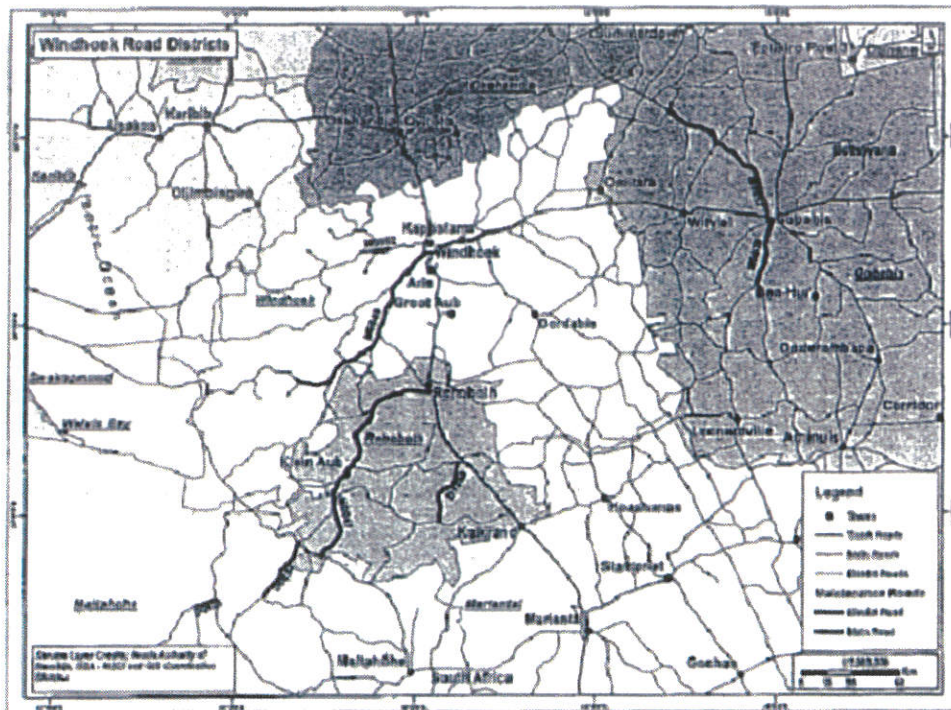


Figure 2: Location of the roads to be re-gravelled in the Windhoek Region
