LANGER HEINRICH URANIUM (Pty) LTD

The National Heritage Council of Namibia hereby grants Langer Heinrich Uranium (Pty) LTD the respective Consent in terms of Section 55 (9) of the National Heritage Act (Act No 27 of 2004). This Consent is granted in relation to the mining license area ML 140. However, this Consent is subject to the following conditions that the Council deems fit to impose in terms of Section 55 (9) of the Act.

- That all archaeological activities under this Consent shall be carried out by qualified personnel from the National Heritage Council of Namibia, Dr. John Kinahan, technical support from the National Museum of Namibia and archaeology students from the University of Namibia (UNAM).
- That a rescue excavation of all 67 archaeological sites, identified in the Reconnaissance Surveys
 Report by Dr. John Kinahan, shall be carried out by qualified personnel involving the National
 Heritage Council if Namibia, technical support from the National Museum and UNAM archaeology
 students.
- During a rescue excavation, all archaeological resources shall be collected and deposited to the National Museum of Namibia within 30 (thirty) days of their collection.
- That all future archaeological or paleontological finds found in the course of the activity authorized under this consent be recorded, conserved and delivered to the National Museum of Namibia.
- 5. That this Consent must not be interpreted as ownership that has been waived as the National Heritage Council remains an institution mandated to protect and conserve all heritage resources either registered or unregistered; it is therefore its statutory mandate to ensure that all activities on heritage conservation and related should be under the auspices of National Heritage Council.

 That Langer Heinrich Uranium considers cost provisions for such rescue excavations of all affected archaeological sites.

1. GENERAL OBLIGATIONS:

- 1.1 Langer Heinrich Uranium (Pty) LTD should recognize that its prospecting / mining activities have significant impacts on Namibia's national heritage resources. Accordingly, Langer Heinrich Uranium (Pty) LTD undertakes during the course of its operations practicable steps necessary to ensure that such mitigations will not impact the entire archaeological deposits of the Namib Desert. In doing so, it will liaise with the National Heritage Council Secretariat as provided for in 2 and 3 below.
- 1.2 That Langer Heinrich Uranium (Pty) LTD contracted archaeologists prepares archaeological mitigation measures and post-exploration rehabilitation measures. These measures should then be sent to the NHC Secretariat before a rescue excavation is undertaken.
- 1.3 Should Langer Heinrich Uranium (Pty) LTD not carry out the conditions in line with Section 55 (9) of the National Heritage Act (Act No 27 of 2004), NHC reserves the right to:
 - · Withdraw this Consent
 - Claim compensation for the damage caused to heritage resources which may have been brought about by Langer Heinrich Pty) LTD activities.

2. ARCHAEOLOGICAL CONDITIONS:

- 2.1 In accordance with section 55 (4) of the National Heritage Act, Act No. 27 of 2004, a person who discovers any archaeological, paleontological object or meteorite must as soon as practicable report the discovery to the National Heritage Council.
- 2.2 Archaeological reports should be submitted to the NHC upon completion of the rescue excavation within 2 months after work is completed. Langer Heinrich Uranium (Pty) LTD warrants that the information to be contained in the archaeological reports is to the best of its knowledge and belief true and correct.

3. COMPLIANCE AND NOTIFICATION

- 3.1 Langer Heinrich Uranium (Pty) LTD acknowledges that the reports, which it is obliged to furnish to the National Heritage Council will include archaeological heritage reports.
- 3.2 Langer Heinrich Uranium (Pty) LTD acknowledges that the officials from the National Heritage Council, National Museum of Namibia and University of Namibia archaeology students be part of this rescue excavation.
