I hereby acknowledge receipt of your client's objection as contained in your letter dated 5th November 2021. The following are my clarifications with respect to the Environmental Clearance Certificate (ECC), Background Information Document (BID), Environmental Impact Assessment (EIA) and Environmental Management Plan (EMP) and the proposed minerals exploration processes:

- 1. The BID as you rightfully pointed out under Point No. 7 of your objection letter is prepared to be used as a source of additional information by the registered stakeholders / registration of the project with the Environmental Commissioner.
- 2. The BID does not replace the need for preparing and submitting of the EIA and Environmental EMP to the Environmental Commissioner.
- 3. The environmental assessment process and steps to be undertaken for listed activities as per the Environmental Management Act (EMA), 2007 and EIA Regulation 2012 and similar to the proposed minerals exploration activities in the EPL 8158 has been provided in the BID on pages 17 and 18 Section 4.2 and clearly illustrated in Fig. 4.1 of the same document. The BID provided, does not present any findings of an assessment process nor the mitigation measures thereof in support of an application for an ECC.
- 4. In this instant an EIA and EMP document have been prepared to support the application for an ECC for the EPL 8158 and the documents are attached to this letter.
- 5. The documents required to support an application for an ECC for a listed activity are normally prescribed by the Environmental Commissioner following the screening of the BID submitted online on the MEFT Portal: http://www.eia.met.gov.na/. Once a project is register and the supporting reports have been uploaded on the Portal, the project is available for further comments / inputs/ objections by the public and registered stakeholder directly to the Environmental Commissioner. As a registered stakeholder, you will be given opportunity to comment on the reports and I will indeed notify you once the reports have been uploaded on the MEFT Portal.
- 6. The ECC application cover the entire exploration phases with respect to the specific authorisation and in this case the EPL 8158. The ECC is not linked to a single exploration stage / step, but to an authorisation and in this case the EPL 8158 as authorised by the Competent Authority (MME) to undertake exploration activities. If economic resources are discovered, then a separate ECC will be required for a Mining License (ML) as an authorisation to undertake mining activities.

- 7. Thank you very much for sharing the key baseline information of the Farm Otjombali No. 189 as detailed in Point 8 of your objection letter. We hereby take note of the highly important baseline information provided and taken into consideration in the preparation of the EIA and EMP Reports. The aim of conducting the environmental assessment is to identify key sensitive receiving environmental receptor and likely negative or positive impacts that may be caused by the proposed exploration activities and prepare mitigation measures contained in the EMP report for implementation by the Proponent.
- 8. Currently no potential minerals target/s have been delineated on the farm in question and there no guarantee that detailed field-based exploration will indeed be undertaken on this specific farm and more so, covering the entire farm resulting in negative impacts presented in your objection letter. Our study covers environmental assessment work aimed at supporting the applications for ECC for this EPL to enable the minerals rights holder to undertake field-based exploration activities if potential prospective targets are delineated during the desktop study phase. It is highly unlikely that the proposed exploration activities will have major influences on surface land carrying capacity of the farm in question or other surrounding farms in the surrounding area.
- 9. Exploration involves the collection of data in order to de-risk the theoretical geological model/s underpinning the basis for the proposed exploration process.
- 10. I am happy to arrange a meeting if needed, so that I could explain the technicalities of minerals exploration and the associated environmental impact and management processes.
- 11. Please find attached to this covering letter our EIA and EMP Reports that will be submitted to the Environmental Commissioner via the Competent Authority (MME). Comments / Inputs/ objections can bee submitted to as provided for in Regulations. PUBLIC NOTICE: APPLICATION FOR ENVIRONMENTAL CLEARANCE CERTIFICATES FOR MINERALS PROSPECTING ACTIVITIES BY MARTHA N. DAWETI - EPLS NOS. 8158 - IN RE: FARM OTJOMBALI NO. 189

We refer to the above subject.

- 1. We write on behalf of our client, Mr Benhard Zaaruka. Our client is the owner of farm OmbuyoTjimbari commonly known as Otjombali No. 189, registration division "J" situated in the green field areas, district of Okahandja, Otjozondjupa region.
- 2. Martha N. Daweti applied for minerals rights under the EPL No. 8158 with respect to base, rare metals and precious stones, dimension stones and industrial minerals. With only prospecting rights, Ms Diweti intents on conducting prospecting activities around the areas covered by the EPL 8158, which includes Farm Otjombali belonging to our client. In light of the above, Ms Daweti applied for an Environmental Clearance Certificate to be able to carry out these prospecting activities.
- 3. A public notice was published in the local newspaper informing the public that the proponent (Martha N. Daweti) intends to conduct prospecting starting with desktop studies and regional fields reconnaissance work and if the results are positive, conduct geological studies, trenching, drilling, sampling, and testing for feasibility reporting. A copy of the public notice is marked as 'BZ01".
- 4. The notice calls upon interested and affected parties to register and submit written comments/objections/ inputs with respect to the proposed prospecting activities. A background Information Document (BID) was made available to the interested parties

- 5. We hold instructions to register and submit our client's written objections on his behalf, as an interested party, to the proposed prospecting activities, which we now do.
- 6. The written comments/objections/ inputs are raised and made on the following grounds:
- 7. The proponent states under paragraph 3.2 that the BID is prepared to be used as a source of background information for stakeholders and a public consultation process as required to be undertaken as part of the environmental assessment process. It is opportune at this point to clearly but briefly set out the environmental assessment process as stipulated by the Environmental Management Act 7 of 2007 and the Environmental Impact Assessment Regulations, GG 4878 of 6 February 2012:
 - 7.1. Part VII IX of the Act determines the procedures to be followed during an environmental assessment process to which a proponent is expected to strictly comply with such procedures (reg. 3(c)). In terms of regulation 5, once an activity has been identified as a listed activity which cannot be carried out without an Environmental Clearance Certificate (ECC), the proponent must apply to the Minister for an ECC. In terms of regulation 7, the proponent must conduct a public hearing in terms of regulation 21 and must subject the proposed application to scooping as part of the initial assessment process. The proponent is required to assess the potential effects of the proposed listed activity on the environment; to determine whether and to what extend the potential effects referred to can be mitigated and whether there are any significant issues and effects that require further investigation.
 - 7.2. Our instructions are that the proponent has not met these requirements in the BID. Paragraph 4.3 of the BID does not set out the potential effects of the proposed exploring activities on the environment. With due respect, it merely indicates how the impacts are going to be assessed and the considerations to be used by the proponents in assessing the impact. The extent of such impact is also not identified. Paragraph 4.4 sets out broad concepts on mitigation measures to be adopted and the proponent does not clearly indicate how the impacts on the environment are going to be mitigated as required by regulation 7. The BID document therefore does not lay out proper information for purposes of assessing the proposed activity.
 - 7.3. Our instructions are that the above requirements would be properly covered in the scooping report and the environmental management Plan to be submitted for comments during the second phase of assessment. However, currently, the BID is of no assistance and the Client fully objects to any prospecting activities and to the granting of any ECC.

- 8. Our client's objections are further supported by the following facts:
 - 8.1. Our client invested multi-millions of dollars in the acquisition and running of the farm for farming and income generating activities. The farm generates income and employment which all stand to be adversely affected by the proposed prospecting operation activities. The prospecting operation activities will therefore cause or has the potential to cause irreparable harm to our client's business.
 - 8.2. The area in which the proposed exploration activities are to be carried out is the operational backbone of the entire farm for the following reasons:
 - 8.2.1. At the moment there are ten (10) permanent employees and their families living on the farm and surviving not only from their monthly salary, but from the natural resources on the farm.
 - 8.2.2. The camps situated in that area carry the highest capacity of large and small stock on the farm.
 - 8.2.3. In the camps designated for proposed prospecting operations activities, there are strong boreholes and two (2) water dams currently used for livestock and designated for a huge plantation project which is at an advanced stage with respect to planning and designing of the crop fields and irrigation systems.
 - 8.2.4. The plantation project will enable the farm to be self-sustainable in that it will immensely contribute to the production of food to be sold to the supermarket for generation of income.
 - 8.2.5. The plantation project will enable the farm to be self-sustainable in that the by-products from the plantation project will be used as fodder for the livestock on the farm. This is part of the farm's business proposal with respect to cost cutting measures.
 - 8.2.6. The plantation project is projected to employ twenty-three (23) permanent employees and more than one hundred and fifty (150) part-time employees. This will greatly contribute to job creation in Namibia, especially the youth and previously disadvantaged Namibians.
 - 8.3. The area where farm Otjombali is situated, is known to be home to a number of lodges and accommodation establishments, which have made considerable investments to attract tourists and to stimulate employment in the area. Plans are underway to establish a five star hotel and recreational facilities on the portion designated for

exploration activities. The prospecting exploration activities will have a negative impact on the natural topography of the area and, will negatively affect the rich flora and fauna of the area. The prospecting operations will be highly damaging to the rich biodiversity of the area and at a national level it will negatively affect Namibia's international reputation as a tourism destination of choice, which industry is crucial to the Namibian economy and is currently try to rise from the impact of Covid-19.

- 8.4. The area size on the farm designated for exploration activities is not specifically set out in the notice nor is it specified in the BID, but on observation from the map that area can be easily two thousand, three hundred hectares (2300 Ha) of farmland which can carry three hundreds (300) herd of cattle which livestock contributes to income generating activities on the farm which then enable Mr Zaaruka to service his loans, maintains one, pay land tax and levies, and pay employees on the farm. This will be negatively affected by the exploration activities on the farm, which ultimately will halt from operations activities.
- 9. The BID specifically set out that there will be a possibility of trenching and drilling on the farm for purposes of exploration, but the document does not the set out potential negative impact for the farmer and/or possible problems they will encounter during the prospecting operations activities.
 - 9.1. The BID does not set out what will happen and/or plans of succession in instances where the EPL of Martha Namutenya Daweti is acquired by a third party or third parties.
 - 9.2. Typical of the wording in the Environmental Clearance Certificate, the following phrase always appears:
 - "[t]his clearance letter does not in any way hold the Ministry of Environment and Tourism accountable for ... any adverse effects that may arise from this project activity.
 - 9.3. The proponent does not make any undertaking as to who will be held liable for adverse effects on the farm which will be caused by prospecting operations activities.
- 10. In terms of regulation 5(1), before an application for ECC is submitted to the Environmental Commissioner, the proponent must determine that the activity for which the application is made is a listed activity. It is clear that section 27 (2), read with GG 4878 of 6 February 2012: List of Activities that may not be undertaken without Environmental Clearance Certificate, Annexure, Item 3, resource removal or extraction of any natural resources is a listed activity which may only be carried out with an Environmental clearance certificate.

- 11. However, the proponent in its document indicates that the first activity to be undertaken is an initial desktop exploration activity which merely involved a review of existing information and all previous prospecting activities undertaken and as prescribed in detail under clause 2.1 of the BID. No period within which this is to commence and be completed is indicated apart from a general indication that it will last for 6 months. In any event, desktop activities are not a listed activity that needs an ECC and the application for the ECC is at this stage premature.
- 12. There is no guarantee that the desktop research will reveal the existence of natural resources as the proponent correctly points out that the prospecting activities are eventually to be done in a greenfield area historically not know to have mineral potential and that no detailed exploration activities has taken place there. The consistent assertion by the proponent in the document that have the ECC will be abandoned in the desktop research is not favorable does not assist much.
- 13. Our client is of the view that adopting the mechanisms provided for in the Act at this stage is premature and may lead to an unjustified encroachment on our client's private rights to his property so enshrined in the Namibian Constitution. Our instructions are therefore in this regard that an application for an ECC at this stage is premature.

Our client objects to the proposed prospecting operations activities and to any application for ECC for reasons set out above and his rights are strictly reserved.
