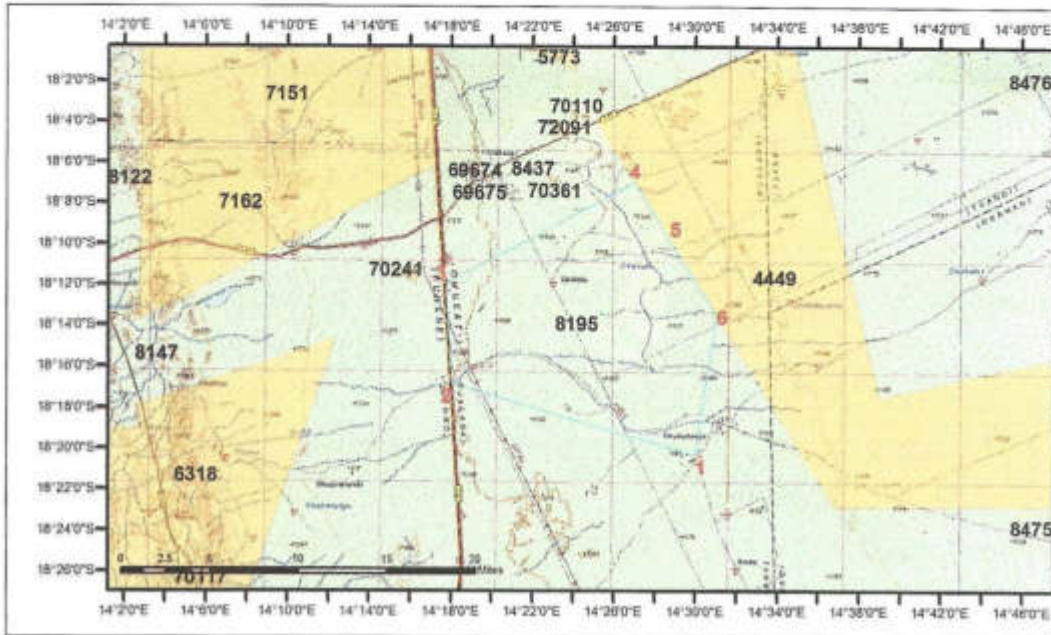

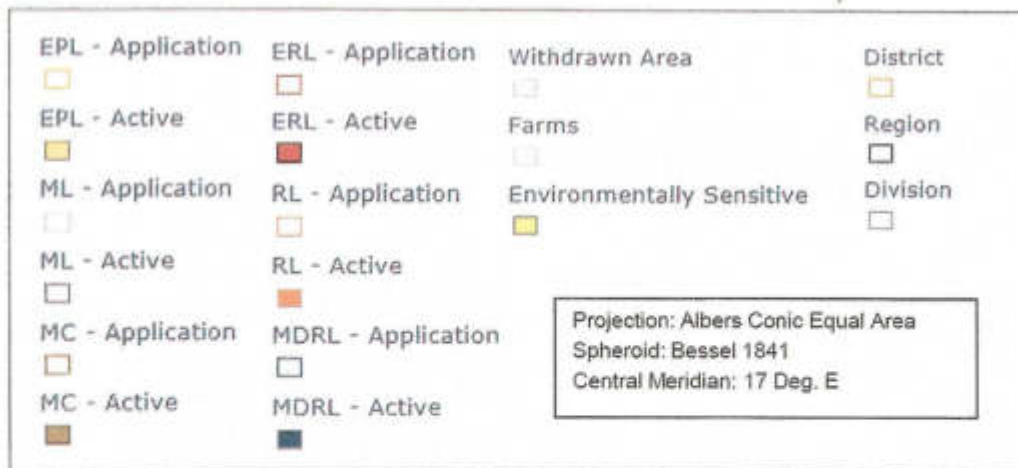


**DIAGRAM – EXCLUSIVE PROSPECTING LICENCE – 8195**
