# DRC police fend for themselves after peacekeepers quit UN base

KAMANYOLA - Doors and locks smashed, power equipment stolen, no fuel, no food, water or electricity... welcome to what's left of a UN base handed over to the Congolese police just weeks ago by peacekeepers in violence-wracked South Kivu province.

The first phase of what the Democratic Republic of Congo's government said would be an "ordered, responsible and lasting" withdrawal" by MONUSCO forces was due to be completed by 30 April.

According to the provincial authorities, peacekeepers have so far left four of the dozen bases in the province, including the post at Kamanyola, which today looks more like a slum than the outpost that Pakistani troops left barely two months ago.

"We have nothing to eat here," says Bruno, one of the policemen deployed to the camp on the Ruzizi plain.

Watched by three colleagues, he is cooking a corn or manioc paste, known locally as foufou, in a pot over a fire on the ground.

Bruno says he begged the ingredients from the nearby Protestant church.

"If I don't share it, my colleagues will die of hunger," he adds. The small group proceeds to wander through what was a UN base just two months ago.

They pass by the helicopter landing pad, where corn now grows nearly two metres (six feet) high.

"I left my wife and children in Uvira (75 kilometres further south). They are suffering down there, and we have been put in cardboard houses," he rages, punching the outside wall of the prefabricated dormitories.

Inside, sitting on a mattress, a man smokes a cannabis joint. He's in civilian clothing, but is a member of the police force's "special intervention unit".

The man admits that with fellow officers, he stole mattresses during the 28 February handover ceremony at the base attended by senior Congolese ranks and top UN officials.

"If we hadn't done that, today we would be sleeping on the wooden floor, and there are nails."

By the end of April, more than half of the 115 policemen supposed to occupy the base have deserted, a visiting *AFP* reporter discovered.

Those who remain are far from happy with the conditions and no pay.

"A policeman who spends two days without eating when he is armed... it's easy for him to attack peaceful citizens" to stock up, says Joe Wendo, an active member of a local civil society group.

He recalls that MONUSCO gave the police three Jeeps, but there is no fuel today.

"When there is a mission to do, how can they move around. That's a problem," says Wendo.

The Ruzizi plain, close to Rwanda and Burundi, has a reputation for robbery and kidnapping.

"The disengagement process by MONUSCO is progressing well," declares Gaston Cissa wa Numbe, provincial minister in charge of liaison between government and the UN in South Kivu.

He tells *AFP* there have been "some challenges, mainly in supplying electricity and drinking water".

But, he assures, "a solution has now been found".

The 15 000 MONUSCO troops deployed in the vast central African country started to leave in February at the request of the Kinshasa government, which considers them ineffective.

A second phase of the UN departure plan concerns wartorn North Kivu where M23 rebels, backed by Rwanda army units, have seized swathes of territory.

At the start of April, several UN bases, set up to defend the provincial capital Goma, were taken over by the rebels after UN peacekeepers ignored orders and abandoned them.

The mission was set up in 1999 in a bid to halt the second DR Congo war, which saw local forces backed by Angola, Namibia and Zimbabwe fight rivals supported by Uganda and Rwanda.

Hundreds of thousands of deaths are blamed on the succession of conflicts since the 1990s.

At its peak, 20 000 UN troops were in the country, where more than 270 MONUSCO peacekeepers have been killed, according to UN figures.

Kinshasa has called for the UN withdrawal to be completed by the end of 2024, but the Security Council has not set a date.

The UN estimated at the end of 2023 that nearly seven million people were displaced in DR Congo, including 2.5 million in North Kivu alone.

# Spotlight on South Africa's democracy

OHANNESBURG - In a year when more than 2.9 billion people in 64 countries - as well as the European Union - already have or will soon elect new governmental leaders, South Africa's election still stands out as unique.

An American political expert notes that South Africans vote for a political party on a nationwide basis while in all other major democracies, citizens choose between two or more individuals competing in a defined geographic area.

"In South Africa, each political party selects the parliamentarians to serve from among its members, depending on the percentage of votes they receive in the election," observed American public policy consultant Godfrey Harris, president of the Los Angeles-based Harris/ Ragan Management Group and a former staff member of US' 36th president Lydon Johnson.

"Asaresult, partymembers owe their primary loyalty in governing to an impersonal political organisation rather than to fellow citizens, or their conscience.

"Government by party is a common feature of authoritarian governments such as in Russia and China, and was seemingly designed into the South African constitution to make the transition from apartheid to a majority rule democracy smoother, quicker and more manageable by the ANC."

Harris believes that this disconnect between government and the people is part of the reason that corruption in the country seems so difficult to deal with

"It is as if there are two different worlds operating in parallel within South Africa-one for the leadership of the major political parties where the spoils of government are allocated, and another for everyone else," he said.

" M e m b e r s o f parliamentary bodies in such democracies as the USA, UK and France provide voters with a connection to the wide variety of government services paid for with their taxes.

"It establishes a clear

quid pro quo: I vote for Candidate X and X, once elected, makes sure that the policies I believe in and the services I need from government are delivered to me.

"For South African citizens, however, the equation has evolved in a totally different way.

"I vote for a party out of heritage, loyalty or habit, even if I know that that party will likely ignore my needs when it comes to its actions in and out of parliament."

Harrisnotes, nevertheless, that at least one political party in the 2024 South African election campaign seems to be trying to change the current situation.

"The United Democratic Movement is using word of mouth promotional techniques to tell voters that if you give us more clout in a new government, the equation will change," he said.

"The UDM has promised to extend the word of mouth connections it is making to an office in its headquarters to link its supporters with the agencies of the national government that can solve a problem, evaluate an idea, or implement a suggestion from its supporters."

Harris thinks that such a connection among voters, UDM party officials, and government agencies would be immensely beneficial, especially to rural communities, which have been generally ignored in the delivery of government services.

He noted that "only the UDM has recognised this needinits political manifesto. There, the UDM pledges to ensure that South African rural communities benefit significantly from their natural resources through trade in wildlife products, trade in subterranean resources, carbon credits and medicinal plants benefits."

Harris added: "In stark contrast, other parties say nothing about rural communities in their manifestos.

"To be fair, the ANC has recently pledged - well into the campaign and long after the UDM manifesto was published to do the same thing, but only in policy announcements that might never be fully implemented."

The UDM is led by

South Africa's former deputy minister of environment, and an unwavering corruption-fighter, general Bantu Holomisa. Hehaspromised in his party's manifesto to push the new government on the need for rural communities to benefit significantly from the natural resources that abound around them.

Harrissaidthatheapplauds Holomisa's ideas "for making South Africa's democracy more representative, and finding ways to bring rural and younger South Africans into the country's political life."

Harris's first job in politics, he noted, was in 1952 as a 15-year-old receptionist in general Dwight D Eisenhower's Beverly Hills (California) campaign office. Eisenhower proved to be both a successful military leader as well as an effective politician, who was twice elected president by the American people.

"Itwouldbeinspiringtosee general Holomisa widen his political accomplishments to match his military successes, as Eisenhower did," said Harris.

Meanwhile, Harris was stunned to learn in a conversation with a political operative in South Africa that "some citizens consider Nelson Mandela a failure in his service to South Africa."

#### Why?

The individual said "Mandela did not get South Africa on a track that would make it a success in the eyes of the world. Instead, Mandela tolerated the ANC's penchant to allow corruption as the price of establishing a fully-functioning government."

Harris said that most disappointing element of the conversation with the Mandela critic was "the realisation that the individual - and probably most of the electorate as well - do not seem to appreciate all that is involved in governing a democracy."

He said, "It (governing) is far more than just making speeches, cutting ribbons, greeting foreign dignitaries and expressing condolences after a disaster.

"I believe that ignorance allows so much of the ills of the country to fester."

# Address fishermen's plight - Venaani

The Popular Democratic Movement (PDM)'s leader McHenry Venaani said if the government's redress programme is not addressed immediately, it will result in a Fishrot 2.0.

The redress programme was launched in 2020 by the Ministry of Fisheries and Marine Resources in collaboration with the Ministry of Labour, Industrial Relations and Employment-Creation, aimed at addressing unemployment among fishermen.

We call on the Ombudsman to begin investigating this matter immediately and come forward with the necessary recommendations for reform, and

failure to do so will not be tolerated," he expressed.

Venaani was speaking at the commemoration of the PDM's Workers' Day rally in Walvis Bay last Wednesday, where he noted that the party is prepared to pursue all avenues of justice, including approaching the highest courts, to test the efficacy of government policies and interventions.

"Our fishermen deserve better, and we will not rest until they receive the justice they deserve. We stand in solidarity with our fishermen and all workers who are fighting for justice and dignity. We therefore demand accountability from our government, and insist on fair and transparent practices

in the allocation of resources and opportunities," he said.

PDM secretary general Manuel Ngaringombe assured that the event was not a PDM campaign rally, but rather a commemorative event in solidarity with the workers as well as the unemployed.

"We want to give the real state of the Namibian workers and not the fake, mixed and made-up stories that happened this morning at the national commemorations of Workers Day in Rundu. We want to address the unfair labour practices faced by workers such as fishermen, petrol attendants and security guards, among others, in the Erongo region," he said.

# 'Omukokoli' lindji laid to rest

OMBUGA YA MUNYOKO - Renowned banker and former Namibia Chamber of Commerce and Industry northern branch chairman Tomas Koneka Iindji was laid to rest at his home village, Ombuga ya Munyoko, on Saturday.

He was 44. Iindji, known affectionately as 'Omukokoli', died last month at a Windhoek hospital after a short illness.

Scores of mourners from all walks of life thronged Ombuga ya Munyoko to pay their last respects. Approximately 10 000 mourners, including Prime Minister Saara Kuugongelwa-Amadhila, Cabinet ministers, regional governors, the business community, church leaders, the banking fraternity and politicians attended the burial.

Most described the late Iindji as an active, dedicated and selfless man.

In a statement delivered on her behalf by Swapo central committee member Naemi Hamufenu, party vice president Netumbo Nandi-Ndaitwah said Namibia has lost a dedicated and hardworking professional who distinguished himself as a highly experienced banker and business leader.

Over the years, Iindji has served as a dedicated leader of the Namibia Chamber of Commerce and Industry (NCCI) in

the northern part. He contributed to the growth of the NCCI," Nandi-Ndaitwah said, adding that Iindji was a mouthpiece for the business community in the northern regions. "With his passing, death has robbed our country of a trusted business executive whose void will be difficult to fill," she said. Comforting the family, Nandi-Ndaitwah said they lost a dependable member who was a pillar of strength, a father, a provider and a role



"A few years ago, he initiated a social organisation namely the Koneka Social Club, named after himself, which promoted and carried out welfare programmes for the youth, elderly and formerly disadvantaged Namibians, especially in the Oshana region," she reminisced. Also speaking at the occasion, Iindji's nephew Willem Amutenya said, "He inspired and motivated us in all spheres, be it business, academics, leadership or politics, especially the young people in the family."

He added that his late uncle connected and strengthened their bond in the family with his charisma. The business community described Iindji as a courteous man who did not discriminate. At the memorial service, villagers stated that Iindji was always kind and assisted them.


Also speaking at the funeral was Hosea Namusha, the pastor of Othika Elcin Parish. He said İindji leaves a huge void in their congregation.





Hello John and Fredrika.

Apologies for the late response - hope our comments can still be added to the scoping report. Our comments:

For the building phase:

- . Ultimate Safaris should keep in touch with SRT and conservancies on dates and plans for building so that we can make sure to have a team present in the area during construction
- . Contractor to send names, cell phone numbers and ID numbers of all workers on site for screening with Blue Rhino Task Team. These details can be sent to SRT and we'll forward them on

For the operational phase:

- . The rhino tracking taking place from the lodge should be coordinated with existing tracking activities for example from Camp Doros and Onduli Ridge so as not to place too much pressure on the rhinos through noise and other disturbance
- Rhino tourism viewing protocols as established at Desert Rhino Camp should be implemented during rhino tracking at all times. This includes zone rotation so as not to visit the same rhino on consecutive days
- . Plans to base a helicopter at Onduli to ferry guests to the new lodge should be thoroughly discussed with all stakeholders including conservancies and MEFT. We are mindful of disturbance to rhinos from helicopters and - should MEFT approve the use of a helicopter in the area - would need a very strong operational plan for pilots and Ultimate Safaris which focuses on minimising impact on rhinos. Likewise the use of a fixed wing to ferry guests will need to be tabled for more thorough discussions and lesson learning from existing camps (Desert Rhino Camp)

Having said all the above I know Ultimate as a responsible operator who understands that rhinos form the basis of their product in the area.
