ENVIRONMENTAL IMPACT ASSESSMENT (EIA) FOR THE PERMANENT CLOSURE OF THE STREET PORTIONS A AND B OF ISMAEL ABRAHAM AND/OR MOSHITILA STREET, SUBDIVISION OF ISMAEL ABRAHAM AND/OR MOSHITILA STREET AND CONSOLIDATION OF PORTIONS A AND B OF ISMAEL ABRAHAM AND/OR MOSHITILA STREET WITH ERVEN 3209 AND R1797, MONDESA, SWAKOPMUND.

1. INTRODUCTION

The Municipality of Swakopmund has in principle approved the sale of the two street portions (Portions A and B of Ismael Abraham Omundele and/or Moshitila Street) to Ms. A. Uushona (herein referred to as the Proponent). The proponent intends to permanently close off the Street Portions A and B of Ismael Abraham and/or Moshitila Street, subdivision of Ismael Abraham and/or Moshitila Street consolidation of Portions A and B of Ismael Abraham and/or Moshitila Street with erven 3209 and R1797, Mondesa, Swakopmund. According to Section 27 of the Environmental Management Act No. 7 of 2007, land use and development activities may not be carried out without undertaking an Environmental Impact Assessment (EIA) and obtaining Environmental Clearance Certificate (ECC).

SandSea Consulting was appointed to undertake the EIA process and to apply for an ECC, in terms of the Environmental Management Act No. 7 of 2007 and its Regulations of 2012.

2. PURPOSE OF THIS DOCUMENT

This background information document provides a brief description of the project and EIA process to be followed and identifies the potential broad environmental impacts, and invites Interested and Affected Parties (I&APs) for comments and input on the proposed project.

3. PROJECT DESCRIPTION

The Municipality of Swakopmund has in principle approved the sale of the two street portions (Portions A and B of Ismael Abraham Omundele and/or Moshitila Street) to the Proponent as per

Council Resolution of 25/03/2021 under item 11.1.19.




Figure 2: Proposed Site after the Closure (in red)




Figure 3: Depicting the existing Erven zoning (encircled & bolded)

The proposed street is in between single residential erven that are occupied. Figures 1 and 2 below depict the proposed activity. The Proponent intends to permanently close the two street portions, subdivide and consolidate the portions with erven 3209 and R1797 and assume the same zoning. The proposed area measures approximately 331m². The zoning is Single Residential as shown in Figure 3.

4. ENVIRONMENTAL IMPACT ASSESSMENT (EIA) PROCESS

This BID forms part of the environmental assessment process. A scoping report will be drafted and presented to the Interested and Affected Parties (I&APs) during the consultation period, based on the comments received and the findings of the assessment. The finalized report will be submitted to the Ministry of Environment, Forestry and Tourism (MEFT): Department of Environmental Affairs and Forestry (DEAF) for approval.

The scoping study provides information on the proposed project and the environment in which it is situated. It identifies, in consultation with I&APs/stakeholders, the potential negative as well as positive impacts of the project. It reports on management measures required to mitigate such impacts to an acceptable level.

The Scoping Report will include an assessment and Environmental Management Plan (EMP). The EMP will detail measures to be implemented during the lifecycle of the proposed activities to ensure that all issues and impacts are monitored, managed and mitigated.

The following are the initial broad potential impacts expected from the construction and operation phases of the proposed project:

- Solid and liquid waste management;
- Traffic impacts;
- Noise and dust pollution, and
- Socio-economic impacts

5. PUBLIC CONSULTATION

This includes anyone that will be directly or indirectly involved, affected and/or interested by the proposed project. This may include but is not limited to adjacent landowners and tenants around the proposed project's location, and all relevant authorities.
