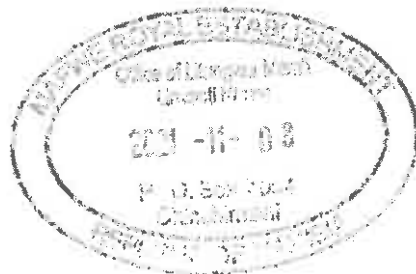

This topic was already introduced to the Chief by the Chairperson of the Zambezi Regional Council. The Hon Chief is interested in seeing development of the land that he avails to government or private sector.


The Hon Chief agreed to avail 5000 hectares to Tulela Agriculture (Pty) Ltd and is requesting:
