EXECUTIVE SUMMARY

Introduction

Gisela Elke Müller, hereinafter referred to as the proponent intends to undertake the following activities:

- **Subdivision of Portion 5 (Ondekaremba Kleinsiedlung) of Farm Ondekaremba No.78 into Portions A to J and Remainder;**
- **Registration of 20 meter Right of Way Servitude over Farm Neudam No 63 in favour of Portion 5 of Farm Ondekaremba No 78;**
- **Registration of a 20 meter Right of Way Servitude over the Remainder of Portion 5 of Farm Ondekaremba No 78 in favour of proposed Portions A to J.**

The above development triggers listed activities in terms of the Environmental Management Act (No. 7 of 2007) and Environmental Impact Assessment Regulations (Government Notice No. 30 of 2012).

As such the proponent appointed Stubenrauch Planning Consultants (SPC) to undertake an independent Environmental Assessment (EA) in order to obtain an Environmental Clearance Certificate (ECC) for the above activities. The competent authority is the Ministry of Environment, Forestry and Tourism: Department of Environmental Affairs and Forestry (MEFT: DEAF).

Project Description

Portion 5 of Farm Ondekaremba No.78 is currently vacant and unutilised. The size of the subject portion is not big enough to allow for large scale agricultural activities. It is therefore the proponent's intension to subdivide Portion 5 into 10 portions and the Remainder (**Figure 7**). The proposed subdivision will enable the owner to sell the proposed portions to prospective buyers who will, in line with the Kapps Farm Town Planning Scheme, have the primary right to use the portions for agricultural purposes and dwelling units.

Public Participation

Communication with Interested and Affected Parties (I&APs) about the proposed development was facilitated through the following means and in this order:

- A Background Information Document (BID) containing descriptive information about the proposed activities was compiled and sent out to all identified and registered I&APs via email on **15 July 2021**;
- Notices were placed in Namibian Sun, Allgemeine Zeitung and the Republikein newspapers dated **15 July 2021 and 22 July 2021**, briefly explaining the activity and its locality, inviting members of the public to register as I&APs (**Appendix B**); and
- A notice was fixed at the project site (see **Appendix A**).

Public consultation was carried out according to the Environmental Management Act's EIA Regulations. After the initial notification, the I&APs were given two weeks to submit their comments on the project (until **5 August 2021**).

The Draft Scoping Report was circulated from the **30 August 2021 until the 13 September 2021** so that the public could review and comment on it.

Conclusions and Recommendations

With reference to **Table 8**, none of the negative construction phase impacts were deemed to have a high significant impact on the environment. The construction impacts were assessed to a **Medium to Low (negative)** significance, without mitigation measures. With the implementation of the recommended mitigation measures in Chapter 7 as well as in the EMP, the significance of the construction phase impacts is likely to be reduced to a **Low (negative)**.

With reference to **Table 8**, none of the negative operational phase impacts were deemed to have a high significance impact on the environment. The operational impacts were assessed to a **Medium (negative)** significance, without mitigation measures. With the implementation of the recommended mitigation measures in Chapter 7 as well as in the EMP, the significance of the construction phase impacts is likely to be reduced to a **Low (negative)**.

It is recommended that this project be authorised because should the development not proceed the portion will remain mostly undeveloped and the proposed portions would not have access. None of the positive or negative impacts from the proposed development would be realized.

The “no go” alternative was thus deemed to have a High (negative) impact, as all the benefits resulting from the development would not be realised.

The significance of negative impacts can be reduced with effective and appropriate mitigation provided in this report and the EMP. If authorised, the implementation of the EMP should be included as a condition of approval.

1 INTRODUCTION

1.1 PROJECT BACKGROUND

Gisela Elke Müller, hereinafter referred to as the proponent intends to undertake the following activities:

- **Subdivision of Portion 5 (Ondekaremba Kleinsiedlung) of Farm Ondekaremba No.78 into Portions A to J and Remainder;**
- **Registration of a 20 meter Right of Way Servitude over Farm Neudam No 63 in favour of Portion 5 of Farm Ondekaremba No 78;**
- **Registration of a 20 meter Right of Way Servitude over the Remainder of Portion 5 of Farm Ondekaremba No 78 in favour of proposed Portions A to J.**

The above development triggers listed activities in terms of the Environmental Management Act (No. 7 of 2007) and Environmental Impact Assessment Regulations (Government Notice No. 30 of 2012).

In terms of the Environmental Management Act (No. 7 of 2007) and Environmental Impact Assessment Regulations (Government Notice No. 30 of 2012), the following listed activities in **Table 1** were triggered by the proposed project:

The above activities will be discussed in more detail in Chapter 4. The proponent appointed Stubenrauch Planning Consultants (SPC) to undertake an independent Environmental Assessment

(EA) in order to obtain an Environmental Clearance Certificate (ECC) for the above activities. The competent authority is the Ministry of Environment, Forestry and Tourism: Department of Environmental Affairs (MEFT: DEA).

The process will be undertaken in terms of the gazetted Namibian Government Notice No. 30 Environmental Impact Assessment Regulations (herein referred to as EIA Regulations) and the Environmental Management Act (No 7 of 2007) (herein referred to as the EMA). The EIA process will investigate if there are any potential significant bio-physical and socio-economic impacts associated with the intended activities. The EIA process would also serve to provide an opportunity for the public and key stakeholders to provide comments and participate in the process.

1.2 PROJECT LOCATION

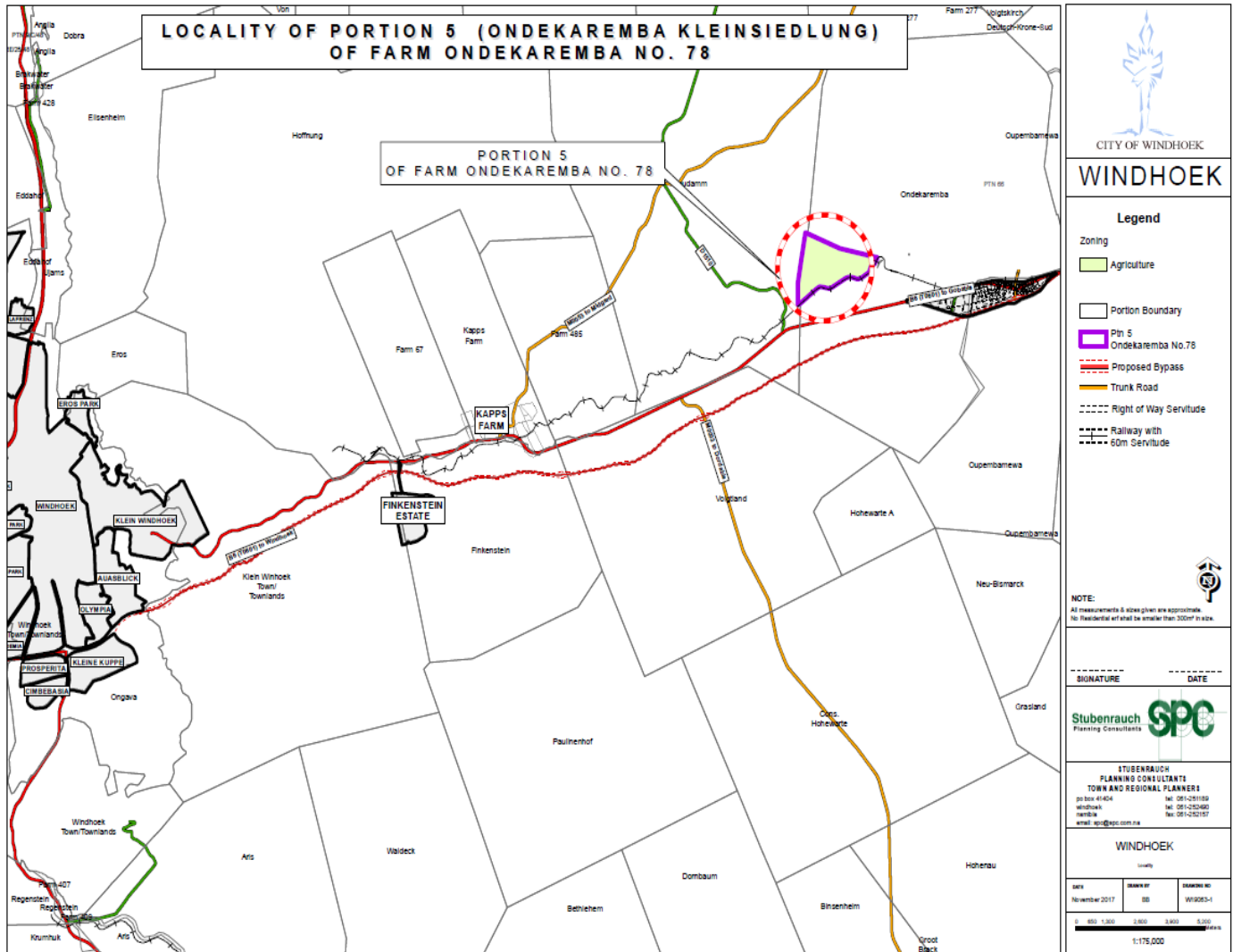


Figure 1: Locality of Portion 5 (Ondekaremba Kleinsiedlung) of Farm Ondekaremba No 78

Portion 5 (Ondekaremba Kleinsiedlung) of Farm Ondekaremba No.78 is situated approximately 35km east of Windhoek adjacent to Portion 47 of Portion 2 of Farm Ondekaremba No.78, Remainder of Portion 6 of Farm Ondekaremba No.78 and Farm Neudamm No. 63. The subject portion forms part of the extended City of Windhoek townlands boundary and measures 420.6102 Hectares in extent. According to the Kapps Farm Town Planning Scheme, Portion 5 of the Farm Ondekaremba No.78 is zoned for "Agriculture" purposes. Please refer to below locality map (**Figure 1**).

1.3 TERMS OF REFERENCE AND SCOPE OF PROJECT

The scope of this project is limited to conducting an environmental impact assessment and applying for an Environmental Clearance Certificate for the following as indicated in section 1.1 above:

- **Subdivision of Portion 5 (Ondekaremba Kleinsiedlung) of Farm Ondekaremba No.78 into Portions A to J and Remainder;**
- **Registration of a 20 meter Right of Way Servitude over Farm Neudam No 63 in favour of Portion 5 of Farm Ondekaremba No 78;**
- **Registration of a 20 meter Right of Way Servitude over the Remainder of Portion 5 of Farm Ondekaremba No 78 in favour of proposed Portions A to J.**

1.4 ASSUMPTIONS AND LIMITATIONS

In undertaking this investigation and compiling the Environmental Scoping Report, the following assumptions and limitations apply:

- Assumes the information provided by the proponent is accurate and discloses all information available.
- The limitation that no alternative except for the preferred layout plans and the 'no-go' option was considered during this assessment. The unique character and appeal of the Ondekaremba area were however taken into consideration with the design perspective.

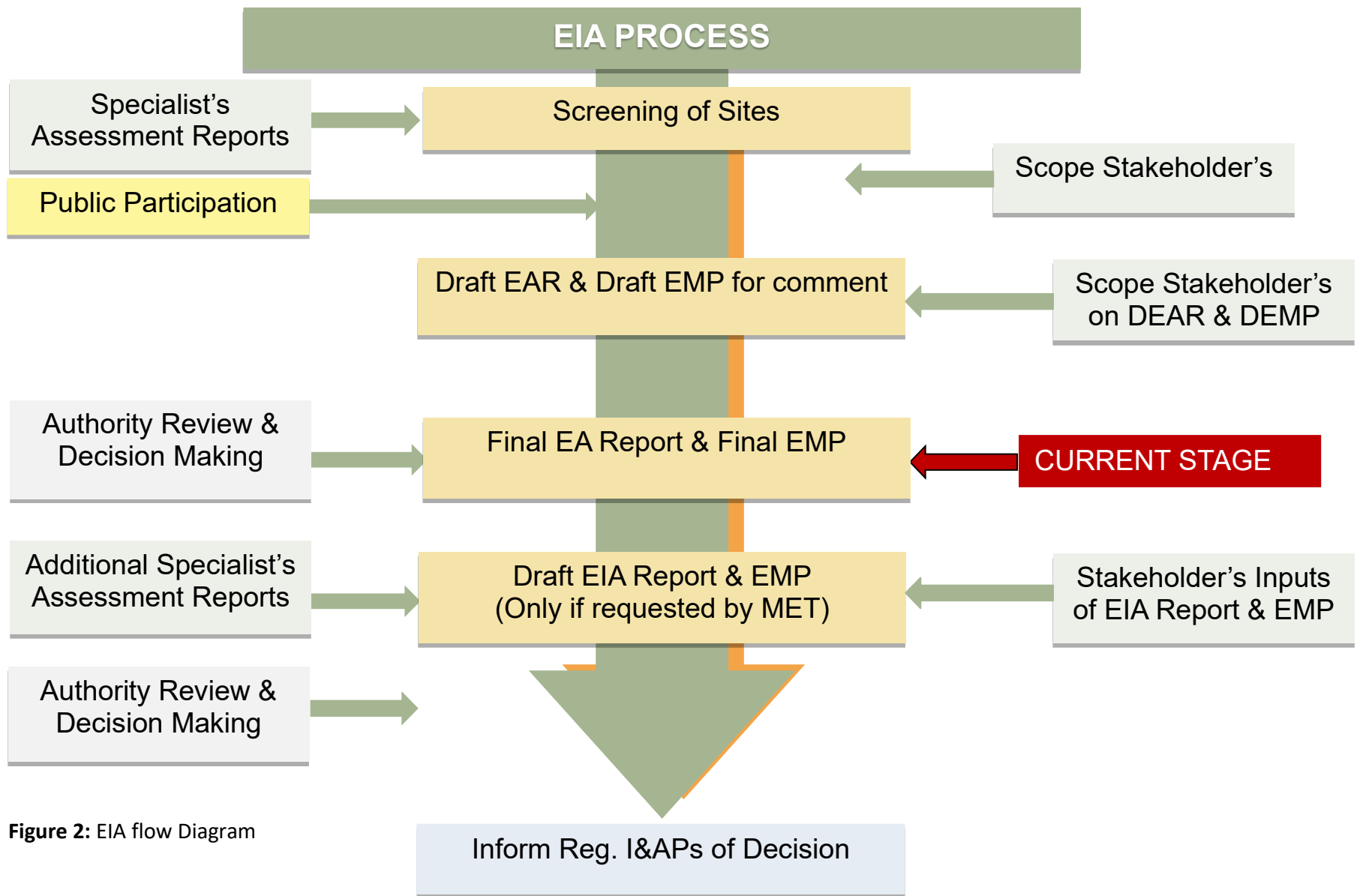


Figure 2: EIA flow Diagram

3 ENVIRONMENTAL BASELINE DESCRIPTION

3.1 SOCIAL ENVIRONMENT

3.1.1 Socio-Economic Context

The statistics shown in **Table 4** below are derived from the 2011 Namibia Population and Housing Census (Namibia Statistics Agency, 2013a), and presented from a local and regional perspective.

3.1.2 Archaeological and Heritage Context

It is unlikely that the proposed project area will have any significant archaeological resources due to the fact that no major historical activity took place within close proximity to the sites. An accidental find procedure may, however, be required in the EMP.

3.2 BIO-PHYSICAL ENVIRONMENT

3.2.1 Climate

The Ondekaremba area is classified as hot semi-arid (steppe) climate according to the Köppen climate classification (“Ondekaremba, Khomas, Namibia”, 2021). The average annual temperatures range between 19°C to 20°C as indicated in **Figure 4**.

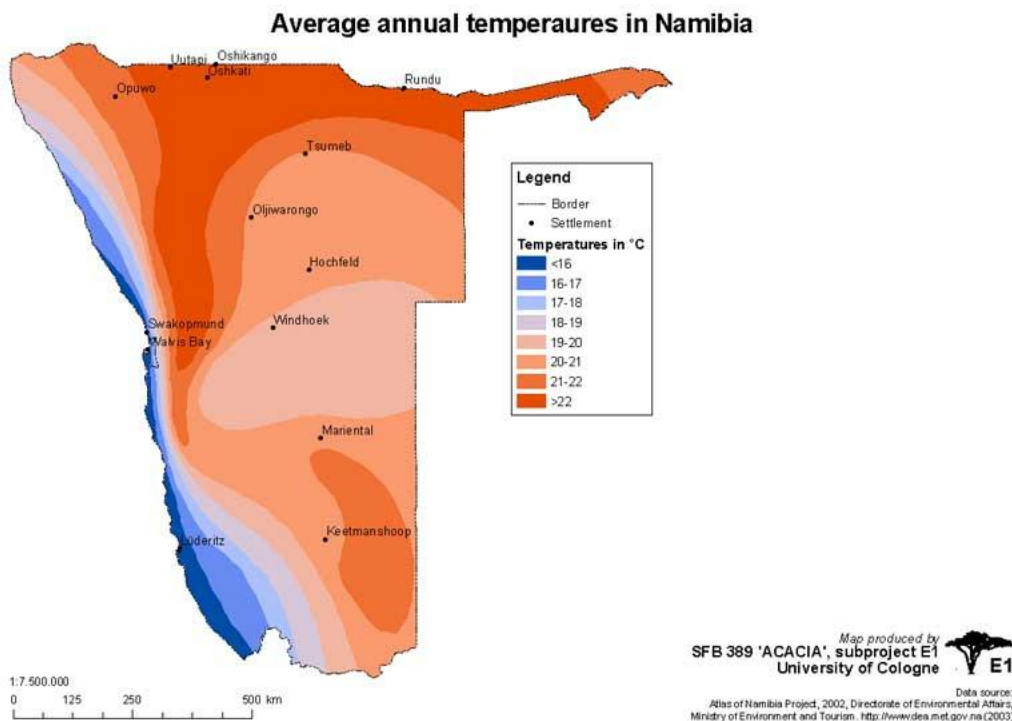


Figure 3: Annual average temperature (Acacia Project E1, n.d.)

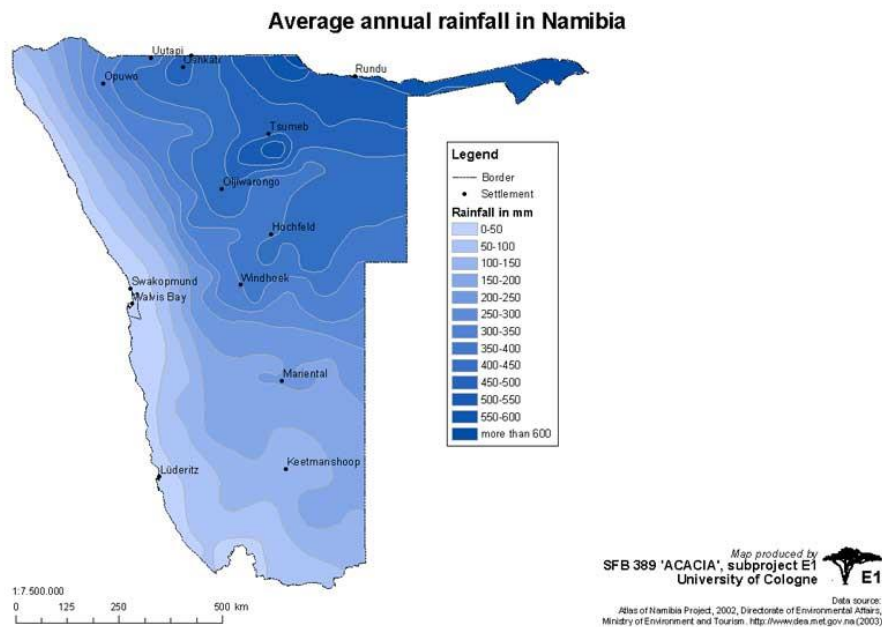


Figure 4: Average annual Rainfall (Acacia Project E1, n.d.)

The median annual rainfall varies between about 300-350mm as indicated in **Figure 4**. Rainfall is experienced mostly within the summer months, with some thunderstorms experienced during October to April.

3.2.2 Topography, Hydrology, Hydrogeology and Geology

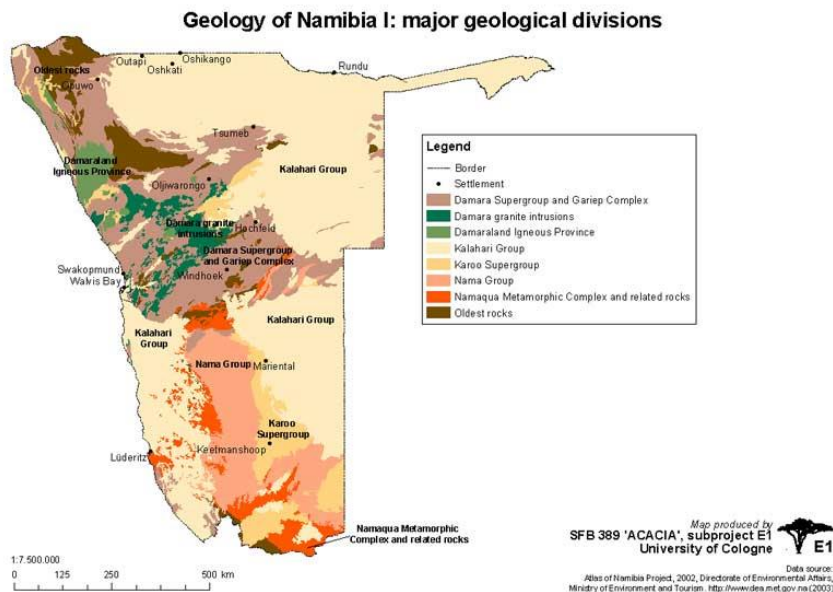


Figure 5: Geology of Namibia (Acacia Project E1, n.d.)

The subject area forms part of the Damara Supergroup and Gariep Complex geological division as depicted in **Figure 5**. This area is characterised by sandstone rock type (Mendelsohn, Jarvis, Roberts, *et al.*, 2002).

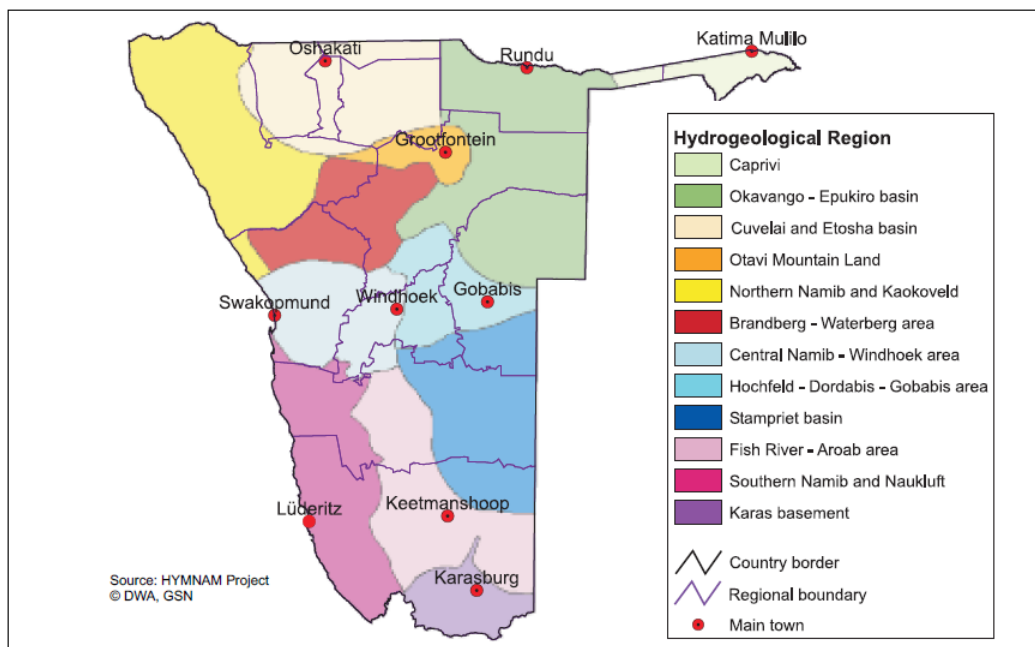


Figure 6: Groundwater basins and hydrogeological regions in Namibia (Ministry of Agriculture Water and Rural Development, 2011)

The Ondekaremba area falls within the Central Namib-Windhoek region as shown in **Figure 6**. The boreholes at both alluvial and fractured aquifers occur in the area east of Windhoek. Alluvial aquifers are found along the riverbeds of the Seeis River. The Seeis wellfield supplements the Ondekaremba water scheme (74) established to supply the international airport. Ondekaremba are on a fractured marble and quartzite aquifer of the Auas Formation (Khomas Subgroup) recharged by the Seeis River (Ministry of Agriculture Water and Rural Development, 2011). The Seeis River runs through the southern part of the portion in a southerly direction.

3.3 Terrestrial Ecology

3.3.1 Flora and Fauna

The subject area falls within the Acacia Tree and shrub Savanna biome. It is characterised by Highland Shrubland which is dominated by shrubs and low trees. The vegetation structure of the area is dense shrubland.

The area has medium terrestrial diversity in terms of animal and plant life. Plant diversity is recorded to be between 300-399 species. The area has high plant endemism with between 26-35 endemic species believed to be found within the area.

In terms of animals the bird diversity is recorded to be between 171-200 species, mammal diversity between 61 -75 species and reptile diversity between 61- 70 species.

The subject site is currently undeveloped and generally undisturbed. Some tracks have been made to allow access to the portion.

4 PROJECT DESCRIPTION

4.1 PROJECT COMPONENTS

As previously outlined in Section 1.1, the proposed project involves the following activities:

- **Subdivision of Portion 5 (Ondekaremba Kleinsiedlung) of Farm Ondekaremba No.78 into Portions A to J and Remainder;**
- **Registration of a 20 meter Right of Way Servitude over Farm Neudam No 63 in favour of Portion 5 of Farm Ondekaremba No 78;**
- **Registration of a 20 meter Right of Way Servitude over the Remainder of Portion 5 of Farm Ondekaremba No 78 in favour of proposed Portions A to J.**

4.2 ALTERNATIVES

4.2.1 No – Go Alternative

The no-go alternative is the baseline against which all alternatives are assessed. The no-go alternative would essentially entail maintaining the current situation, whereby the existing portion will remain undeveloped. Thus, none of the positive or negative impacts associated with the intended development would realize.

4.3 THE PROPOSED DEVELOPMENT

The City of Windhoek in the recent years expanded its Townlands Boundary to encompass areas that are governed by the Aris Town Planning Scheme as well as the Kapps Farm Town Planning Scheme. This expansion was done for the City of Windhoek to acquire more land to cater for its growth as the city was running out of developable land within its former boundary.

A number of developments have thus emerged along the B6 Trunk Road leading to the Hosea Kutako International Airport. These include accommodation and hospitality facilities, businesses, and industrial establishments (such as Sungate) and a few residential estates. This route is progressively becoming a prominent activity corridor that is characterised by diverse land activities.

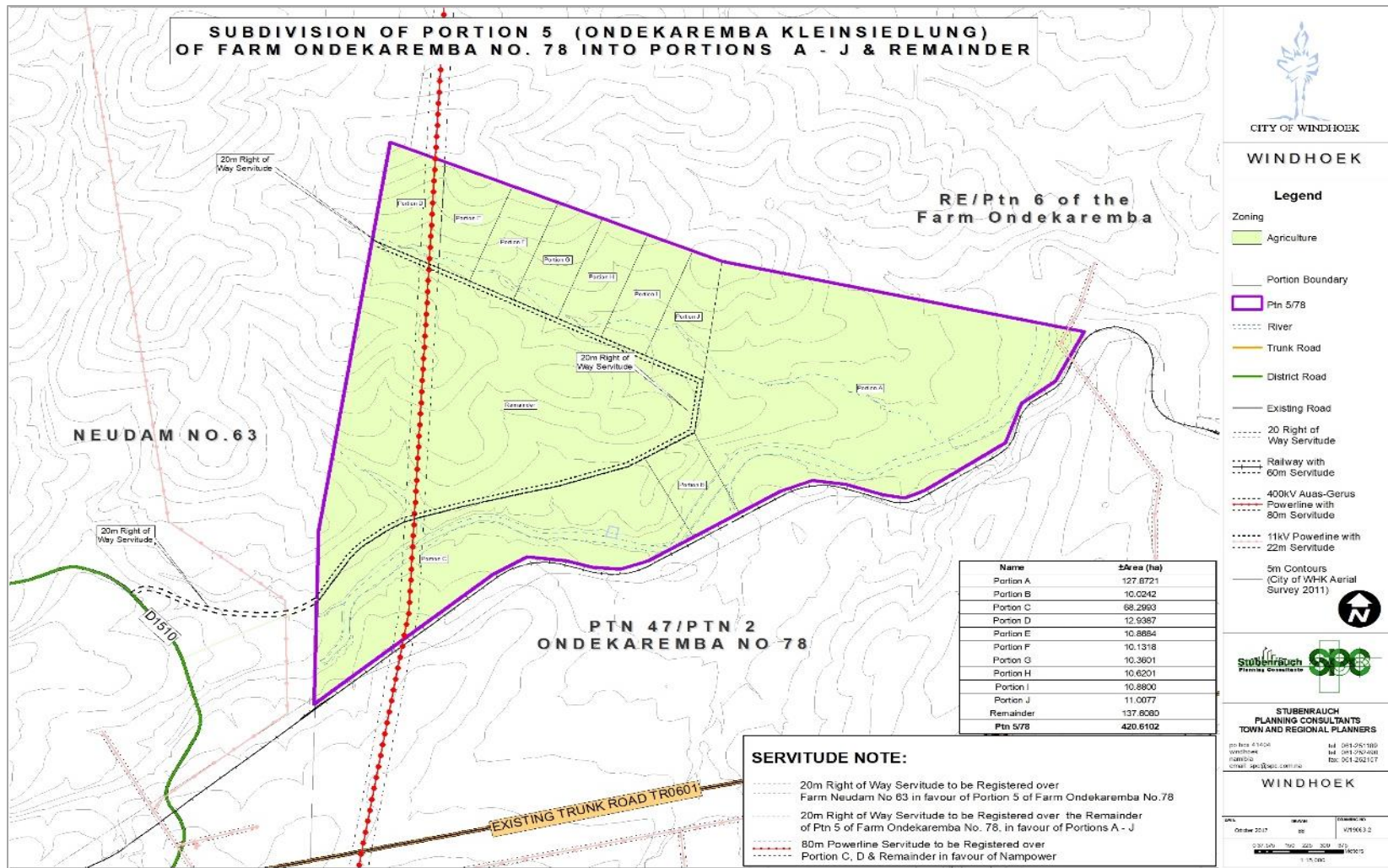


Figure 7: Subdivision of Portion 5 of Farm Ondekaremba No 78

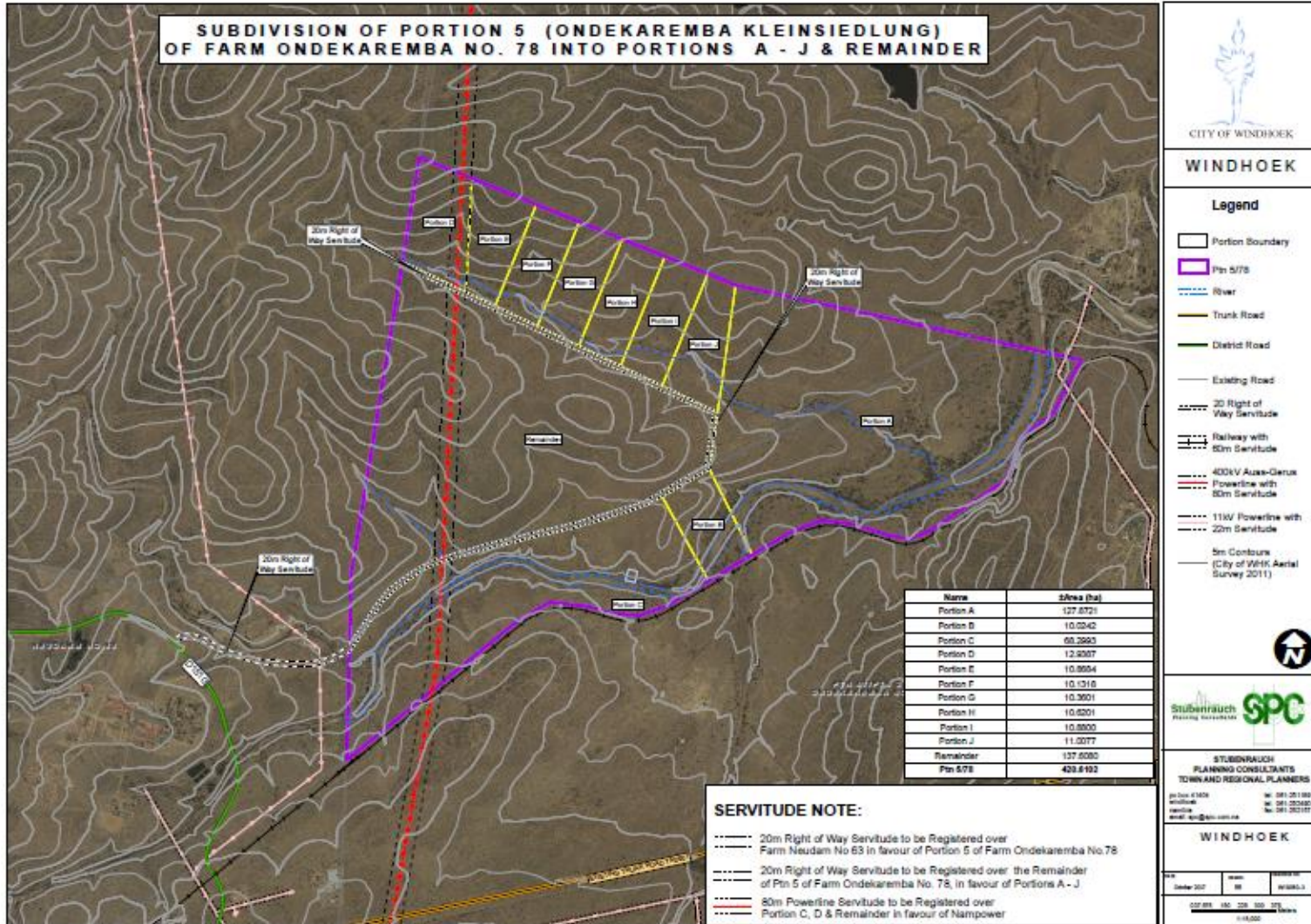


Figure 8: Aerial Map of the Subdivision of Portion 5 of Farm Ondekaremba No 78

Portion 5 of Farm Ondekaremba No.78 is currently vacant and unutilised. The size of the subject portion is not big enough to allow for large scale agricultural activities. It is therefore the proponent's intension to subdivide Portion 5 into 10 portions and the Remainder (**Figure 7 and 8**). The proposed subdivision will enable the owner to sell the proposed portions to prospective buyers who will, in line with the Kapps Farm Town Planning Scheme, have the primary right to use the portions for agricultural purposes and dwelling units.

It should be noted that the Kapps Farm Town Planning Scheme does not have any restrictions on the minimum portion size of “Agriculture” zoned land. However, the Scheme stipulates a gross density of 1 unit per 10 hectares applicable to agricultural land used for the purposes of dwelling units. In line with the Kapps Farm Town Planning Scheme, the minimum portion size of the proposed portions is 10 hectare (see **Table 5** below).

Farms along the B6 Trunk Road leading to the Hosea Kutako International Airport are known for their potential to carry out small scale subsistence livestock to crop farming. The proposed subdivision will create portions that are viable for the mentioned agricultural activities, while at the same time creating the option of a calm "out of the city" living environment for the prospective buyers.

It should be noted that the current EA encompasses the proposed subdivisions and creation of streets (right of ways) only. Should further development proposed to take place on the portions trigger a listed activity in terms of the EMA and its EIA regulations a separate EIA would have to be undertaken for that activity.

4.4 ENGINEERING SERVICES AND ACCESS PROVISION

4.4.1 Water

Proposed Portions A-J and the Remainder will make use of existing boreholes within the subject area as a source of water provision (as available). Should additional boreholes be required, the relevant procedures and permits as per the Water Resources Management Act are to be obtained as required.

4.4.2 Power supply

Proposed Portions A-J and the Remainder will make use of solar energy for power supply.

4.4.3 Sewage

The proposed portions are to be individually connected to a French Drain sewer system.

The proponent is to appoint an engineer who will be responsible for service installations for the proposed development.

4.4.4 Access

The following servitudes are to be registered to allow access to the proposed development:

- **Registration of a 20 meter Right of Way Servitude over Farm Neudam No 63 in favour of Portion 5 of Farm Ondekaremba No 78;**
- **Registration of a 20 meter Right of Way Servitude over the Remainder of Portion 5 of Farm Ondekaremba No 78 in favour of proposed Portions A to J.**

5 PUBLIC PARTICIPATION PROCESS

5.1 PUBLIC PARTICIPATION REQUIREMENTS

In terms of Section 21 of the EIA Regulations a call for open consultation with all I&APs at defined stages of the EIA process is required. This entails participatory consultation with members of the public by providing an opportunity to comment on the proposed project. Public Participation has thus incorporated the requirements of Namibia's legislation, but also takes account of international guidelines, including Southern African Development Community (SADC) guidelines and the Namibian EIA Regulations. Public participation in this project has been undertaken to meet the specific requirements in accordance with the international best practice. Please see **Table 6** below for the activities undertaken as part of the public participation process. The I&APs were given time to comment from **15 July 2021 to 5 August 2021**.

5.1.1 Environmental Assessment Phase 2

The second phase of the PPP involved the lodging of the Draft Environmental Scoping Report (DESR) to all registered I&APs for comment. Registered and potential I&APs were informed of the availability of the DESR for public comment *via* a letter/email dated **30 August 2021**. An Executive Summary of the DESR was included in the letters to the registered I&APs. I&APs had until **30 September 2021** to submit comments or raise any issues or concerns they may have with regard to the proposed project.

6 ASSESSMENT METHODOLOGY

The purpose of this chapter is to describe the assessment methodology utilized in determining the significance of the construction and operational impacts of the proposed project, and where applicable the possible alternatives, on the biophysical and socio-economic environment.

Assessment of predicted significance of impacts for a proposed development is by its nature, inherently uncertain – environmental assessment is thus an imprecise science. To deal with such uncertainty in a comparable manner, a standardised and internationally recognised methodology has been developed. Such accepted methodology is applied in this study to assess the significance of the potential environmental impacts of the proposed development, outlined as follows in **Table 7**.

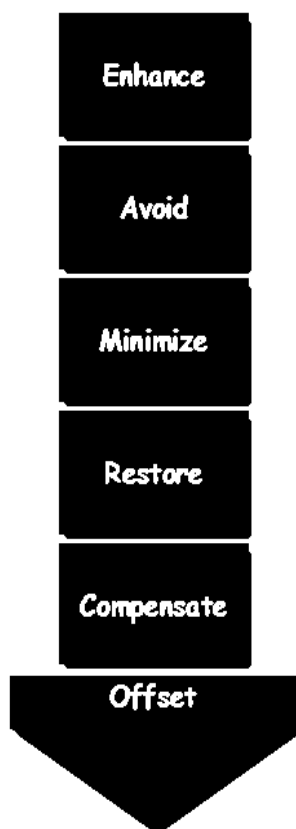

For each impact, the EXTENT (spatial scale), MAGNITUDE (size or degree scale) and DURATION (time scale) are described. These criteria are used to ascertain the SIGNIFICANCE of the impact, firstly in the case of no mitigation and then with the most effective mitigation measure(s) in place. The decision as to which combination of alternatives and mitigation measures to apply lies with the proponent, and their acceptance and approval ultimately with the relevant environmental authority.

The SIGNIFICANCE of an impact is derived by taking into account the temporal and spatial scales and magnitude. Such significance is also informed by the context of the impact, i.e. the character and identity of the receptor of the impact.

6.1 MITIGATION MEASURES



There is a mitigation hierarchy of actions which can be undertaken to respond to any proposed project or activity (See **Figure 9** below). These cover avoidance, minimization, restoration and compensation. It is possible and considered sought after to enhance the environment by ensuring that positive gains are included in the proposed activity or project. If negative impacts occur, then the hierarchy indicates the following steps.

Impact avoidance: This step is most effective when applied at an early stage of project planning. It can be achieved by:

- not undertaking certain projects or elements that could result in adverse impacts;
- avoiding areas that are environmentally sensitive; and
- putting in place preventative measures to stop adverse impacts from occurring.

Impact minimization: This step is usually taken during impact identification and prediction to limit or reduce the degree, extent, magnitude, or duration of adverse impacts. It can be achieved by:

- scaling down or relocating the proposal;
- redesigning elements of the project; and
- taking supplementary measures to manage the impacts.

Restoration: This step is taken to improve degraded or removed ecosystems following exposure to impacts that cannot be completely avoided or minimised. Restoration tries to return an area to the

original ecosystem that occurred before impacts. Restoration is frequently needed towards the end of a project's life-cycle but may be possible in some areas during operation.

Impact compensation: This step is usually applied to remedy unavoidable residual adverse impacts. It can be achieved by:

- rehabilitation of the affected site or environment, for example, by habitat enhancement;
- restoration of the affected site or environment to its previous state or better; and
- replacement of the same resource values at another location (off-set), for example, by wetland engineering to provide an equivalent area to that lost to drainage or infill.

7 ASSESSMENT OF POTENTIAL IMPACTS AND POSSIBLE MITIGATION MEASURES

7.1 INTRODUCTION

This Chapter describes the potential impacts on the biophysical and socio-economic environments, which may occur due to the proposed activities described in Chapter 4. These include potential impacts, which may arise during the operation of the proposed development (i.e. long-term impacts) as well as the potential construction related impacts (i.e. short to medium term). The assessment of potential impacts will help to inform and confirm the selection of the preferred layouts to be submitted to MEFT: DEAF for consideration. In turn, MEFT: DEAF's decision on the environmental acceptability of the proposed project and the setting of conditions of authorisation (should the project be authorised) will be informed by this chapter, amongst other information, contained in this EA Report.

The baseline and potential impacts that could result from the proposed development are described and assessed with potential mitigation measures recommended. Finally, comment is provided on the potential cumulative impacts which could result should this development, and others like it in the area, be approved.

7.1 PLANNING AND DESIGN PHASE IMPACTS

During the planning and design phase consideration should be given on aspects such as biodiversity.

7.1.1 Flora and Fauna (Biodiversity)

The subject site is mostly undeveloped and located within the urban surrounds of the city of Windhoek. As such the site may accommodate significant flora or fauna on site. The trees located on the subject site should be accommodated in the proposed tracks to be developed for access to the newly created portions. Trees protected under the Forestry Act 12 of 2001 should be protected within the development and may not be removed without a permit from the local Department of Forestry.

7.2 CONSTRUCTION PHASE IMPACTS ON THE BIOPHYSICAL ENVIRONMENT

The construction phase impacts are those impacts on the biophysical and socio-economic environment that would occur during the construction phase. These impacts are inherently temporary in duration but may have longer lasting effects.

7.2.1 Flora and Fauna Impacts (Biodiversity)

Trees protected under the Forestry Act 12 of 2001 should be protected especially during site clearance for the proposed development. The trees located on the subject site should be accommodated in the layout and proposed use for the erf as far as possible. Trees to be protected should be marked with danger tape or paint to ensure that they are not removed during the construction activities. It is anticipated that the proposed development would have localised negative implications on the environment and associated fauna and flora should the proposed mitigation measures as outlined in the EMP be enforced.

7.2.2 Surface and Ground Water Impacts

Surface and groundwater impacts may be encountered during the construction phase, especially if development takes place within the rainy season. The risk of contaminating such water sources can be increased by accidental spillage of oils and fuels and any other equipment used during construction of the access roads. This risk is minimised by the fact that the construction phase will be a short-term activity.

7.2.3 Soil Erosion Impacts

Given the characteristics of the proposed site, soil erosion is likely to be encountered especially if construction will take place during the rainy season, the removal of vegetation will render the soil vulnerable to erosion as they also serve the purpose of keeping the soils compacted.

7.3 CONSTRUCTION PHASE IMPACTS ON THE SOCIO-ECONOMIC ENVIRONMENT

7.3.1 Heritage impacts

No archaeological and heritage resources are expected to be found on the site. The project management should however be made aware of the provisions of the National Heritage Act regarding the prompt reporting of archaeological finds. Section 3.1.2 provides an overview of the archaeological and heritage context of the town and region.

7.3.2 Health, Safety and Security Impacts

Working conditions on site need to ensure that the health and safety of construction workers are ensured at all times. The use of local labour during construction is strongly encouraged so as to reduce the need for migrant workforce. Health and Safety requirements need to comply with the Labour Act No. 11 of 2007, local and international health and safety legislation and standards during construction.

7.3.3 Traffic Impacts

Traffic is expected to increase slightly during the construction phase of the project in areas where construction will take place. A number of trucks and other heavy machinery will be required to deliver, handle and position construction materials as well as to remove spoil material. Not only will the increase in traffic result in associated noise impacts, but it will also impact on the roads in the area. It will additionally create dust as most of the roads in the area are gravel roads.

7.3.4 Noise Impacts

Construction may result in associated noise impacts. These noise impacts will mainly be associated with construction machinery and construction vehicles. The impact is however limited mainly to the construction period only.

7.3.5 Dust and Emission Impacts

Excavation and stockpiles during the construction phase could result in dust impacts, if not managed correctly. Dust could impact negatively on the health of the nearby community if mitigation measures are not implemented. Dust impacts are primarily associated with the construction phase.

7.3.6 Municipal Services

The construction phase will result in additional people on-site, who will require provision of the following services:

- Potable water for domestic (ablution and drinking) and construction purposes.
- Temporary toilets during the construction phase.
- Solid waste management (domestic and construction waste).

These services should be managed in accordance with the EMP to reduce avoid water wastage; litter; solid and human waste pollution at the site.

7.3.7 Storage and Utilisation of Hazardous Substances

Hazardous substances are regarded by the Hazardous Substance Ordinance (No. 14 of 1974) as those substances which may cause injury or ill-health to or death of human beings by reason of their toxic, corrosive, irritant, strongly sensitizing or flammable nature or the generation of pressure thereby in certain circumstances. During the construction period, the use and storage of these types of

hazardous substances, such as shutter oil, curing compounds, types of solvents, primers and adhesives and diesel, on-site could have negative impacts on the surrounding environment if these substances spill and enter the environment.

7.4 OPERATIONAL PHASE IMPACTS

The operational phase impacts are those impacts on the biophysical and socio-economic environment that would occur during the operational phase of the proposed project and are inherently long-term in duration.

7.4.1 Impacts on the surrounding area

The proposed development is not expected to have a negative impact on the nature and character of the surrounding area as the development will retain its current zoning which is Agriculture. The land uses for the proposed portion is additionally in line with the surrounding land uses.

7.4.2 Traffic Impacts

Traffic is expected to increase slightly as the area becomes developed. Traffic is however not expected to increase significantly as the subject portions will retain the existing land use.

7.4.3 Dust Impacts

Tracks to be created to allow access to the newly created portions will most likely be gravel, as such dust is expected to be generated when vehicles are travelling on the roads. Dust levels are however not expected to be significant due to the land uses for the portions.

7.5 CUMULATIVE IMPACTS

The cumulative impacts of the proposed developments in regard to the degradation of the project area is very difficult to rate. If all proposed mitigation measures are however in place to minimise the overall impacts, then the cumulative impact can be expected to be rated as **Medium-Low (negative)** for the proposed developments.

7.1 ENVIRONMENTAL MANAGEMENT PLAN

An Environmental Management Plan (EMP) is contained in **Annexure E** of this report. The purpose of the EMP is to outline the type and range of mitigation measures that should be implemented during

the construction and decommissioning phases of the project to ensure that negative impacts associated with the development are avoided or mitigated.

7.2 SUMMARY OF POTENTIAL IMPACTS

A summary of all the potential impacts from the proposed project assessed above is included in **Table 8**. The **Tables 9 to 11** provide a summary of the mitigation measures proposed for the impacts. While some difference in magnitude of the potential impacts would result from the proposed alternatives this difference was not considered to be significant for any of the potential impacts. As such, the table below applies to all proposed alternatives.

8 CONCLUSION

The purpose of this Chapter is to briefly summarise and conclude the FESR and describe the way forward.

8.1 CONSTRUCTION PHASE IMPACTS

With reference to **Table 8**, none of the negative construction phase impacts were deemed to have a high significant impact on the environment. The construction impacts were assessed to a **Medium to Low (negative)** significance, without mitigation measures. With the implementation of the recommended mitigation measures in Chapter 7 as well as in the EMP, the significance of the construction phase impacts is likely to be reduced to a **Low (negative)**.

8.2 OPERATIONAL PHASE

With reference to **Table 8**, none of the negative operational phase impacts were deemed to have a high significance impact on the environment. The operational impacts were assessed to a **Medium (negative)** significance, without mitigation measures. With the implementation of the recommended mitigation measures in Chapter 7 as well as in the EMP, the significance of the construction phase impacts is likely to be reduced to a **Low (negative)**.

8.3 LEVEL OF CONFIDENCE IN ASSESSMENT

With reference to the information available at the project planning cycle, the confidence in the environmental assessment undertaken is regarded as being acceptable for the decision-making, specifically in terms of the environmental impacts and risks. The Environmental Assessment Practitioner believes that the information contained within this FESR is adequate to allow MEFT: DEA to be able to determine the environmental acceptability of the proposed project.

It is acknowledged that the project details will evolve during the detailed design and construction phases. However, these are unlikely to change the overall environmental acceptability of the proposed project and any significant deviation from what was assessed in this FESR should be subject to further assessment. If this was to occur, an amendment to the Environmental Authorisation may be required in which case the prescribed process would be followed.

8.4 MITIGATION MEASURES

With the implementation of the recommended mitigation measures in Chapter 7 as well as in the EMP, the significance of the construction and operational phase impacts is likely to be reduced to a **Medium - Low (negative)**. **It is further extremely important to include an Environmental Control**

Officer (ECO) on site during the construction phase of the proposed project to ensure that all the mitigation measures discussed in this report and the EMP are enforced.

It is noted that where appropriate, these mitigation measures and any others identified by MEFT: DEA could be enforced as Conditions of Approval in the Environmental Authorisation, should MEFT: DEA issue a positive Environmental Authorisation.

8.5 OPINION WITH RESPECT TO THE ENVIRONMENTAL AUTHORISATION

Regulation 15(j) of the EMA, requires *that the EAP include an opinion as to whether the listed activity must be authorised and if the opinion is that it must be authorised, any condition that must be made in respect of that authorisation.*

It is recommended that this project be authorised because should the development not proceed the portion will remain mostly undeveloped and the proposed portions would not have access. None of the positive or negative impacts from the proposed development would be realized.

The “no go” alternative was thus deemed to have a **High (negative)** impact, as all the benefits resulting from the development would not be realised. The significance of negative impacts can be reduced with effective and appropriate mitigation provided in this report and the EMP. If authorised, the implementation of the EMP should be included as a condition of approval.

8.6 WAY FORWARD

The FESR is herewith submitted to MEFT: DEA for consideration and decision making. If MEFT: DEA approves, or requests additional information / studies all registered I&APs and stakeholders will be kept informed of progress throughout the assessment process.
