

In this regard it is relevant to refer to the efforts to assure accountable and transparent administration by the Second Land Conference of Namibia of 2018. During this conference it was resolved and in fact directed that the MAWLR should conduct an audit of the land acquisition and allotment activities.

In view of the above, the Ministry of Agriculture, Water and Land Reform would herewith like to invite those members of the public who have solid proof or evidence of officials, possible beneficiaries and/or other parties conniving with one another to commit or engage in the mentioned atrocities of corruption, fraud or other irregular conduct with the aim to corruptly or inappropriately benefit the officials, beneficiaries and/or other parties to report the same.

Any such information must be in writing, contain the contact details of, and be signed by, the depositor and be handed in in a sealed envelope at the office of the Minister, 4th Floor, Ministry of Agriculture, Water and Land Reform, Government Office Park (new Agriculture Building), Windhoek. Upon receipt of any such written communique the depositor would be furnished a written acknowledgement.

Project Background and Description: The proposed project, i.e. upgrade of the railway line between Kranzberg Station and Otjiwarongo Station (Phase 1), has become necessary and desirability to improve the railway transport network as part of the larger railway network between Walvis Bay and Tsumeb and Otavi to Katima Mulilo. The upgraded railway line will provide for a 100km/h transport compared to the 80km/h of the current railway line.

The decision to upgrade a complete new railway line between Kranzberg Station to Tsumeb and Otavi to Grootfontein, of which Phase A includes the section from Kranzberg Station to Otjiwarongo, is based on the safety risk that the current railway line holds and yearly costs to maintain the old railway infrastructure. The safety risk and high maintenance costs of the railway line are directly related to the unstable state of the railway embankment and poor condition of the railway tracks, which has reached its lifespan.

The Phase 1 of the proposed project entails the upgrade of the railway line in between Kranzberg Station and Otjiwarongo following the existing railway line for the majority of the length, with some deviations, leaving the railway servitude onto adjacent farms. This includes the construction of a new embankment, bridges and railway sidings. Farm owners affected by the deviations (i.e. loss of land) will be contacted to obtain consent and discuss compensation. Aggregate, gravel, soil and water will be sourced from adjacent farms after consent has been obtained from the affected farm owners. The existing railway line will become redundant, but continue to be used as the service road required for operational maintenance.


