1. I refer to my office letter dated 2023-10-03, regarding the site visit and inspection of the envisaged area earmarked for explosives storage at Farm 38, Walvis Bay in Erongo Region on Tuesday, 10 October 2023.
2. Kindly take note that on above mentioned date at about 08:30, Deputy Commissioner Nghiyoonanye accompanied by members of the Namibian Police Force from the Office of the Inspector-General, office of the President, members from the Namibian Defence Force, office of the Regional Commander, Namibian Airport Company, Municipality of Walvis Bay, Explosives Control Sub-Division in the Region, Mr. Sakwa Nyambe, Executive Director of Vibrant Upstream Services (Pty) Ltd and his team, and Mr. Colin P. Namene from the Environmental Assessment Company, conducted a site meeting and inspection at Farm 38, Walvis Bay District in Erongo Region.
3. During the site meeting the inspection team was pre-satisfied with the selected site, however the company was advised to look into the proposed quantities to be stored therein in order to determine the final distances. The following safety distances were observed;
  - 3.1. From the proposed storage facility to the shooting range approximately 3.1 kilometers
  - 3.2. From the proposed storage facility to the national road approximately 2 kilometers
  - 3.3. From the proposed storage facility to the nearest water pipeline approximately 0.5 kilometers
  - 3.4. From the proposed storage facility to nearest electrical pole approximately 0.3 kilometers
  - 3.5. From the proposed storage facility to nearest buildings Erongo Quarry Magazines and Native Storage Facility approximately 2.6 and 1.5 kilometers respectively.
4. Additionally, during the meeting and inspection the company was advised to;

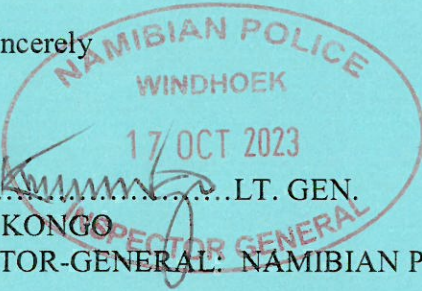
