APPLICATION FOR ENVIRONMENTAL CLEARANCE CERTIFICATE (ECC) BY KAI//KHAUN TRADITIONAL (KTA), HOACHANAS, HARDAP REGION

1. The above mentioned matter bears special reference.
2. Road Fund Administration (RFA), is releasing a certain amount on an annual basis to Hardap Regional Council (HRC) for maintenance of existing road infrastructure in Hoachanas Settlement.
3. Thus, the Council has put out a tender last year November for an interlocked paved road from the KTA to the T-Junction next to the Business Park.
4. The awarding and site handover was planned for February 2024, but due to the non-availability of the ECC for the borrow pit, the latter was not done.
5. There is an existing borrow pit which is situated approximately 800 meters from the Settlement Office on the eastern side of the Settlement.
6. Pursuant to the above mentioned, HRC is pleading with your office to treat this matter with the utmost urgency and grant the approval of the Environmental Clearance certificate to the Kai//khaun Traditional Authority at your earliest convenience as the money allocated for the interlocked paved road is from the previous financial year and the Council is afraid that these funds might be cancelled by the Road Fund Administration.

7. The interlocked paved road will be the first of kind in this Settlement and we believe that this will pave for more to come for further development.
8. Therefore, we trust and rely on your favorable consideration of this request at your earliest convenience.


