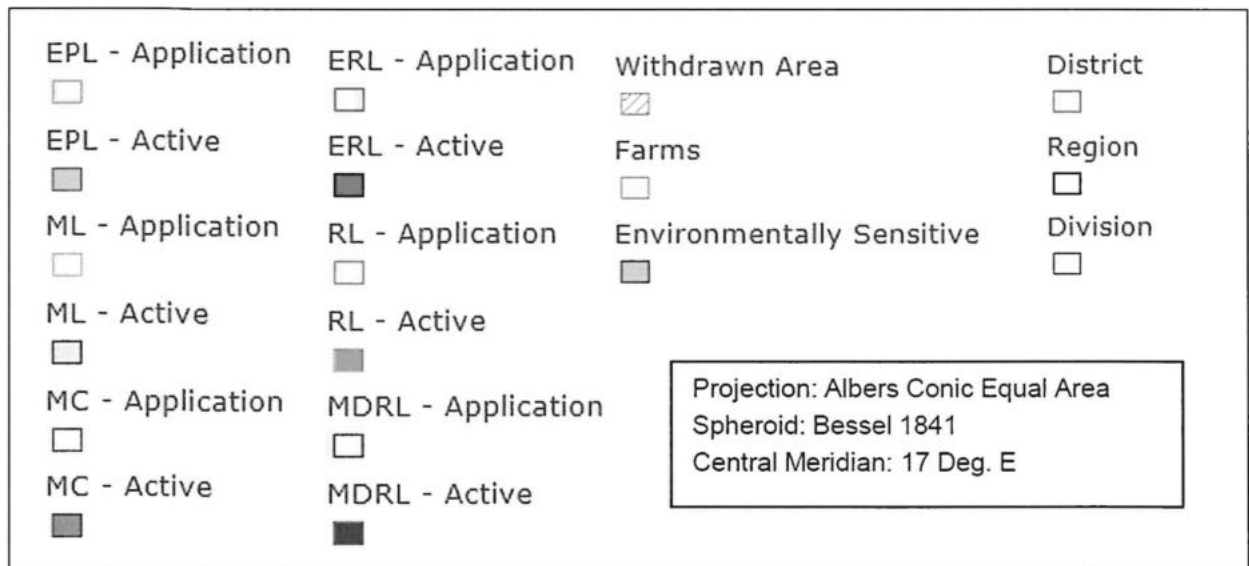


**DIAGRAM – EXCLUSIVE PROSPECTING LICENCE – 7675**
