

Communication with I&APs, and Means of Consultation Employed

Regulation 21 of the EIA Regulations details the steps to be taken during a public consultation process and these have been used in guiding this process. Communication with I&APs with regards to the proposed development was facilitated through the following means and in this order:

- A Background Information Document (BID) containing brief information about the proposed project was compiled and hand delivered to the Ministry of Environment, Forestry and Tourism (MEFT) accompanying the ECC application, and uploaded on the MEFT (ECC) Portal for project registration and shared with registered Interested and Affected parties (I&APs).
- A Stakeholders' (I&AP) List was developed and updated as new I&APs register for the ESA.
- Project Environmental Assessment notices were published in The Namibia Media Holdings' *Market Watch* newspapers (*Allgemeine Zeitung, Die Republikein, and Namibian Sun*) dated 28 November 2022 and 05 December 2022 – attached hereto.
- Due to the fact that the EPL is located within the Gaingu Conservancy, a consultation meeting was held with the Gaingu Conservancy management on the 23rd of March 2023 in Tubusis (see photos below). Another consultation meeting was held in Windhoek with the respective Head of the Traditional Authority for the area (Chief Gaseb) on the 01st of August 2023. The consultation meeting minutes for the two meetings were taken and attached hereto.

Feedback and Issues raised by the Stakeholders (I&APs)

Issues were raised by I&APs (from the consultation meetings) and these issues have been recorded and incorporated in the ESA Report and EMP. The summary these few key issues are presented in the Table below.

Summary of main issues and comments received throughout the consultation period

Aspect	Summary
Corporate Social Responsibility (CSR)	The Proponent to implement CSR
Promotion of transparency in communication and continued engagement	Promote and maintain transparency before and during exploration by continuously engaging the Traditional Authority and Conservancy.
Employment of locals and surrounding communities	Employment of locals should be prioritized for jobs that can be done by them. These include general and casual jobs, where applicable.
Utilization of available local goods and services	Consider the use of local procurement of services and goods for the project activities to empower local businesses, where possible and applicable.
Ecological of the EPL area	The EPL is within a conservancy and thus wildlife needs to be protected while carrying out the activities.
Existence of mining claims	The need for EPL holders to co-exist with mining claim owners

The consultation period ran from the 28th of November 2022 to the 30th of December 2022 and then extended to end of March 2023 (pending consultation meetings. However, no comments were submitted to the Consultant. Given the remoteness of the EPL area, consultation meetings were held with the key stakeholders in Tubusis and Windhoek, whereby comments were made (as provided in the Table above).

Fitch maintains South Africa's ratings

South Africa has a favourable government debt structure, which is mostly in rand and with long maturities.

The US credit rating agency Fitch maintained its view on South Africa, while S&P boosted its outlook on Eskom from "negative" to "stable". This is thanks to an expected transfer of some of Eskom's debt to government.

Fitch said South Africa's finances are constrained by high and still rising government debt, weak growth and high inequality. But it also has a "favourable" government debt structure, which is mostly in rand (not foreign currencies) and with long maturities. In addition, the country has a "credible" monetary policy framework.

The agency noted "substantial recent over-performance on fiscal revenues and the government's strong efforts to control expenditure", which if successfully continued, could bring about debt stabilisation.

a substantial part of recent higher revenues to be temporary and see current public sector wage negotiations pointing to increased upward pressure on spending.”

Fitch doesn't expect load shedding will significantly improve next year and will ease only gradually in 2024.

South Africa's growth potential remains low and is a key credit weakness, Fitch said.

"There recently has been more progress on the government's reform agenda pushed by a focus on process bottlenecks under Operation Vulindlela, but full implementation

still takes a long time and reforms on the agenda are limited in ambition. There is also a risk that measures to improve transport infrastructure, a key part of the agenda, are merely offsetting an underlying deterioration, as worsening capacity issues amid rising demand have held back mining exports this year.”

Tax revenue has been surprisingly high, but Fitch expects it to fall back as profits in the mining sector nor-

malise. Fitch kept South Africa's long-term rating at 'BB-' with a "stable" outlook.

Also on Friday, US ratings agency S&P hiked its outlook on Eskom from "negative" to "stable", keeping its rating at "CCC+”.

Eskom

It noted that Eskom's operating performance is deteriorating and its costs are rising, with billions spent

on diesel for emergency power generation. Fitch says there are signs that load shedding could increase in coming months. However, government's plan to take on between one- and two-thirds of Eskom's debt would help stabilise its finances.

It warned, however, that the debt transfer plan is complex and not without risks.

In addition, the transfer won't address Eskom's other challenges, such as weak operational performance, overdue receivables from municipalities, and below-cost tariff increases. Eskom's cash flow will depend on its new tariffs for next year, which will be granted by the regulator, Nersa, next month. Eskom asked for a 33% increase in its tariffs.

"We believe a full tariff award would be unaffordable for many customers, and either lead to lower sales volumes or a rise in bad debts," S&P said.

S&P says it would lower its rating if bondholders receive less value than the original promise under the debt transfer plan.

A week ago, S&P kept South Africa's credit ratings unchanged. Its outlook remains "positive", meaning the next step could potentially be an upgrade.

Sanlam, Absa creates SA's biggest black-owned asset manager

Assets exceed R1 trillion

Sanlam and Absa have formally combined their investment businesses a year after announcing the merger.

Sanlam and Absa have officially combined their investment businesses to form South Africa's largest black-owned asset manager. The two companies announced in October 2021 that they were joining forces to create an asset management firm second only to Ninety One in terms of size.

The new company, to be born out of marrying Sanlam Investments and Absa Investments – which comprised Absa Asset Management, Absa Alter-

native Asset Management, Absa Fund Managers and Absa Multi-Management – will have assets of more than R1 trillion.

On Thursday, the two firms said they've now met all the conditions, allowing them to officially launch the new asset management venture, Sanlam Investment Holdings Proprietary Limited (SIH), on 1 December.

GIANTS

The two combined all their investment management businesses in South Africa.

Absa Investments got a stake in SIH. Absa also entered into a 10-year distribution agreement with SIH. This means that the new asset management firm will use both Sanlam and distribution networks, thus reaching significantly more clients than they



ever could individually.

They also said that doing it as a team of two financial giants will help them bring a more holistic range of investment solutions to the market.

“Sanlam and Absa clients will gain from the enhanced investment offering. This partnership will allow

us to deliver investment solutions that sustain future generations,” said Sanlam Investment Group CEO, Carl Roothman.

He believes that the scale of SIH will position the group as the preferred investment solutions provider in South Africa.

TotalEnergies has applied for environmental authorisation toward developing its gas discoveries offshore South Africa.

The move forms part of a production right application in Block 11B/12B,

which is available for public comment, according a draft scoping report published online.

Future transition

Development of the block could potentially revive state-owned PetroSA's 45 000-barrel-a-day Mossel Bay gas-

to-liquids plant, which has run out of feedstock.

South Africa also plans to use the fuel to transition away from coal that's used to generate nearly all of the nation's electricity.

The production right area that is being applied for is smaller than the explora-

tion right area that the company previously held, according to the report.

TotalEnergies is the operator of the block with 45% of the rights, Qatar Petroleum holds 25%, CNR international 20%, and the remainder is held by the South African consortium Main Street.

1. INTRODUCTION AND WELCOMING

The meeting was opened by Mr. Anthony Mr. Jantjies (the Chairperson of the #Gaingu Conservancy) who welcomed everyone and requested all the attendees to introduce themselves. After introductions, Mr. Jantjies handed over the chair to Ms. Fredrika Shagama (the Environmental Assessment Practitioner / Consultant from Serja Hydrogeo-Environmental Consultants cc) who thanked the Conservancy management committee



representatives for making time to attend the meeting. She briefly explained the meeting agenda of the meeting in accordance with the Public Consultation's Section 21 to 24 of the 2012 EIA Regulations: Environmental Management Act No. 7 of 2007.

The Environmental Consultant circulated the consultation meeting attendance for signature as proof of consultation to be appended to the ESA Report. Printed copies of the Background Information Documents (BIDs) were also distributed to the attendees for self-reading so that they could raise their concerns, and submit comments after.

2. MEETING AGENDA AND PRESENTATION

Ms. Shagama presented the agenda of the meeting which included the following main points:

2.1 Explanation of what an ESA is, its Process and the Public Role in the Process

Ms. Shagama explained the ESA process and that the proposed prospecting and exploration works is one of the listed that cannot be undertaken without an environmental clearance certificate (ECC) from the Environmental Commissioner, and that the consultation meeting is one of the requirements to the EIA study process to apply for the ECCs for the two EPLs (8521 and 7603). She also indicated that EPL-7603 was under the previous system whereby the ESA Study would be done after the EPL is granted (which is only done now). However, EPL-8521 is under the new system whereby an ESA Study needs to be done and ECC granted before EPL exploration rights can be considered for approval, i.e., before the EPL rights are granted to the Proponent.

2.2 Brief Description of the Project

A brief description of the planned project activities was presented as per the provided BIDs copy. Ms. Shagama reiterated that it is important to understand that the proposed activities and ECCs applied for are not for mining activities but prospecting and exploration only. This is also because the Proponent cannot mine on EPLs as mining can only be done once the exploration activities yield positive (economic feasible) results, of which the Proponent will need to apply for a Mining License (ML). The ML will be subject to another separate detailed EIA Study with specialists and apply for ECCs for mining activities.

2.3 Presentation of Potential Project Impacts

To ensure transparency and that the attendees understand both sides of the proposed project activities, Ms. Shagama also presented the potential pre-identified potential positive and negative environmental impacts anticipated from the proposed prospecting and exploration activities.

2.4 Public Open Discussion (Interactive Session)

Upon presentation of the ESA/EIA process, project activities, and anticipated impacts, the meeting attendees were afforded an opportunity to ask questions and/or raise concerns with regards to the proposed project activities.

The key comments and concerns raised in the meeting were noted for consideration and inclusion in the ESA Report. These recorded comments and concerns are presented in **Table 1**.

Ms. Fredrika Shagama (Ms FS): Noted. The rehabilitation of disturbed site areas after exploration will be incorporated in the EMP for implementation
5.		If the exploration results in mining, will there be a need to relocate people?	Mr. NM: This is unlikely to happen during exploration, but should it come to light towards the end of exploration (when there is enough data to know whether to continue to apply for mining licenses), then this will be communicated with the leaders and communities for further engagements to reach amicable solutions and way forward. In some cases, a landowner may choose to sell off the portion of their area, lease it off or

6.		The meeting information shared with us indicate that there would be a meeting in Grootspitskop (Spitzkoppe Settlement) with the community at 14h00. I do not think this will materialize because Settlement is far from the two communities of Farm Spitzkoppe and Ketelbank and transport will be a challenge. I think the meeting should be held at one of the two farms or at each.	(Ms FS): Noted. We will probably need to reschedule for another meeting in April to cater for the communities on the farm and Traditional Authority. However, since we are already in the area, we will proceed to the farms for our preliminary site assessment and collection of baseline environmental information.
7.	Mr. Anthony Jantjies	Will there be blasting during exploration?	Mr. NM: There will be no blasting. The activities will be phased into sample collection by geologists and using aeromagnetic surveys and then followed up with exploration trenching and drilling.

People have no income, hence diverting to small-scale mining. MME needs to consult the conservancies and traditional authorities first before approving or pre-approving applications.	Ms. FS: Noted. If the small-scale miners have registered mining claims, they do have the same rights as the EPL owners in an area. Therefore, this is a matter of educating the small-scale miners (with legally registered mining claims) about their rights to mine in an area, even if it is inside an EPL. Some (new) EPL owners may not be aware of this but they equally need to be educated about this and respect the rights of the mining claim owners.

Way forward: Ms. Shagama will reschedule the meeting with Farm Spitzkoppe and Ketelbank sometime in April so that the communities can submit and or raise their comments and concerns for inclusion.



Ms. Shagama concluded the meeting and thanked the attendees for their participation. She informed them that their comments will be incorporated into the ESA report and suggestions added to the EMP and updated with the inputs from the next community meeting (to be rescheduled) before finalizing the documents for submission to the Environmental Commissioner. The meeting was adjourned at 12h00.

- **One representative for the EPLs (7603 and 8521)**
- **Two (2) representatives from the Oe-Gan Traditional Authority as well as Ministry of Urban & Rural Development (MURD).**

1. INTRODUCTION AND WELCOMING

The meeting was opened by Ms. Fredrika Shagama (the Environmental Assessment Practitioner / Consultant from Serja Hydrogeo-Environmental Consultants cc) who thanked the attendees for their time. She briefly explained the meeting agenda of the meeting in accordance with the Public Consultation's Section 21 to 24 of the 2012 EIA Regulations: Environmental Management Act No. 7 of 2007.

Since the draft Scoping Report and Environmental Management Plan (EMP) have already been compiled following the first consultation meeting in March 2023, Ms. Shagama handed over the printed copy of the Report (merged with the EMP and other appendices) to the Office of the Chairperson of the Traditional Authorities Council. The attendance register was also circulated for all to sign as proof of the meeting.

2. MEETING AGENDA AND PRESENTATION

Ms. Shagama presented the agenda of the meeting which included the following main points:

2.1 Explanation of what an ESA is, its Process and the Public/Stakeholders' Role in the Process

Ms. Shagama explained the ESA process and that the proposed prospecting and exploration works is one of the listed that cannot be undertaken without an environmental clearance certificate (ECC) from the Environmental Commissioner, and that the consultation meeting is one of the requirements to the EIA study process to apply for the ECCs for the two EPLs (7603 and 8521). She also indicated that EPL-7603 was under the previous system whereby the ESA Study would be done after the EPL is granted (which is only done now). However, EPL-8521 is under the new system whereby an ESA Study needs to be done and ECC granted before EPL exploration rights can be considered for approval, i.e., before the EPL rights are granted to the Proponent.

2.2 Brief Description of the Project and Potential Project Impacts

Following the printed Scoping Report, a brief description of the planned project activities was presented by Ms. Shagama. She also informed the attendees that it is important to understand that the proposed activities and ECCs applied for the two EPLs are not for mining activities but prospecting and exploration only. This is also because the Proponent cannot mine on EPLs as mining can only be done once the exploration activities yield positive (economic feasible) results, of which the Proponent will need to apply for a Mining License. The ML will be subject to another separate detailed EIA Study with specialists and apply for ECCs for mining activities.

To ensure transparency and that the attendees understand both sides of the proposed project activities, Ms. Shagama also presented the potential pre-identified potential positive and negative environmental impacts anticipated from the proposed prospecting and exploration activities. She also pointed out the management and mitigation measures provided in the EMP.

2.4 Public Open Discussion (Interactive Session)

Upon presentation of the ESA/EIA process, project activities, and anticipated impacts, the meeting attendees were afforded an opportunity to ask questions and/or raise concerns with regards to the proposed project activities.

The key comments and concerns raised in the meeting were noted for consideration and inclusion in the ESA Report. These recorded comments and concerns are presented in **Table 1**.

EPLs are just aimed at prospecting and exploration, where you put money with no guarantee, therefore, considerate a risk. This is why some people say that people who invest in EPLs use money that they do not need at the time.</p> <p>To the question of whether communities can also apply for EPLs in their area, of course they can, given that they meet the set requirements. I would suggest, that a community can come up with a company that can probably use money from the funds paid by EPL holders (land use fees paid through the Traditional Authority) in the area and apply for an EPL (as a starting point).
