Wheelie bins will be made available at the site and it will be emptied on weekly basis at Opuwo landfill.

No industrial waste will be generated from the envisaged project.

Portable toilets will be erected in the vicinity of the basecamp and it will be emptied at Opuwo sewerage pond on weekly basis.

Vehicles:

Three 4X4 Toyota pick-up bakkies and one eight-ton truck will be used during the operation of the project.

Earthmoving equipment:

An 400PC excavator equipped with the exclusive highly efficient hydraulic control system will be used for excavation and loading purposes.

Drilling equipment:

A jackhammer equipped with a compressor will be used for drilling purposes.

3.2.2 Describe the environmental damage that is likely to result from the use of vehicles and machinery within the mining claim area (e.g. on the landscape in general, soil, vegetation, noise, dust, etc.).

The existing tracks will be used to access the site by vehicles and machinery, however; only plant species that will be within the targeted area will be cleared if such plant species are inevitable. A vegetation management plant will be formulated and all the protected and high valued plant species in the area will be avoided. The vehicles and earthmoving equipment will be serviced on regular basis to ensure that there is no soil contamination and if any oil leakage have been detected a drip tray will be used. All employees will be provided with the correct Personal Protect Equipment (PPE). The operation hours will be from 8h00 AM to 17H00 PM, from Monday to Friday, no work will be allowed during dusk hours.

3.2.3 How will you control the movement of vehicles and machinery in order to minimize environmental damage?

Only existing tracks will be used during the operation of the project and no new roads or tracks will be established. No off-roading will be permitted on-site and an assistant environmental officer will be appointed to ensure compliance.

3.2.4 Which routes will be used by vehicles to get to your mining claim and state whether you intend making new roads or tracks (both to your mining claim and within your mining claim)?

An existing track from the site connecting to the D3703 road which stretches from Opuwo to Orotjitombo and Omukurukaze Villages will be used to access the mining claims area.
