From: The area of interest is located about 20 km North-East of Outjo, Kunene Region, Namibia. It covers a surface area of about 63 958 hectares (ha) and overlies farms; Clark no. 330, Cunninghun no. 331, Harris no. 340, Ramsey no. 341, Ouma no. 342, Isio no.

364, Oubaas no. 343, Jannie no. 365, Koening no. 332, Gaulle no. 333, Teddar no. 334, Benjamin no. 363, Dan Pienaar no. 344, Morial, Norma no. 366, and Macarthur no. 352.

(Description of the site, location as in the application)

In accordance with: Archaeological and Heritage Impact Assessment Report for the proposed mineral on Exclusive Prospective License (EPL) 8634 for the exploration of Base and Rare metals, Industrial minerals, Dimension stone, Non-nuclear fuel minerals, Nuclear fuel minerals and Precious Metals, Erongo Region.

The following conditions (imposed in terms of section 55(9) of the Act.) apply to this permit:

- a) Farms Clark no. 330, Cunninghun no. 331, Harris no. 340, Ramsey no. 341, Ouma no. 342, Isio no. 364, Oubaas no. 343, Jannie no. 365, Koening no. 332, Gaulle no. 333, Teddar no. 334, Benjamin no. 363, Morial, and Macarthur no. 352 are to be excluded from any exploration activities until a field survey is conducted within these areas.
- A 100m buffer zone should be created and maintained around all burial sites found within the EPL.
- c) A 100 m buffer zone should be created and maintained around the old farm house found within the EPL.
- d) Monitoring and evaluation inspection will be carried out on the area during the course of the year.
- e) As per Section 55 (9) (a) the activity authorized by this consent be supervised by a person with appropriate professional qualifications or experience.
- f) The proponent should take caution approaches together with the compliance and of the Chance Find Procedure.
- g) The consent holder is to report back to the National Heritage Council every six (6) months on compliance with the conditions of this consent.

- h) This consent does not exempt the holder from any conditions that may be imposed by owners, hosts or any other relevant authorities in consultation with NHC who have a stake in the project area.
- NHC shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities related to this permit.
- j) This Consent is subject to the provisions of the National Heritage Act (Act 27 of 2004). Should any of the conditions contained herein conflict with the Act; the provisions of the Act as per section 55 (10) shall prevail.
- k) This consent is renewable, upon submission of an application at least two months before the current permit lapses.
- Failure to adhere to the conditions will attract fines or imprisonment or the retraction of the consent as per the National Heritage Act no.27 of 2004.
