

ALLOCATION OF 250 HECTORS OF LAND BY TRADITIONAL LEADERSHIP AND COMMUNITY IN KAOKO-OTAVI FOR THE DEVELOPMENT OF THE GARDEN BY THE DIRECTORATE OF THE CORRECTIONAL SERVICES

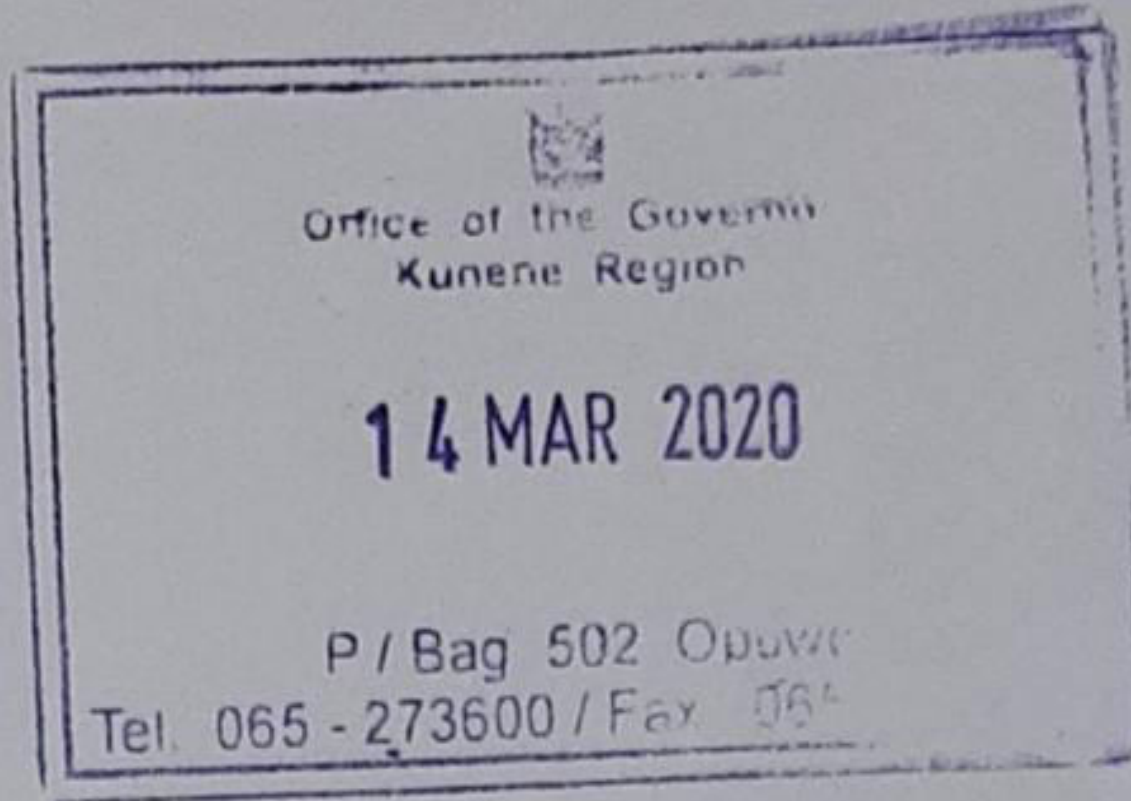
This note serves to inform your esteem office that Kaoko-Otavi Traditional leadership and community as a whole agreed for the allocation of 250 hectares of land for the development of a Garden by Directorate of Correctional Service. The allocation letter signed by the Traditional leaders which is received by our office is in the vernacular language and our office prepared this letter to indicate what is in the allocation letter. There are conditions/requests from the community which are as follows:

1. The surrounding community must be provided with water and electricity
2. There must be provision made for the community to participate in the cultivation or a portion of land to be reserved for them to do cultivation in the fence off land.
3. Community members from Kaoko-Otavi must be the first one to be offered permanent/temporary employment as per their skills.
4. The Office of the Governor must arrange a trip to Divundu for the community members of Kaoko-Otavi to learn how the community of Divundu are benefiting from the establish garden in their area. Furthermore the community requested the establishment of the garden to start as soon as possible without any delay.



Omaunguriro wotjikunino ihi arikana nga ye ute rukuru nai, aye kara nongono.


