1. Opening and Welcoming

The meeting was blessed by a community elder before official opening and welcoming.

Hon. J. Amunkete of the Tsandi Constituency opened meeting and welcomed everyone. He thanked everyone for coming and wished for a productive meeting. He also requested for full cooperation and participation. Thereafter, Hon. introduced the consulting team members and their roles.

He then gave a short background of the meeting explaining that previous consultation meetings at Regional level started already in February 2022, and that the Regional Council is fully aware of these developments.

2. Overview of the Meeting

Mr Don Muroua from Trinity Environmental Solutions (TES) explained that the meeting was going to discuss and address the proposed construction to gravel standard the current earth track road from lipanda to Tsandi via Eendombe and Elondo.

Don emphasised the need for a proactive participation during the meeting as it was the right platform to ask questions, give suggestions, provide information and recommendation, and to receive feedback from the Proponent and project consultants.

3. Project background and description, overview of Environment Impact Assessment (EIA) process and its role

The consulting team gave presentations on the projects background, the EIA processes and its role. Their presentation highlighted the following:

- Background of the project
- Project Rationale and need for the development
- EIA process and compliance with national laws, guidelines and policies
- Proposed project description and possible impacts
- Project technical details

Mr D. Kaihiva (EMCON) further informed the meeting participants that road construction comes in different stages; from planning, public meetings, designs, looking for materials, construction, etc. It was also emphasized that the existing road alignment will be kept as much as possible. Also that, it was unlikely that people will be required to move. It was also noted that compensation sometimes takes long and that all efforts will be made for



an efficient compensation process. EMCON also informed the meeting that they will start with surveying work to record all structures and infrastructure and to identify who needs compensation. Emphasis were made on issues related to compensations and borrow pits, that in communal area, compensation is only for loss of property and not for materials mined.

Mr D. Kaihiva also requested for support and cooperation when community members are interacting with the surveyor teams who will be soon in the area for marking of the road's route, sitting of borrow pits and recording various infrastructure such as crop fields, camps, homesteads, houses, buildings, roads, electric power lines, water pipelines, water pans, etc..

Mr H. Simasiku (Roads Authority) informed the meeting that the construction of the road will take at least 20 months, and that this road is already proclaimed since the late 1990's. The Contractor to be appointed will determine where they want the construction to start, either lipanda or Eendombe or Tsandi. He further informed the meeting that, should everything go according to plan, construction will start January 2023. He also informed the meeting that the funding for this road construction is co-financed by the German Federal Government through the KfW Bank and the Government of the Republic of Namibia.

He also explained that employment will de done at once and not in phases. He also explained that, when the contractor is appointed hopefully by the end of this year, he will then approach the Hon Councilor and the Traditional Authority for list of names for people to be considered for employment.

Mr H. Simasiku further explained that the appointment of SME's as sub-contractors will be done at the same time as the appointment of the main Contractor. Hence SME's are expected to team-up/joint-venture with main Contractors so that they submit their offers with the main Contractor. Also that separate Tender Documents are available for SME's/sub-contractors to be completed.

After a long and detailed presentation, an opportunity was given for comments, recommendations, suggestions and clarification questions. Comments, questions and responses are presented in the table below.
