The old pipe and refuse should be removed there are a lot of old pipes that were left years ago. 4. Existing tracks and roads should only be used. 5. Areas damaged to be rehabilitated. 6. Special care should be taken to protect the Lichenfields.

3. Questions/Suggestions: 1. Animal crossings every 5km. 2. Vehicle crossings that are closed that could be opened should the need arise. 3. All refuse and old pipes to be removed, old pipeline being replaced and the old broken pipes that were dumped. 4. Staff that build should have name tags, uniform and vehicles should be branded. 5. Should submit all documents EIA, EMP and Environmental clearance to our office at MEFT Swakopmund. 6. The proposed area to be inspected to see proposed development and then inspect regular intervals and after the work is done and area is rehabilitated. 7. NAMWATER to give environmental induction training to their staff and that of the sub-contractors. 8. Entry permit should be applied for entry into Dorob National Park and names to be submitted and registration details of the vehicles. 9. The Entry permit copy to be in the possession of staff at all times and to present to Meft staff at their request. 10. Request that NAMWATER sponsor portion of the cable fence and signage that are around the Lichenfields as some kind of environmental protection offset or social responsibility. 11. All park rules and regulations to be adhered.
