 - (d) All applicable and required permits are obtained and mitigation measures stipulated in the EMP are applied particularly with respect to management of ecological impacts.

- 2. Proposed Amendments(s): The proposed amendment is to have the ECC read as follows: SUBJECT: ENVIRONONMENTAL CLEARANCE CERTFICATE FOR THE CONSTRUCTION AND OPERATION OF THE NEW 66 KV NAMPOWER POWER LINE FROM OBIB TO ZINCUM SUBSTATION FOR RPZC MINE IN THE KARAS REGION AND INCLUSION OF THE ZINCUM SUBSTATION, AURUS METERING STATION AND 400M POWERLINE FROM AURUS METRING STATION TO ZINCUM SUBSTATION
- 3. Reason for Amendment(s): To include the Zincum Substation and Aurus Metering Station in the construction and operation (Figure 1). As well as the 400m powerline from Aurus to Zincum (Figure 2).

The main activities at the substations and metering station will entail:

- · Civil works for the powerline feeder bay,
- Mechanical mainly erection of columns, beams and installation of electrical equipment.
- Electrical installation will include pulling of the cables from equipment to the junction boxes and to the control room.
- Commissioning and testing: conducted prior to energisation.
- Transmission of power is a listed operational activity which will happen after energisation.

- 4. Describe the environmental changes arising from the proposed amendment(s): No changes will arise from this, as the activities will take place within the existing Zincum Substation and Aurus Metering Station. Access roads exist two both facilities.

 The 400m line from Aurus to Zincum runs in an already heavily impacted area, e.g. pipeline to the tailings dam (see Photo 1 and 2).
- 5. Describe how the environment and the community might be affected by the proposed amendment(s): There will be no environmental changes, as construction will either be conducted in the existing footprint or in already heavily damaged area (400m powerline).
- 6. Describe how and to what extent the environmental performance requirements set out in the assessment report previously approved or activity profile previously submitted for this activity may be affected: The environmental performance requirements set out in the previous Environmental Management Plan (Environmental Impact Assessment for the new Nampower powerline from Obib to Zincum substation for RPZC mine) are sufficient and cover the mitigation measures for laydown areas, waste management and impacts on flora, fauna and archaeology are not applicable, as the upgrades do not involve the change of the current footprint.

 The 400m powerline from Aurus to Zincum runs in an already heavily impacted area, e.g. pipeline to the tailings dam (see Photo 1).

Notice is herewith given in accordance with section 37(2) of the Environmental Management Act, Act 7 of 2007 and Environmental Impact Assessment Regulations of 2012 (GG 4878): that a decision in respect to your application No. APP 2977 for Environmental Clearance Certificate to undertake a listed activity has been reached.

DECISION

An Environmental Clearance Certificate (ECC) to undertake the listed activities specified in the environmental assessment report and draft management plan dated September 2021, is granted (ECC 01937). The applicant / proponent is therefore advised to comply with conditions of approval set out in Section C of this notification.

A. DETAILS OF THE PROPOSED ACTIVITY

C. CONDITIONS

C1: Conditions of Approval

- 1. This certificate does not in any way hold the Ministry of Environment and Tourism accountable for misleading information, nor any adverse effects that may arise from these activities. Instead, full accountability rests with the proponent and its consultants.
- 2. This Ministry reserves the right to attach further legislative and regulatory conditions during the operational phase of the project.
- 3. Regular environmental monitoring and evaluations on environmental performance should be conducted. Targets for improvements should be established and monitored throughout this process.

C2: Clearance Certificate Validity

- 4. This environmental clearance is valid for a period of 3 (three) years, from the date of issue unless withdrawn by this office.
- 1. On expiry of the ECC, the proponent is required to submit within a period not exceeding one month, and in the prescribed form and manner an application to the Office of the Environmental Commissioner for the renewal of the ECC.
- 2. Failure to renew an expired environmental clearance certificate shall result in permanent termination of the environmental clearance certificate.
- 3. In terms of Section 3 (2)C of the Environmental Impact Assessment, you are instructed to, within 14 days of this notice issuance date, ensure that all registered interested and affected parties ("1&APs") are notified that an environmental clearance certificate has been issued in respect to your application and of their right to appeal

C3: Compliance with authorization under other laws

4. All other applicable and required permits or authorization from relevant competent authorities must be obtained prior to commencing the proposed activities and accordingly adhered to.

C4: Implementation and Monitoring

- 5. The granting of the Environmental Clearance Certificate (ECC) constitute, an approval for the implementation of mitigation measures proposed in your approved Environmental Management Plan (EMP), hence making the approved EMP legally binding document.
- 6. The proponent shall appoint a suitably experienced environmental control officer, or site agent where appropriate, before the commencement of any listed activities to ensure compliance with the conditions of approval and mitigation stipulated in the approved EMP
- 7. A copy of the Environmental Clearance Certificate (ECC), EMP, Environmental Audit and monitoring reports must be kept at the site of the authorized activity and readily available for inspection by officials of the Ministry and registered Interested and affected Parties (I&APs) on request.

- 8. Should any heritage remains be exposed during excavations or any other actions on the site, these must immediately be reported to the National Heritage Council of Namibia. Heritage remains uncovered or disturbed during earthworks must not be further disturbed until the necessary approval has been obtained from National Heritage Council.
- 9. Using the best and affordable methodology, the Proponent must ensure that all listed activity's operations footprints are thoroughly rehabilitated prior to closure of the operation. Wherever possible, the Proponent must proceed with the rehabilitation process concurrently with the progression of the project rather than wait until the damage is far beyond the available means of management.
- 10. The general standard for all rehabilitation processes must at all costs aim at restoring the natural character of the environment to the satisfaction of the Ministry of Environment and Tourism. Such rehabilitation processes shall be inspected and certified satisfactory or unsatisfactory by the Ministry of Environment and Tourism. Where a certificate of unsatisfactory is issued, the Proponent shall be advised to carry-out certain tasks to meet the requirements. Failure to meet the basic rehabilitation requirements shall be regarded by this Ministry as a breach of this contract and of which serious consequences shall follow.
- 11. Officials of the environmental commissioner's office may from time-to-time conduct spot-inspection (non-auditing) without prior notice and or Auditing Inspection (dates to be agreed prior to arrival to the site), hence access to the site and the aforementioned documentation must be granted to any authorized official representing the Office of the Environmental Commissioner and Registered Interested and Affected Parties (1&APs)
- 12. Any changes to, or deviations from the scope of the alternative described in section B above must be accepted or approved, in writing, by the Office of the Environmental Commissioner before such changes or deviations may be implemented. In assessing whether to grant such acceptance/ approval or not, the Competent Authority may request information in order to evaluate the significance and impacts of such changes or deviations, and it may be necessary for the holder to apply for further authorisation in terms of the applicable legislation.
- 13. Officials representing the Office of the Environmental Commissioner must be, in possession and or by request and for the purpose of inspection referred to in C4(12) present their staff identification card in order to gain entry to the premises
- 14. The proponent is required, from the date of commencing implementation of project activities, to compile and submit environmental monitoring reports (on project progress and the environmental management profile) on a bi-annual basis to Office of Environmental Commissioner
- 15. Any changes to, or deviations from the scope of project activities approved in respect to the assessment received and reviewed for the purpose or granting this ECC Number (ECC 01937) are subject to an amendment application and approval by the Environmental Commissioner prior to adopting / implementing any such changes / deviations.
- 16. For the purpose of amending and or transferring the ECC, the proponent submit in the prescribed form and manner an application to the Office of the Environmental Commissioner, clearly indicating the need for amendment and or transfer of the ECC

17. Non-compliance with a condition of this Environmental Clearance Certificate or EMP may render the Proponent liable to criminal prosecution.




