

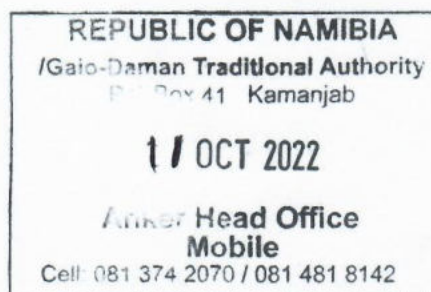


In response to your request refer to the 12/10/2023 meeting on review of the above-mentioned follow-up and Environmental Management Plan Presentation.

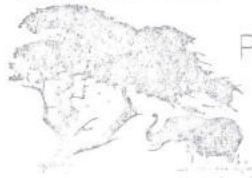
