#### AIMS FOR THE VERIFICATION

- The area of interest is in highly sensitive and archaeologically significant areas, and found in an understudied area in the Kunene Region.
- The identification and assessment of the heritage resources visible at the targeted area,
   since the place is rich in archaeological and historical resources.
- The identification and demarcation of sensitive heritage resources requiring special mitigation measures.
- Formulation of site-specific mitigation measures which can include permit applications
  to the removal of heritage resources if there is any.

The verification relies on indicative value of surface finds.

#### **VERIFICATION OF CONSENT APPLICATION 34/2023**

ARCHAEOLOGICAL AND HERITAGE IMPACT ASSESSMENT REPORT FOR EXPLORATION ACTIVITIES ON EXCLUSIVE PROSPECTIVE LICENCE (EPL) NO. 8613, LOCATED NORTH-WEST OF KHORIXAS, KUNENE REGION, NAMIBA.

Ms. Ndeyapo Mungoba (hereinafter referred to as the proponent) is intending to carry out exploration and prospecting activities on Exclusive Prospecting Licence (EPL) 8613. The EPL is located approximately 53km North-west of Khorixas town. It covers a surface area of 8 047 hectares and overlies farms Brakwater 670, Ruspoort 669 and Eersbegin 675. The EPL is accessible via the D2650 road from Kamanjab to Ongauti settlement.

This application was presented to the Council in February 2023, where the Council resolved that verification needed to be carried out before granting consent, as it is found in an understudied area in the Kunene region.

#### ASSESSMENT


A reconnaissance field survey was carried out for two days on the targeted EPL, which covers an area of 8 047 hectares.

The finds observed in the initial report had been located and verified. There was one burial site recorded in the report, however, this site was outside the EPL. It should be noted, that this area is sparsely populated and is mostly used for farming activities. The local community when engaged, could not provide information on past human activities of archaeological significance. Additionally, this area is dominated by rocky and mountainous landscapes.

The lithic artifacts verified were loosely scattered and in secondary context, however, these do not have a high level of archaeological significance.




Figure 1: Locality map of the proposed project.
