1. WELCOME

1.1. Message from the coordinator – Mr Charles Loots

Our mining businesses do not operate in an isolated environment. Levels of scrutiny towards environmental and social performance are increasing, the strength of the community voice is growing, and higher standards of governance and accountability (e.g. King IV) are influencing and guiding the way companies do business. The plan has been compiled from information gathered during a two-day workshop held on 28th – 30th June 2017 at Otjikoto Trust Environmental and Education Centre.

The purpose of the workshop was to share information on the environmental work being carried out at each mine, discuss successes and challenges, identify key environmental issues to be addressed in the plan, identify main actions needed to implement the environmental components of the plan, and to consider an independent and external environmental assessment awards programme for the Namibian mining industry.

The workshop coordinated by the Namibian Chamber of Environment and the Chamber of Mines was a great success with members from across the country attending and actively participating in the development of this plan. The consolidated plan outlined in this document will focus the industry's attention on key environmental and social performance areas for mining and mineral operations in Namibia.

The actions derived from the Strategic Environmental Plan have set a demanding programme for the period ahead. We are confident that with your support we can achieve our objectives and improve industry's environmental and social performance.

We look forward to implementing the plan and welcome your feedback at any time throughout the life of the plan.

2. STRATEGY AND VISION

This Environmental Strategy and Action Plan (ESAP) is a three-year strategic plan that forms part of the Chamber of Mines' strategic plan, and outlines the vision, mission and strategic framework for the Namibian mining and minerals industry.

The Strategic Environmental Plan 2017-2019 (this plan) was developed by a collective group of environmental professionals within the mining and minerals industry, working with the Namibian Chamber of Environment (NCE). This plan will be reviewed annually to reflect our progress towards our goals.

2.1. VISION AND MISSION

The Namibian Chamber of Mines' (CoM) vision for the mining industry, reflecting the consensus of all members of the CoM, is as follows.

"Our vision for the Namibian Mining Industry is to be widely **respected** as a **safe**, **environmentally responsible**, globally **competitive** and **meaningful contributor** to the long-term **prosperity** of **Namibia**".

Chamber of Mines Mining Industry Vision

The future of the Namibian minerals industry is directly linked to the global mineral producer's commitment to sustainable development. The Brundtland Commission's definition of sustainable development is "development that meets the needs of the present without compromising the ability of future generations to meet their own needs". In the mining and minerals sector, this translates to investments in minerals projects that should be **financially profitable**, **technically appropriate**, **environmentally sound and socially responsible**.

Industry's mission as stated by the CoM is "to effectively promote, encourage, protect, foster and contribute to the growth of responsible exploration and mining in Namibia to the benefit of the country and all stakeholders".

To achieve continual improvement and successful implementation of the National Environmental Strategic Plan for the minerals and extractive industry, the CoM and the NCE have developed this framework in collaboration with representatives from the environment departments of exploration and mining companies operating in Namibia.



2.2. METHODOLOGY

The ESAP was compiled based on information gathered during a two-day workshop held in June 2017. Each mining company gave a presentation on their work, challenges, successes and what they considered to be the key strategic issues for the industry. Arising from the information provided and a series of facilitated working group sessions, eight priority focus areas were identified that form the foundation of this plan.

The ESAP is thus based on eight pillars that outline what we want to achieve and incorporates a number of strategic priories to each of the eight focus areas (see diagram below). These are supported by the necessary actions considered necessary to achieve the strategic priorities. The specific actions have been allocated to key personnel to coordinate, manage and implement.



5. ENSURING WE ARE ACCOUNTABLE

We want to measure our success, we want to know when we are doing well and we want to know when and where we can improve. Importantly we want to establish a reporting framework that holds us accountable for our environmental and social performance. CoMEC together with the Namibian Eco Awards programme plan to implement a mining award system that is independent, transparent and holds our operators accountable for their performance.

The Chamber of Mines Environmental Committee would like to introduce you to The 'Responsible Mining Awards' program.

The Responsible Mining awards programme will be a prestigious hallmark that all mining operators will use to demonstrate their success. Based on a five-star rating, each operation will be independently audited against specific criteria formulated on the performance standards of the International Finance Corporation (IFC) for responsible mining. We won't stop there, we will use the award system to benchmark operations against their peers, and use this transparent approach to engage and educate the public.

The areas for assessment will align with our strategic plan and will link to the relevant IFC performance standard. An annual independent audit will be conducted by the 'Eco Awards' organization. We will strengthen the Eco Awards organization by providing training and mining expertise to the audit team, provide toolkits for assessment and as a mining environmental committee, review findings from the field audit that will result in the issue of the operations 'Responsible Mining' award. CoMEC fully supports this initiative and is seeking the commitment from the CoM Council to develop and implement the 'Responsible Mining' awards system.
