## DECLARATION OF GAME PARK: NAUTE RECREATION RESORT

Under section 14(1) of the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975), it is hereby made known that the Cabinet has declared the area described in the Schedule hereto as a game park.

## SCHEDULE

## NAUTE RECREATION RESORT

The area defined as follows:

Beginning at the point where district road 545 intersects the eastern boundary of the railway servitude on the farm Gawachab 114; thence generally south-south-eastwards with the said servitude boundary to the point where it intersects the north-western boundary of the farm Gabasis West 112; thence generally north-north-eastwards, east-north-eastwards, north-westwards and north-north-westwards along the boundaries of the following farms so as to exclude them from the area, viz Gabasis West 112, Elbersfeld 118,

### ADVISORY BOARD ELECTIONS: DETERMINATION OF DATE ON WHICH PERIOD OF POSTPONEMENT OF ELECTIONS SHALL END IN RELATION TO BY-ELECTIONS

Under section 2 of the Advisory Board Elections Postponement Proclamation, 1983 (Proclamation AG. 1 of 1983) -

- (a) the Cabinet hereby determines the date, 31 October 1988, as the date on which the period referred to in subsection (1) of that section shall end in relation to by-elections for the filling of casual vacancies in Advisory Boards; and
- (b) the Cabinet hereby directs that if on the date mentioned in paragraph (a), any vacancy exists in any Advisory Board which, in terms of the regulations relating to the election of
