

Indicators 1-17 reflect the performance of the management team in place in the conservancy and an efficient team can achieve a good rating in all 17 indicators.



Human wildlife conflict




Most troublesome problem animals 2017-2019

the chart shows the number of incidents per species for the last 3 years; the darkest bar (on the right) indicates the current year for each species




Type of damage by problem animals 2017-2019










Vegetation monitoring




