

- A. SUBJECT in respect of the figure ABCDGQR on Diagram No. A 87/89, annexed to the said Certificate of Consolidated Title No. T765/1989, to the following conditions created in Government Grant No. 43/1945, which conditions inter alia relate to:
 - (i) "The reservation of mineral rights in favour of the Government;
 - (ii) the construction of dams, water furrows, railways, roads, telegraph and telephone lines by the Administrator, subject to the payment of compensation;
 - the resumption of the whole or any portion of the land for public purposes subject to the payment of compensation;
 - the existing or future reservations, servitudes, obligations, laws and regulations;







- (v) the use of all roads, thoroughfares and rights of outspan."
- B. SUBJECT FURTHER in respect of the figure D E F G on Diagram No. A 87/89, annexed to the said Certificate of Consolidated Title No. T765/1989, to the following conditions created in Government Grant No. 69/1927, which conditions inter alia relate to:
 - (i) Die aanlê van damme, watervore, spoorweë, paaie, telegraaf- en telefoonlyne deur die Administrateur teen vergoeding;
 - (ii) Die terugname van die hele of enige deel van die grond vir publieke doeleindes teen vergoeding;
 - (iii) Die gebruik van alle paaie, deurgange en regte van uitspanning:
 - (iv) Noodsaaklike paaie.
- C. SUBJECT FURTHER in respect of the figure D E F G on Diagram No. A 87/89, annexed to the said Certificate of Consolidated Title No. T765/1989, to a Servitude of Perpetual Right to convey electricity by means of three separate power lines, subject to conditions with ancilliary rights, in favour of the S.W.A. WATER- EN ELEKTRISITEITSKORPORASIE (EIENDOMS) BEPERK (Mpy. Nr. F2051) (Ingelyf in die Republiek van Suid-Afrika), created by virtue of Notarial Deed No. 17/1971.
- D. AND SUBJECT FURTHER in respect of the figure G H J K and L M N P Q on Diagram No. A 87/89, annexed to the said Certificate of Consolidated Title No. T765/1989, to the following conditions created by virtue of Certificate of Substituted Title No. 742/1921, namely:

"The Purchaser is obliged to re-transfer to the Government such ground as may be required for the construction of public roads, railways and telegraph and telephone lines, and for other constructions for the purpose of communication, as well as for the purpose of irrigation at the original cost price, and the Government shall also pay adequate compensation for the removal of any improvements on such ground."

WHEREFORE the Appearer, renouncing all the Right and Title which the said TRANSFEROR

heretofore had to the Premises, did, in consequence also acknowledge the said **TRANSFEROR**

to be entirely dispossessed of, and disentitled to, the same, and that by virtue of these presents the TRANSFEREE as aforesaid, now and henceforth shall be entitled thereto, conformably to local custom: the State, however, reserving its rights, and finally acknowledging that the purchase price of the aforesaid property amounts to N\$1 221 686,00.
