Investigators remove medication from Gene Hackman and Betsy Arakawa’s home

Gene Hackman and his wife Betsy Arakawa’s home has had medications removed from it by investigators. The Hollywood icon, 95, and his spouse, 64, were discovered in their secluded mansion on Wednesday sparking a probe by authorities into their cause of death – with family members speculating about carbon monoxide poisoning and police ordering autopsies and toxicology tests to determine the cause. Investigators are now reported to have searched the \$3.8 million property on Thursday listing “thyroid medication, Diltiazem, and Tylenol” among the items found inside. Betsy’s body was widely reported to have been discovered on the bathroom floor, with an open bottle of prescription pills scattered nearby.

An affidavit also stated: “New Mexico Gas Company responded to the residence and was conducting active testing on the gas line in and around the residence. “As of now there are no signs or evidence indicating there were any problems associated to the pipes in and around the residence.” Santa Fe County Sheriff Adan Mendoza said: “Initial findings noted no external trauma to either individual. There were no apparent signs of foul play. The manner and cause of death has not been determined. The official results of the autopsy and toxicology reports are pending. This remains an open investigation.” Gene’s body was found in a mudroom near the kitchen, with his sunglasses and cane lying next to him. A maintenance worker, who

discovered the bodies, made a distressed 911 call. The worker said: “Damn, damn! I think we just found a deceased person inside the house.”He added to the call handler: “I don’t know, sir, just send somebody up here quick. “The house is closed, it’s locked... I can’t go in but I see she’s laying on the floor.” A dead German shepherd was also found in a bathroom closet near Betsy. Two other dogs were found alive on the property, one inside the house and another outside. Gene and Betsy are believed to have been dead for up to two weeks before their discovery, with the cool, dry winter climate of Santa Fe likely contributing to the partial mummification of their bodies.-iol

Oscars 2025: Zoe Saldaña responds to ‘Emilia Pérez’ backlash from Mexican community

Oscar winner Zoe Saldaña has apologised to any Mexicans who felt offended by the depiction of their country in her film “Emilia Pérez”. The “Avatar” star won Best Supporting Actress at the Oscars on Sunday, March 02 for her performance in the controversial crime musical, which has been heavily criticised by the Mexican and transgender community.

Backstage after her win, Saldaña was asked to respond to the criticism by a Mexican journalist who declared that “Emilia Pérez” has been “really hurtful for us Mexicans”. “First of all, I’m very, very sorry that you and so many Mexicans felt offended. That was never our intention,” she replied. “We came from a place of love and I stand by that. I don’t share your opinion. For me, the

heart of this movie was not Mexico. We were making a film about friendship. We were making a film about four women.” Saldaña insisted that the film was about the relationships between four women - played by herself, Selena Gomez, Karla Sofía Gascón and Adriana Paz - and they could have been of any nationality. “These women are still very universal women that are struggling every day but trying to

survive systemic oppression and trying to find the most authentic voices,” she continued. “So I will stand by that but I’m also always open to sit down with all of my Mexican brothers and sisters, and with love and respect, having a great conversation on how Emilia could have been done better. I have no problem. I welcome it.” During her acceptance speech, the “Guardians of the Galaxy” star celebrated being the first American

of Dominican origin to receive an Academy Award and dedicated her prize to her grandmother. “Emilia Pérez” went into the ceremony with 13 nominations but only came away with two wins - Best Supporting Actress and Best Original Song for El Mal. Its 11 losses make it the all-time biggest loser in Oscars history alongside “The Color Purple” and “The Power of the Dog”.
